# Town of Cairo Town Board Meeting @7pm Location: Town Hall Meeting Room

#### **September 26, 2012**

The Town Board of the Town of Cairo met for a Town Board meeting on Wednesday, September 26, 2012 at the Town Hall, Main Street, Cairo, New York.

Supervisor Ted Banta, called the meeting to order at 7:00 PM and then asked the attendees to Pledge Allegiance to the Flag. Councilperson Suttmeier was absent.

MA Tarpinian gave presentation about the 19<sup>th</sup> Annual Apple Harvest Festival and the events planned for that day. There is going to be 50 plus vendors, local food vendors, Bobby Val Country Music Band with Square dancing, Apple pie baking contest, and a Little Miss or Mr. Cairo. Portion of proceeds of the Apple Festival are going to Toys for Tots. Dot Rosenthal is going to be our town crier.

Janet McKeon gave presentation about the summer recreation program that runs for 6 weeks every summer. She went over the importance of giving the children something to do during the summer.

The minutes from the September 12, 2012 Workshop Meeting was accepted by Councilperson Ostrander and seconded by Councilperson Joyce.

Code Enforcement Officer Stacey Sprague asked Board about household garbage. Councilperson Joyce asked about numerous properties that have been in violation in town.

Superintendent of Highways Robert Hempstead recognized Jimmy Kusisto as the new foreman for the Highway Dept. as of October 1<sup>st</sup>.

Councilperson Ostrander reported there was excess water in parking lot when it rained. Hempstead will get in touch with company to fix the problem.

Supervisor Banta went over the Supervisor's Report. (See Supervisor's Report) He asked Councilperson Ostrander to assist him in redoing the emergency plan because the plan is outdated.

**Resolution No. 222-12** "Receipt of Monthly Supervisor's Report" offered by Councilperson Puorro and seconded by Councilperson Ostrander:

WHEREAS, it has been recommended by the NYS Comptroller's Office in the Town of Cairo Report of Examination 2008M-175, that the Supervisor should present a Monthly Report to the Board Members consisting of cash receipts, cash disbursements, and a budget versus actual report for expenses and revenues, and it be documented in the minutes; therefore, be it,

RESOLVED, that the Town Board Members accept the monthly Supervisor's Report for August, 2012.

All members in favor – motion carried.

**Resolution No. 223 -12** "Grant Permission to the Justice Court to Apply for the 2012 JCAP Grant" offered by Councilperson Ostrander and seconded by Councilperson Puorro:

WHEREAS, the Town of Cairo Justice Court is in need of (4) filing cabinets, (1) desk and chair, (1) new desktop computer, funds to scan records, and updates to the court security system; and

WHEREAS, there is a 2012 Justice Court Assistance Program Grant (JCAP) available; therefore be it

RESOLVED, that the Town Board of the Town of Cairo does hereby grant permission to the Justice Court to apply for the 2012 JCAP Grant.

All members in favor – motion carried.

**Resolution No. 224-12** "Authorizing a Two Night Accommodation for the Deputy Highway Superintendent's Conference Attendance" offered by Supervisor Banta and seconded by Councilperson Joyce:

WHEREAS, the Town Board approved the Deputy Highway Superintendent's attendance to the State Comptroller's Accounting School, Resolution 173-12, on July 11, 2012;

AND WHEREAS, the Highway Superintendent approved a two night stay accommodation for the conference held in Oneonta because of the long commute and because the overnight accommodations would be less than the daily commute expense; therefore,

BE IT RESOLVED, that the Town Board of the Town of Cairo does hereby authorize the two night accommodation for the Deputy Highway Superintendent for the attendance at the State Comptroller's Office Conference, as it is more cost effective than daily mileage and travel time.

All members in favor – motion carried.

**Resolution No. 225-12** "Approve Ambulance Financing" offered by Councilperson Puorro and seconded by Councilperson Ostrander:

WHEREAS, the Town Board approved the purchase of a new ambulance on May 9, 2012, Resolution 120-12;

AND WHEREAS, the Town has received financing options from 3 vendors:

The Bank of Greene County: 3 yr at 2.09% & 5 yr at 2.29%

Integrated Vehicles & Equipment Leasing: 5 yr at 4.96% & 6 yr at 4.99%

Advantage Funding: 3 yr at 3.97% & 4 yr at 3.99%

The lowest financing option submitted by the Bank of Greene County; therefore,

BE IT RESOLVED, that the Town Board of the Town of Cairo does hereby approve the 5 year financing option provided by the Bank of Greene County at 2.29%.

**Resolution No. 226-12** "Fee Schedule Amendment" offered by Councilperson Ostrander and seconded by Councilperson Puorro:

WHEREAS, the Town of Cairo adopted a revised Fee Schedule on April 25, 2012; AND WHEREAS, the Town of Cairo has updated the fee schedule on 6/13, 8/8, & 8/22;

BE IT RESOLVED, that the Town Board of the Town of Cairo does hereby amend the Fee Schedule to add a \$20 FOIL Deposit for Maps and to delete the escrow comment in parentheses in the line item for Curb Cut/Driveway Upgrade-deleting "Escrow established by the Highway Dept".

**Resolution No. 230-12** "Accept Local Law No. 3 - Regulating Storage Bins" offered by Councilperson Ostrander and seconded by Councilperson Joyce:

Be it resolved that the Town Board of the Town of Cairo does hereby accept the Local Law 3 - Regulating Storage Bins in the Town of Cairo.

All members in favor – motion carried.

**Resolution No. 231-12** "Board to Move into Executive Session" offered by Councilperson Ostrander and seconded by Councilperson Joyce:

BE IT RESOLVED, that the Town Board of the Town of Cairo does hereby move into Executive Session at 8:20 PM to discuss medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation within the Town of Cairo.

**Resolution No.** 233 -12 "Deny Variance for Meadowfields Apt." offered by Councilperson Puorro and seconded by Councilperson Ostrander:

# TOWN BOARD OF THE TOWN OF CAIRO RESOLUTION VARIANCE APPLICATION FOR RELIEF FROM TOWN RESORT CONVERSION MORATORIUM MEADOW FIELDS APARTMENTS, LLC/PAGANOS

WHEREAS, the Town of Cairo's Comprehensive Plan includes as one of the several goals of the Town, the preservation and encouragement of the tourism and resort industry within the Town; and

WHEREAS, Meadow Fields Apartments, LLC and Vasileios Paganos (hereinafter referred to "Applicants") are the owners of certain real property located at 940 County

Route 24, Round Top, Cairo, NY, and

WHEREAS, the Town Board of the Town of Cairo, based upon the existence of several potential conversions of resort properties into other uses within the Town, enacted a moratorium local law to allow the Town to review and possibly regulate the potential negative and positive impacts of such conversions to the Comprehensive Plan and the Town. Said moratorium is entitled Town of Cairo Local Law #2 of 2012, entitled "A Local Law Imposing a Temporary Six Month Moratorium on Approvals Involving Resorts"; and

WHEREAS, the Applicants initially filed a site plan review application with the Town of Cairo Planning Board seeking to convert a building located on such property from the former use as a resort to that of a senior housing facility in early 2008 and pursued the application through the normal process each month for several months, but did not attend August, September, and October 2008 meetings, with the application being ultimately withdrawn in November of 2008. The matter then lay dormant until re-filed in 2011 with the review and normal process before the Planning Board occurring each month until halted as the result of the above-mentioned moratorium following the June 2012 Planning Board meeting; and

WHEREAS, thereafter, the Applicants filed an application for a variance from the moratorium, pursuant to Section 8 thereof, wherein it states that

"Should any owner of property affected by this Local Law suffer an unnecessary hardship in the way of carrying out the strict letter of this Local Law, then the owner of said property may apply to the Town Board of the Town Cairo in writing for a variance from the strict compliance with this Local Law upon the submission of proof of such unnecessary hardship. For the purpose of this Local Law, unnecessary hardship shall not be mere delay in being permitted to make application or waiting for a decision on the application for a subdivision, variance, special use permit, site plan, site plan review, building permits, other municipal approvals or permits during the period the moratorium imposed by this Local Law."

WHEREAS, the Town Board scheduled and duly noticed a public for such application, which occurred on August 22, 2012; and

WHEREAS, the Applicant appeared only by its counsel Michael Esslie, Esq., and who offered statements relating solely to the procedural history of the application and the Applicant's opinion regarding the compatibility of the proposed use with the Town's Comprehensive Plan;

WHEREAS, several members of the public attended the public hearing, speaking both in favor of and against the granting of the variance application; and

WHEREAS, at the close of the public hearing, the Applicant's counsel submitted a written 4 (four) page narrative containing a recapitulation of Applicant's counsel's statements during the public hearing and one sub-paragraph relating to an alleged unnecessary "pecuniary" loss of "having to pay monthly mortgage payments, taxes, insurance and loss of rent income." The narrative also included four pages of copies of recent Town of Cairo Planning Board minutes, which purportedly support the argument that the underlying application is consistent with the Comprehensive Plan.

#### NOW THEREFORE

Upon a review and consideration of all testimony, statements and written documentation submitted, the Town Board of the Town of Cairo hereby

FINDS, DETERMINES AND RESOLVES THAT the standard of review and proof for the granting of a variance pursuant to the aforementioned Local Law #2 of 2012 requires the applicant to submit proof of an unnecessary hardship and that "...unnecessary hardship shall not be mere delay in being permitted to make application or waiting for a decision on the application for a subdivision, variance, special use permit, site plan, site plan review, building permits, other municipal approvals or permits during the period the moratorium imposed..." by that local law; and further

FINDS, DETERMINES AND RESOLVES THAT the Applicant failed to carry such burden of proof, specifically

1. The oral statements provided by Applicant's counsel during the public hearing related entirely to the Applicant's opinion that the underlying project is consistent with the Town's Comprehensive Plan and no offer of proof relating to an

unnecessary hardship.

- 2. The written narrative contains 6 (six) subparagraphs labeled "Hardship". However a review of the narrative reveals that
  - a) The first Hardship is an argument that the project is consistent with the Comprehensive Plan and thus should not be discarded.

    Even if this argument is accepted at face value, without any supporting documentation, it fails to carry the Applicant's burden in that it does not allege an unnecessary hardship and merely opines that the variance should be granted because of the alleged consistency with the Comprehensive Plan.
  - b) The second Hardship is the same argument, restated in different terms. This argument fails for same reasons set forth above in a).
  - c) The third Hardship is an argument that the moratorium places an additional level of review on the project that no other Applicant has had to face.

Moratoria have long been recognized as legitimate tools for municipalities to utilize to protect significant local interests against potential threats and have been repeatedly accepted by the Courts of the State of New York as an appropriate manner in which to protect those interests. Indeed, the Town Board could have implemented a moratorium that did not include a variance process and the fact that such a process is permitted provides the Applicant greater safeguard than the typical moratorium. There can be no unnecessary hardship by the mere fact of the enactment of the moratorium herein.

d) The fourth Hardship is the argument that the Applicant will allegedly lose mortgage payments, taxes, insurance and suffer a loss of rent income.

Again, without any factual basis as an offer of proof it is impossible for the Town Board to assess the alleged hardship as it relates to the payment of the Applicant's mortgage, real property taxes, etc. Further, it is submitted that the payments set forth in this argument would need to be paid regardless of the existence of the moratorium and are payments that virtually every owner of real property in the Town of Cairo must make.

- e) The fifth and sixth Hardships are the same argument as set forth in a) and b) above, but again merely stated in different terms.
- As set forth above in the analysis of the first Hardship, even if this argument is accepted at face value, without any supporting documentation, it fails to carry the Applicant's burden in that it does not allege an unnecessary hardship and merely opines that the variance should be granted because of the alleged consistency with the Comprehensive Plan.
- 3. The written narrative is a factually unsubstantiated statement by Applicant's counsel without any form of evidentiary, testimonial, sworn or any other proof to support the uncorroborated claims; and the Board further

FINDS, DETERMINES AND RESOLVES THAT any argument that Applicant may make relating to an unnecessary hardship due to delay cannot be deemed to have weight in the Town's Board's consideration herein, since the application for this project has been before the Planning Board, on and off, for the past several years, with most of that time period attributable to either the Applicant's failure to appear at scheduled meetings or as the result of the application being withdrawn by the applicant.

Based upon the above, on a motion by Councilman Puorro and seconded by Councilman Ostrander and unanimously carried, the application for the variance was denied.

#### Town of Cairo Town Board Public Hearing on "Regulating Storage Bins"

#### **September 26, 2012**

The Town Board of the Town of Cairo held a Public Hearing on Wednesday, September 26, 2012 at the Town Hall, Main Street, Cairo, New York.

Supervisor Ted Banta, called the meeting to order at 8:00 PM with the following Board Members present: Councilpersons Ostrander, Joyce and Puorro. Councilperson Suttmeier was absent.

The purpose of the Public Hearing is to receive public comment on a Local Law Proposed to Regulate Storage Bins.

Supervisor Banta read excerpts from the Proposed Local Law.

The Town Board of the Town of Cairo finds and declares that the intrusion of non-regulated storage bins is causing annoyance to citizens in the Town of Cairo and may lead to negative visual impacts and potential health hazards. The provisions contained in this local law are intended to prohibit the placement of storage bins in the Town of Cairo except in accordance with the terms of this local law so as not to negatively impact the health and safety of the residents of the Town.

#### **Storage Bins Prohibited Without Permit. Conduct**

- a. No person, corporation, entity, organization or group shall place a storage bin in any location within the Town of Cairo, except in the following locations and with the owners consent thereof, unless such person shall first obtain a permit from the Town:
  - i. Property owned by the Town of Cairo;
  - ii. Property owned by a duly organized fire company or district;

iii. Property owned by a church or other place of worship.

Motion was made by Councilperson Ostrander and seconded by Councilperson Joyce to close the Public Hearing at 8:05 PM.

The Town Board of the Town of Cairo met for a work session meeting on Wednesday, October 10, 2012 at the Town Hall, Main Street, Cairo, New York.

Supervisor Banta called the meeting to order at 4:05 PM and then asked the attendees to Pledge Allegiance to the flag. Councilperson Ostrander, Councilperson Joyce, Councilperson Suttmeier were present. Councilperson Puorro was absent.

**Resolution No 237-12** - "Recognize October 2012 as Bullying Awareness Month"

Councilperson Ostrander offered the following resolution and moved its adoption:

WHEREAS, We must safeguard schools and communities for our children, and, through our recognition of the serious issues that face them each day, offer our children an environment that holds promise and security; and

WHEREAS, Many organizations, school districts, educators and parents have publicly expressed concern about the bullying of children; and

WHEREAS, Each day an estimated 160,000 children refuse to go to school because they dread the physical and verbal aggression of their peers, and the loneliness that comes from

being excluded and made the target of rumors and cyber-bullying; many more students attend school in a chronic state\_of anxiety; and

WHEREAS, It is time to "Recognize & Extol the Virtues & Attributes of Positive Moral Character & disparage, reject, and stop Bullying!"; now, therefore,

BE IT RESOLVED, the Town of Cairo does hereby designate the month of October 2012 as Bullying Awareness Month as a symbol of our commitment to the year-round struggle against bullying.

A RESOLUTION AUTHORIZING THE ACQUISITION OF A 2012 AMBULANCE AND ISSUANCE OF SERIAL BONDS OF THE TOWN OF CAIRO, GREENE COUNTY, NEW YORK IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$95,000 PURSUANT TO THE LOCAL FINANCE LAW TO FINANCE THE COST THEREOF, AND DELEGATING CERTAIN POWERS IN CONNECTION THEREWITH TO THE TOWN SUPERVISOR.

BE IT RESOLVED, by the Town Board of the Town of Cairo, Greene County, New York (the "Town") (by the favorable vote of not less than two-thirds of all of the members of the Town Board) as follows:

SECTION 1. The specific purpose (hereinafter referred to as "purpose") to be financed pursuant to this resolution is the acquisition of a 2012 Demers Sprinter 3500 Type II ambulance. The aggregate estimated maximum cost of said purpose is \$95,000 and said amount is hereby

appropriated therefor. It is hereby determined that said purpose is an object or purpose described in subdivision 27-a of paragraph a of Section 11.00 of the Local Finance Law, and that the period of probable usefulness of said purpose is ten years.

SECTION 2. It is hereby determined that the aforesaid purpose constitutes a Type II action as defined under the State Environmental Quality Review Regulation, 6 NYCRR Part 617, which has been determined under SEQRA not to have a significant impact on the environment.

SECTION 3. It is hereby determined that the proposed maturity of the obligations authorized by this resolution will not be in excess of five years from the original date of issuance of such obligations.

SECTION 4. The Town Board plans to finance the total cost of said purpose by the issuance of serial bonds of the Town in an amount not to exceed \$95,000, hereby authorized to be issued therefore pursuant to the Local Finance Law.

SECTION 5. Current funds are not required to be provided prior to the issuance of the bonds authorized by this resolution or any notes issued in anticipation of said bonds.

SECTION 6. The proceeds of the bonds herein authorized and any bond anticipation notes issued in anticipation of said bonds may be applied to reimburse the Town for expenditures made after the effective date of this resolution for the purpose for which said bonds are authorized. This resolution shall constitute a statement of official intent for purposes of Section 1.150-2 of the Treasury Regulations.

SECTION 7. Each of the bonds authorized by this resolution and any bond anticipation notes issued in anticipation of said bonds, shall contain the recital of validity prescribed by Section 52.00 of the Local Finance Law. The faith and credit of the Town are hereby irrevocably pledged for the payment of the principal of and interest on said bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on said bonds becoming due and payable in such year. There shall annually be levied on all the taxable real property of the Town a tax sufficient to pay the principal of and interest on said bonds as the same become due and payable.

SECTION 8. Subject to the terms and contents of this resolution and the Local Finance Law, and pursuant to the provisions of Sections 30.00, 50.00 and 56.00 to 63.00, inclusive, of said Law, the power to authorize bond anticipation notes in anticipation of the issuance of the serial bonds authorized by this resolution and the renewals of said notes and the power to prescribe the terms, form and contents of said serial bonds and said bond anticipation notes (including without limitation the date, denominations, maturities, interest payment dates, consolidation with other issues, and redemption rights), the power to determine to issue said bonds providing for substantially level or declining debt service, and the power to sell and deliver said serial bonds (including as statutory installment bonds), and any bond anticipation notes issued in anticipation of the issuance of such bonds, is hereby delegated to the Town Supervisor, the Chief Fiscal Officer of the Town. The Town Supervisor is hereby authorized to sign any serial bonds issued pursuant to this resolution and any bond anticipation notes issued in anticipation of the issuance of said serial bonds, and the Town Clerk is hereby authorized to affix the corporate seal of the Town to any of said serial bonds or any bond anticipation notes and to attest such seal.

SECTION 9. The Town Supervisor is further authorized to take such actions and execute such documents as may be necessary to ensure the continued status of the interest on the bonds authorized by this resolution, and any notes issued in anticipation thereof, as excludable from gross income for federal income tax purposes pursuant to Section 103 of the Internal Revenue Code of 1986, as amended (the "Code") and to designate the bonds authorized by this resolution and any notes issued in anticipation thereof as "qualified tax-exempt bonds" for purposes of Section 265(b)(3)(B)(i) of the Code.

SECTION 10. The validity of said serial bonds or of any bond anticipation notes issued in anticipation of the sale of said serial bonds may be contested only if:

- (1) Such obligations are authorized for an object or purpose for which the Town is not authorized to expend money; or
- (2) The provisions of law which should be complied with at the date of the publication of this resolution are not substantially complied with;

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication; or

(3) Such obligations are authorized in violation of the provisions of the Constitution of New York.

SECTION 11. The Town Clerk is hereby authorized and directed to publish this resolution, or a summary thereof, together with a notice in substantially the form provided by Section 81.00 of the Local Finance Law, in the <u>Catskill Daily Mail</u>, being a newspaper having a general circulation in the Town and hereby designated as the official newspaper of the Town for such publication.

SECTION 12. This resolution shall take effect immediately.

The question of the adoption of the foregoing resolution was duly put to vote on a roll call, which resulted as follows:

The foregoing resolution was thereupon declared duly adopted.

Supervisor Banta stated that letters will have to be sent to the owners of the clothing bins in the Town of Cairo informing them of our newly enacted law. They will have 30 days to remove the bins. Supervisor's clerk will follow up with a courtesy phone call.

Town Board gave permission to Gerard Buckley to install water lines to his laundromat.

After discussion of upcoming meetings that needed to be scheduled, the board decided that they will have a budget meeting on Friday October 19, 2012 at 9:00am, a zoning meeting

on Monday, November 5, 2012 at 4:00pm and a labor meeting on October 31, 2012 or November 1, 2012. Supervisor will contact the attorney and will inform the board what date the meeting will be held.

Stacy Sprague, Code Enforcement Officer spoke with the board regarding outstanding violations and how would the board like her to proceed. Town Attorney, Tal Rappleyea stated the Town Board has the authority to enforce the local laws with a hearing of property owner and the Town Board. The Town Board can also have the code enforcement officer issue appearance tickets and go through court proceedings. After discussion, the board decided to start court proceedings with all violations brought before the board. Stacy Sprague queried about the property owner that is currently in court and the board decided to hold a hearing with the property owner on Wednesday, November 14, 2012 at 4:30pm. Supervisor Banta asked that the cost of demolition be identified as a town or county bill.

Supervisor Banta informed the board that he received a phone call from an independent film scout looking to use the police station and to film around the Town of Cairo. Supervisor Banta will look further into this matter and report back to the board.

Supervisor Banta spoke about the letter they received from the Town of Catskill regarding a wastewater collection system in South Cairo. Supervisor Banta will contact Supervisor Leggio to arrange a meeting and will inform the board the date and time.

- 1. Surface treatment crews are out resurfacing/patching various roads within the town.
- 2. The gradall crew continues to upgrade the drainage/ditching within the town.
- 3. The mower is completing its fourth run around the town for the season.
- 4. The mechanics are working on the snow removal equipment in preparation of winter.

- 8. Town wide trash clean up and the repairing/replacing or warning signs is ongoing.
- 9. We have purchased a used 20 ton trailer. This will be very cost effective due to all the FEMA jobs that need to be completed. We can now move our own equipment, which is a reimbursable expense through FEMA.
- 10. We need to put the two F550's and two F350's out to bid with new specifications.
- 11. The guide rail project on Route 32 has been completed.
- 12. We have been installing/upgrading driveway pipes on various roads.
- 13. The new foreman Jim Kusisto is a huge asset to the highway department.
- 14. The annex renovations are almost complete. The building is ready to house the police vehicles.
- 15. The recently purchased vacuum sweeper has been out on various roads and is working well.
- 16. We will be putting timers on the lights down at the park.
- 17. We assisted the Chamber of Commerce for the Apple Harvest Festival.
- 18. We continue to utilize court ordered community service hours. These individuals maintain lawns, gardens, paint, general maintenance, etc.
- 19. We have received numerous emails and phone calls regarding the Cairo Nature Center looking for directions so they can bring their family for a day out.

#### FIRE PROTECTION CONTRACT

THIS AGREEMENT, made as of the day of , Two Thousand and Twelve, by and between the <u>TOWN OF CAIRO</u> a municipal subdivision of the County of Greene, State of New York (hereinafter designated as the party of the, first part), and the

ROUND TOP FIRE COMPANY, INC., a volunteer fire company organized and existing under and by virtue of the Laws of the State of New York, with its firehouse located in the Town of Cairo, Greene County, New York (hereinafter designated as the party of the, second part), and

#### WITNESSETH:

WHEREAS, there has been established in the said **TOWN OF CAIRO** a Fire Protection District known as the ROUND TOP FIRE PROTECTION DISTRICT, embracing territory in said Town, as such territory is more fully described in the Resolution establishing such District, and

WHEREAS, following a Public Hearing duly called and held, pursuant to Town Law §184, the party of the first part duly authorized a Contract with the party of the second put through its Fire Department for fire protection end emergency service to that portion of the **TOWN OF CAIRO** within said District upon the terms and provisions hereinafter set forth, and

WHEREAS this Contract has also been duly authorized by the party of the second,

NOW THEREFORE, the party of the first part engages the party of the second part to furnish fire protection and emergency service to that portion of the said Town within said District, and the party of the second part agrees to furnish such protection in manner following, to wit:

(1) The party of the second part shall at all times during the period of this Agreement be subject to call for attendance upon any fire or emergency service in case of accidents, calamities or other emergencies in connection with which the services of

firefighters would be required and occurring in that portion of said Town within such District, and when notified by alarm or telephone call, such Fire Department shall respond and attend upon the fire or emergency without delay with one or more companies and with suitable ladder, pumping and hose apparatus of the party of the second part upon arriving at the scene of the fire, the firefighters of such Department attending shall proceed diligently and in every way reasonably necessary to extinguish said fire, and to save and protect the lives and property of persons affected thereby.

- (2) The term of this Agreement shall be for 12 months, commencing January 1, 2013 and terminating December 31, 2013, subject to the right of said Fire Company to terminate said Agreement at the end of any calendar year in order to request additional annual compensation in the event that unforeseen financial obligations not resulting from actions of said Fire Company should result in significant, increased annual expenses to it.
- (3) In consideration of furnishing aid and the use of apparatus as aforesaid, the party of the first part shall pay the party of the second part the sums of :

\$86,700

for the one year during which this Agreement remains in effect.

- (4) Any loss or damage sustained to the fire apparatus or equipment of the party of the second part, or any expense in connection therewith, shall be borne by the party of the second part and not by the **TOWN OF CAIRO**.
- (5) Each party shall assume the obligations imposed upon it by the appropriate statutes of the State of New York for medical expense, compensation or other benefits or claims arising by reason of the injury or death of a fireman or member of the emergency relief squad of the said Fire Company which may be sustained by reason of answering, attending or returning from any fire, or emergency call within the District.
- (6) All money to be paid under any provision of this Agreement by the party of the first part shall be charged upon that portion of the Fire Protection District within

the Town protected hereunder, said sums to be assessed and levied upon the taxable real property therein and collected with the respective Town taxes.

Dear Mr Banta,

I am writing to express the gratitude and appreciation of our international research team for the permissions and support provided by the Town Board of Cairo and yourself in particular, in relation to the recent drilling of 6 cores at Cairo Quarry. Our research tearn involves collaborations between the Universities of Sheffield, Cardiff and Southampton in the UK, SUNY-Binghamton University, and the New York State Museum, investigating "The Evolutionary Rise of Deep-Rooting Forests and Enhanced Chemical Weathering".

Our research team have been made very welcome at Cairo, and on behalf of the team, I wish to express our immense gratitude for the all the assistance provided, the interest of the local press, and all the logistical support received to enable the drilling work to take place. The Highway Superintendant, Mr Hempstead, was exceptionally obliging and helpful and I have written separately to thank him personally, but we would like also to pass on our thanks to others such as the truck drivers to whom we are greatly indebted. Without this support and assistance the venture would not have been possible.

The samples we have obtained are revealing the extent of the root systems of some of the earliest trees to grown on Earth and we are seeking evidence of the extent to which the rise of forested ecosystems across the world changed soil properties—with effects that are thought to have fed back to control the chemistry of the oceans and atmosphere over the past 370 million years.

The 6 cores we have taken from Cairo Quarry will be subjected to detailed description, photography and chemical analysis over the next year, and should allow us to find out much more about what the forest site was like when the trees lived there. Early indications are that these cores will be very insightful and we are looking forward to sharing the results with the town once our analyses are complete. On the basis of the success with the drilling it is likely that we will wish to request permission for additional follow-up sampling next year.
