TOWN OF CAIRO Public Hearing

December 12, 2012 @ 4:00PM Location: Town Hall, Cairo

Reason/Proposal: To renew the Junk Yard Moratorium-Local Law #5 2012

Section 3. Purpose and Intent:

Pursuant to the statutory powers vested in the Town of Cairo to regulate and control land use, and to protect the health, safety and welfare of its residents, the Town Board hereby declares a temporary six month moratorium on the establishment or development of new junk yards or similar business activities in the Town, or the issuance of any approvals or permits therefore.

The Town Board is now in the process of considering various options relating to this issue and is nearing completion of a proposed zoning law that will address the issue. The Town Board finds and determines that it needs the period of time covered by the moratorium imposed herein in order to carefully study the issue, draft proposed amendments to the Town local laws, including a new zoning document, make appropriate changes to the draft of the proposed new Local Laws, schedule and hold the required public hearing on the Local Laws, comply with applicable provisions of law, adopt the Local Law, and file a copy of the Local Laws (as adopted) with the Secretary of State of the State of New York.

TOWN OF CAIRO <u>Public Hearing</u>

December 12, 2012 @ 4:00PM Location: Town Hall, Cairo

Reason/Proposal: To extend the Resort Moratorium-Local Law #4 2012

Section 2. Purpose and Intent:

Pursuant to the statutory powers vested in the Town of Cairo by the Municipal Home Rule Law of the State of New York, to regulate and control land use, and to protect the health, safety and welfare of its residents, the Town Board hereby declares a temporary six (6) month moratorium on any new subdivision application, site plan review, building permits or other municipal approvals for any use involving the conversion of a resort, motel or bed and breakfast to some other use other than those relating to an agricultural use as that term is defined in the NYS Agriculture and Markets Law or one or two-family dwellings in the Town, or the issuance of any approvals or building permits therefore.

The Town Board has recently adopted a new Comprehensive Plan and is now in the process of implementing a new zoning law and other land use goals set forth therein which would address, among other things, subdivision of lands, site plan review, building permits or other municipal approvals of land relating to the preservation and rejuvenation of the Town's tourism infrastructure and base attractions including but not limited to seasonal resorts, inns, hotels and similar uses and structures in the Town. The Town Board finds and determines that several former resort properties have recently been permanently lost to a change in use by new development. The Town Board further finds and determines that it needs the period of time covered by the moratorium imposed herein in order to carefully complete the enactment of the necessary statutory and other tools to implement the same, including but not limited to, drafting proposed amendments to existing Town Local Laws, schedule and hold the required public hearing on either amendments to existing Local Laws or the enactment of new Local Laws, perform the appropriate environmental reviews thereof, comply with applicable provisions of law, adopt the Local Law(s), and file the same with the Secretary of State of the State of New York.

Town of Cairo Town Board Meeting @7pm Location: Town Hall Meeting Room

November 28, 2012

The Town Board of the Town of Cairo met for a Town Board meeting on Wednesday, November 28, 2012 at the Town Hall, Main Street, Cairo, New York.

Supervisor Ted Banta, called the meeting to order at 7:00 PM and then asked the attendees to Pledge Allegiance to the Flag. All Board Members were in attendance.

Kathleen Harm of Greenville gave presentation to the Board on bringing affordable, high-quality broadband solutions to 100% of Greene County communities.

Sylvia Hasenkopf of the Cairo Historical Society gave presentation to the Town Board on developing a new program honoring our hometown heroes who hve served in our military from Revolutionary days to the present. They are proposing to hang Hometown Heroes Banners along Main St. Mountain Avenue and Purling, wherever there are existing lampposts. The picture of the serviceman or woman would be portrayed on each banner along with some key details of their service. They are asking the Town Board to purchase 45 mounting brackets in the amount of \$2115, plus shipping.

Claudia Zucker, Vice President acting as President of the Cairo Chamber, asked the Town Board for a small space at the Town Hall for the Chamber of Commerce. She reported the Chamber is still alive and they are looking for volunteers.

The minutes from the November 14, 2012 Workshop Meeting was accepted by Councilperson Ostrander and seconded by Councilperson Puorro.

The Town Board will visit the Ambulance Building at 3:00 PM on December 12, 2012.

Supervisor Banta went over the Supervisor's Report. (See Supervisor's Report)

There was discussion with the Town Board about Storage Bins in the park near recycling center. Not for profit should have preference and should not be charged a fee. Town Board needs to determine how many boxes could be put in recycling.

Resolution No. 279-12 "Receipt of Monthly Supervisor's Report" offered by Councilperson Suttmeier and seconded by Councilperson Ostrander:

WHEREAS, it has been recommended by the NYS Comptroller's Office in the Town of Cairo Report of Examination 2008M-175, that the Supervisor should present a Monthly Report to the Board Members consisting of cash receipts, cash disbursements, and a budget versus actual report for expenses and revenues, and it be documented in the minutes; therefore, be it,

RESOLVED, that the Town Board Members accept the monthly Supervisor's Report for October, 2012.

Attorney for the Town Tal Rappleyea presented information about the sewer generator. There needs to be a public hearing to inform the public. Also there needs to be a recommended value assigned to the generator. Sewer generator needs to be replaced because of Hurricane Sandy.

The Town Board set a public hearing for the sewer generator on December 12, 2012 at 4:00 pm.

- 3. Replacing septic tank at ambulance building.
- 4. The furnace at the Acra Community Center has been repaired and serviced.
- 5. Relocated judge's bench and installed new outlets and data ports along wall.
- 6. Road sand and salt is being mixed and stockpiled.
- 7. Repair work complete on Mountain Avenue lighting. Repair consisted of installation of breakers, shut offs and new grounding.
- 8. Repaired street lights on Main Street.
- 9. Assisted the Town of Windham with our large bucket truck.
- 10. Number 23 had rotted frame repaired and will soon be back in service.
- 11. Purchased a new flatbed for number 2 to replace the rotted dump body.
- 12. Completed one pole barn to house tractors and will be starting additional one shortly.
- 13. Snow plow equipment has been installed on Number 1.
- 14. The backhoe with the hydraulic hammer completed the much needed removal of large rock formation at the intersection of Bald Hill and Blackhead to facilitate site distance. We will continue to Winterclove and Maple Lawn to jackhammer formations.

Staff reports that new cards continue to be issued to first time card holders who live in Cairo. Except for the multimillion dollar rumor, all responses from patrons have been positive with people frequently saying, "This is great!"

The Cairo Public Library will not be open on December 21 if the world comes to an end.
