Town of Cairo Town Board Meeting @7pm Location: Town Hall Meeting Room

August 22, 2012

The Town Board of the Town of Cairo met for a Town Board meeting on Wednesday, August 22, 2012 at the Town Hall, Main Street, Cairo, New York.

Supervisor Ted Banta, called the meeting to order at 7:00 PM and then asked the attendees to Pledge Allegiance to the Flag. Councilperson Puorro was absent.

The minutes from the July 25, 2012 Board Meeting was accepted by Councilperson Suttmeier and seconded by Councilperson Joyce.

The minutes from the July 31, 2012 Special Meeting was accepted by Councilperson Ostrander and seconded by Councilperson Joyce.

The minutes from the August 8, 2012 Workshop was accepted by Councilperson Joyce and seconded by Councilperson Suttmeier.

Fran Wolf, Trustee of the Library, gave an update as to the activity in the Library.

Supervisor Banta went over the Supervisor's Report. (See Supervisor's Report) He scheduled a budget meeting for Monday, August 27, 2012 at 4:30 pm.

Resolution No. 197-12 "Receipt of Monthly Supervisor's Report" offered by Councilperson Suttmeier and seconded by Councilperson Ostrander:

WHEREAS, it has been recommended by the NYS Comptroller's Office in the Town of Cairo Report of Examination 2008M-175, that the Supervisor should present a Monthly Report to the Board Members consisting of cash receipts, cash disbursements, and a budget versus actual report for expenses and revenues, and it be documented in the minutes; therefore, be it,

RESOLVED, that the Town Board Members accept the monthly Supervisor's Report for August, 2012.

All members in favor – motion carried.

Resolution No. 198-12 "Accepting Sewer Use Billings Dated August 1, 2012" offered by Councilperson Joyce and seconded by Councilperson Ostrander:

WHEREAS, it is necessary for the Sewer Use Billings to be authorized by the Town Board and documented in the minutes; therefore,

BE IT RESOLVED, that the Town Board of the Town of Cairo accepts the Sewer Use Billings as presented from the Sewer Administrator in the amount of \$37,895.36, dated August 1, 2012.

BE IT RESOLVED, that the Town Board of the Town of Cairo accepts the Water Penalties as presented from the Water Administrator in the amount of \$1,458.38, dated August 13, 2012.

WHEREAS, Linda Kuever is absent from her position as Supervisor's clerk for medical

reasons; therefore, be it,

RESOLVED, that the Town Board of the Town of Cairo does hereby approve utilizing and/or hiring Debra Sommer, a current employee, on a temporary basis to fill the Supervisor's Clerk position at the same current pay rate of \$10.75 per hour.

Resolution No. 201-12 "Approve Court Clerk Attendance at the Annual NYS Association of Magistrates Conference" offered by Councilperson Ostrander and seconded by Councilperson Joyce:

BE IT RESOLVED, that the Town Board of the Town of Cairo does hereby approve Joan VanDenburgh's attendance at the 2012 NYS Association of Magistrates Court Clerk Conference between the dates of September 30, 2012 and October 3, 2012 in Albany, NY.

The Town Board approves the following fees and costs with corresponding receipts:

- Pre-registration fee of \$40.00 (pre-registration is prior to September 26, 2012)
- Commuter two-day meal package in the amount of \$85.00, which includes Monday & Tuesday breakfast and lunch.
- Mileage for daily commute

BE IT RESOLVED, that the Town Board of the Town of Cairo does hereby approve the following additional tapping fees:

- Fire Hydrant Tapping Fee of \$100

WHEREAS, the Local Law for Salvage & Junk Yards LL6-1985 effective June 1, 1985 adopted in February of 1985 states that the annual license fee of \$25.00 in Section XI License Fees has not been revised or updated accordingly-following the process to update said Local Law, therefore,

BE IT RESOLVED, that the Town Board of the Town of Cairo does hereby amend the fee in the Fee Schedule for Junk Yard/Salvage Licenses from \$300 to \$25.

Proposed Local Law on Regulating Storage Bins

Supervisor Banta presented the draft of the Local Law on Storage Bins. The Board will read it over and discuss at Workshop.

Fran Wolfe, Trustee of the Cairo Library, asked if the furniture invoices would be paid. Supervisor Banta stated there was just one invoice that still did not have the correct documentation.

John Morgese asked if the outflow of the Waste Water Treatment Plant was ever tested. What is causing algae where it dumps. Joe Meyers will be contacted about this.

Dave Robinson, Board of Directors of Cairo Little League, questioned the Board about other organizations using the baseball fields since they are the one putting all the money into them. He was informed that it is Town property and anyone using the field will return it to its original condition.

Councilperson Ostrander stated that all events will be listed on the Town's website.

Mike Esslie asked the Town Board that if the property he represents at Meadow Fields Apts., goes in a different direction and keeps it as a motel, can they just go ahead and start their project. Tal Rappleyea, Attorney for the Town, suggested this request is too vague and the Board should not make a decision on this.

TOWN OF CAIRO LOCAL LAW # OF 2012 REGULATING STORAGE BINS

§ 1. Title.

This local law shall be known and cited as "Storage Bin Regulation Local Law."

§ 2. Purpose.

The Town Board of the Town of Cairo finds and declares that the intrusion of non-regulated storage bins is causing annoyance to citizens in the Town of Cairo and may lead to negative visual impacts and potential health hazards. The provisions contained in this local law are intended to prohibit the placement of storage bins in the Town of Cairo except in accordance with the terms of this local law so as not to negatively impact the health and safety of the residents of the Town.

§3. Definitions.

As used in this chapter, the following terms shall have the meanings indicated:

STORAGE BINS: Any container utilized or intended to be utilized for the outdoor storage of items, including but not limited clothing, shoes, household items or any other personal property, to be collected, given, donated, stored, or distributed.

PERSONS: Individuals, partnerships, family groups, voluntary associations, entities, unincorporated organizations and corporations.

§4. Storage Bins Prohibited Without Permit. Conduct

- a. No person, corporation, entity, organization or group shall place a storage bin in any location within the Town of Cairo, except in the following locations and with the owners consent thereof, unless such person shall first obtain a permit from the Town:
 - i. Property owned by the Town of Cairo;
 - ii. Property owned by a duly organized fire company or district;
 - iii. Property owned by a church or other place of worship.
- b. It shall be the responsibility of the owner of the property and the owner of the storage bin to site bins in a location to shield bins from public view.
- c. No more than one (1) storage bin may be placed on any parcel of land within the Town of Cairo.
- d. It shall be the responsibility of the owner of the property and the owner of the storage bin to prevent dumping of trash, refuse, rubbish or any other items which are not the intended items for collection at the storage bin and to immediately remove such items from the parcel.

§5. Permit Process.

Prior to issuance of any storage bin permit, the persons applying for such permit shall file a written statement with the Code Enforcement Officer at least twenty business days in advance of the placement of a storage bin, setting forth the following information:

a. The full name and address of applicant.

- b. The location, including 911 address and tax map parcel number at which the proposed storage bin is to be placed.
- c. The starting and ending dates on which the storage bin shall be present.
- d. Written authority by the owner of the property on which the storage is to be placed, allowing the placement thereof.
- e. A sketch of the location on the parcel where the storage bin is to be placed, including the manner in which the storage bin shall be shielded from public view.
- f. A permit fee in amount to be set by the Town Board, as it from time to time, deems appropriate for the issuance of such permit.

§6. Enforcement; complaints.

This local law shall be enforced by the Building Department and/or the Town of Cairo Police Department, and it shall be their duty to investigate and prosecute any violation of this local law. If, after an investigation, a violation is found to exist, the Building Department shall prosecute a complaint before a court of appropriate jurisdiction, including but not limited to the Justice Court of the Town of Cairo.

§7. Violations and penalties.

- a. Any person, firm or corporation who or which shall violate any provision of this Local Law shall, upon conviction thereof, be guilty of a violation as that term is defined in the New York State Penal Law and shall be sentenced in accordance therewith. Every day that a violation of this Local Law continues shall constitute a separate offense.
- b. Following a finding by a court of appropriate jurisdiction, including the Justice Court of the Town of Cairo, the Town shall be authorized to immediately remove the storage bin and any items in, on, around or near such storage bin.
- c. If the owner shall fail to pay the costs and expenses associated with such removal within 10 days after being notified of the same by mail, the Town Clerk shall file, prior to the time for completing the levy of annual town taxes, a certificate of said cost and expense with a statement as to the property upon which the same were incurred, with the Town Board, which shall in the preparation of the next annual tax levy of general town taxes, levy said amounts upon such property, and the same shall be levied, collected and enforced in the same manner, by the same proceedings at the same time, with the same penalties, and having the same lien upon the property assessed as the general town tax and as a part thereof.

§8. Miscellaneous

- a. This Local Law is expressly adopted pursuant to the relevant sections of the New York State Town Law and the New York State Municipal Home Rule Law.
- b. In the event any section or provision of the laws contained herein or as amended hereafter shall be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of the laws as a whole or any part thereof other that the part so declared to be invalid.
- c. This local law shall be effective immediately upon filing with the Secretary of State.
