Be it enacted by the Town Board of the Town of Durham, in the County of Greene, as follows:

SECTION 1. TITLE

This local law shall be known as the "Alternative Veterans Exemption Law of the Town of Durham, Greene County, New York."

SECTION 2. AUTHORITY

This local law is adopted pursuant to Real Property Tax Law § 458-a. All terms, definitions and conditions of such statute shall apply to this local law.

SECTION 3. PURPOSE

It is the purpose and intent of this local law to increase the maximum exemption allowable for the alternative veteran's exemption, as set forth by the Real Property Law of New York State, § 458-a, Subdivision 2, paragraphs (a), (b) and (c).

SECTION 4. ELIGIBILITY

Pursuant to § 458-a of the Real Property Tax Law of the State of New York, the following veterans exemptions shall be in force as of taxable status date March 1, 2006, and after:
