Be it enacted by the Town Board of the Town of Cairo as follows:

Section 1. Local Law number 3 of the year 2010 of the Town of Cairo entitled 'Local Law Imposing a Temporary Six Month Moratorium on Junk Yard Approvals', which has heretofore been extended for two additional period of six months shall expire on June 14, 2012 and which shall be and hereby is extended for an additional period of six months effective through December 14, 2012.

Section 2. This local law shall take effect immediately when it is filed in the Office of the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law."
