### BE IT ENACTED AS FOLLOWS:

#### SECTION 1. TITLE.

This local law shall be known as the 'Fees relating to Subdivision Local Laws of the Town of Cairo, Greene County, New York."

#### SECTION 2. AUTHORITY.

This local law is adopted pursuant to the New York State Municipal Home Rule Law. All terms, definitions and conditions of such statute shall apply to this local law.

It is the purpose and intent of this local law to remove reference to the level of fees in the Subdivision Local Law for the Town of Cairo from such laws to provide flexibility in the setting of same by resolution by the Town Board.
