Minutes

Town of Cairo Town Board Meeting

March 28, 2012

The Town Board of the Town of Cairo met on Wednesday, March 28, 2012 at the Town Hall, Main Street, Cairo, New York.

Supervisor Ted Banta, called the meeting to order at 7:05 PM and then asked the attendees to Pledge Allegiance to the Flag. Board members present: Councilperson Ostrander, Councilperson Suttmeier, and Councilperson Joyce. Councilperson Puorro was absent.

The first order of business for the meeting was to present Debra Kamecke, the Distinguished Librarianship Award, for her achievements with the Cairo Public Library. Debra Kamecke received the L. Marion Moshier/Asa Wynkoop Award for Distinguished Librarianship. The award honors a library director who has given outstanding service to a community of 7,500 in population or less.

Warren Hart, Director of the Department of Economic Development, Planning & Tourism gave a presentation about programs available for small business training classes and funding. He reported that Greene County also has economic development loan funds available for job-creating projects through its Quantum Fund.

Mr. Hart also informed of some of the new events coming to Greene County this year.

Supervisor Banta introduced Robert Bradley as the new owner of the Family Dollar on Main Street in Cairo.

The minutes for the February 22, 2012 Board Meeting was accepted by Councilperson Joyce and seconded by Councilperson Ostrander.

Ethics Board Supervisor Banta reported on the Ethics Board which was established on 7/21/10. The members still willing to service and who were reappointed/reconfirmed on February 22, 2012 were Donald Gibson, Sr., Denise Daly, Joseph Kames and Kathleen Passaro. Supervisor Banta was able to speak with the 5th member, Barbara Annis, who was previously appointed. Barbara stated that she was interviewed and sent a letter of acceptance. She also stated that a meeting was scheduled and then cancelled, and nothing more was done.

Farmers Market Chuck Solberg, owner of Medusa Meadows Farm and the Catskill Country Store addressed the Board about having a Farmers Market in the Cairo Town Park starting June 16 through October 13. Mr. Solberg wants to get the local community groups involved to foster a sense of community pride. He also explained that the Farmers Market would not interfere or be a conflict with events already scheduled for the park.

Town Property Forest Management Supervisor Banta will contact Forest Manager to see what opportunities are available to the Town, such as logging. Councilperson Joyce suggested looking into the possibility of generating revenue for the Town by logging/thinning the trees on the Town properties.

Parking Lines on Main Street

Councilperson Suttmeier suggested having the lines on Main Street done before Memorial Day Weekend. Supervisor Banta informed Board that Highway Superintendent Hempstead purchased machine to do lines in-house to save money for Town

Resolution No. 75-12 "Authorization to Hire a Full-time Police Officer" offered by Councilperson Suttmeier and seconded by Councilperson Joyce:

BE IT RESOLVED, that the Town Board of the Town of Cairo does hereby authorize Chief of Police Chris Sprague to hire Richard Bush as a Full-time Police Officer at a pay rate of \$16.60 per hour.

All members in favor – motion carried.

Resolution No. 76-12 "Acceptance of the Tentative Agreement with the Highway Unit-Teamsters Local 294" offered by Councilperson Ostrander and seconded by Councilperson Joyce:

WHEREAS, the Town of Cairo (the "Town") and the Teamsters Local 294 (Highway Unit) are parties to a Collective Bargaining Agreement (the "Agreement") for the term January 1, 2008 to December 31, 2010; and

WHEREAS, the Town and the Teamsters Local 294 have entered into a tentative agreement to modify and extend the Agreement through 2011; and

WHEREAS, a copy of the tentative agreement is attached hereto and made a part hereof; and

WHEREAS, the Town Board desires to adopt and accept the terms of the tentative agreement;

NOW THEREFORE, BE IT RESOLVED that the Town Board of the Town of Cairo adopts and accepts the terms of the tentative agreement.

All members in favor – motion carried.

Resolution No. 77 -12 "Accepting Sewer EDU Billing Dated March 1, 2012" offered by Councilperson Ostrander and seconded by Councilperson Joyce.

WHEREAS, it is necessary for the Sewer EDU Billing be authorized by the Town Board and documented in the minutes; therefore, be it

RESOLVED, that the Town Board accepts the Sewer EDU Billings as presented from the Sewer Administrator in the amount of \$59,425.00, dated March 1, 2012.

All members in favor – motion carried.

Resolution No. 78 -12 "Accepting Sewer Use Penalties Dated March 16, 2012" Offered by Councilperson Ostrander and seconded by Councilperson Suttmeier:

WHEREAS, it is necessary for the Sewer Use Penalties be authorized by the Town Board and documented in the minutes; therefore, be it

RESOLVED, that the Town Board accepts the Sewer Use Penalties as presented from the Sewer Administrator in the amount of \$2,877.99, dated March 16, 2012.

All members in favor – motion carried.

Resolution No. 79-12 "Authorizing the Use of Town Property for an Annual Street Festival" offered by Councilperson Ostrander and seconded by Councilperson Joyce:

WHEREAS, the Cairo Historical Society has requested the use of the front lawn of Town Hall and the closure and use of Railroad Avenue from Main Street to the Cairo Firehouse for their 2nd Annual Temperance and Tommy Guns Prohibition Street Festival,

WHEREAS, the Cairo Historical Society has requested the use of picnic tables and garbage pails; therefore, be it

RESOLVED, that the Town Board of the Town of Cairo authorizes the use of the Front Lawn of the Town Hall of Cairo and the Closure and Use of Railroad Avenue from Main Street to the Cairo Firehouse for the Cairo Historical Society's 2nd Annual Temperance and Tommy Guns Prohibition Street Festival on June 16, 2012 from 9 am to 10 pm.

All members in favor – motion carried.

Resolution No. 80 -12 "Authorization for the Town Clerk to Attend Conference" offered by Councilperson Joyce and seconded by Councilperson Ostrander:

BE IT RESOLVED, that the Town Board of the Town of Cairo does hereby permit Tara Rumph, the Town Clerk, to attend the 30th Annual New York State Town Clerk's Association conference from April 22nd to the 25th at a cost of \$465.72.

All members in favor – motion carried.

Resolution No. 81-12 "Remit \$144.64 to the NYS Retirement System" offered by Councilperson Ostrander and seconded by Councilperson Joyce:

WHEREAS, Jack Pagliaroni was an employee of the highway department in 2005 from October 17th to December 21st and 3% NYS Retirement Contributions of \$144.64 were withheld from his pay that were not reported nor disbursed to the NYSA Retirement System; and

WHEREAS, upon review it is necessary to report his time worked and submit the contributions withheld to the NYS Retirement System; therefore be it

RESOLVED that the sum of \$144.64 be expended from budget line item DA-9010.8 ERS Retirement and remitted to the NYS Retirement System.

All members in favor – motion carried.

Resolution No. 82 -12 "Appointing Attorney for the Town" offered by Councilperson Ostrander and seconded by Councilperson Joyce:

BE IT RESOLVED, that the Town Board of the Town of Cairo does hereby appoint Tal G. Rappleyea, Esq. as Attorney for the Town of Cairo for a time period of 90 days from April 1, 2012 to June 30, 2012 at a monthly retainer of \$1,000.00 and at the rate of \$125.00 per hour for such further litigation, legislation and other representation that the Town Board shall deem to be outside the scope of the monthly retainer. The Attorney for the Town is not an employee but has the status of an independent contractor.

Resolution No. 83-12 "Authorization to Designate a Bookkeeper" offered by Councilperson Ostrander and seconded by Councilperson Joyce:

BE IT RESOLVED, that Ted Banta, Supervisor of the Town of Cairo is hereby authorized to designate Louann Arp to the full-time position of bookkeeper for 90 days from April 1, 2012 to June 30, 2012; salary for the 90 days will be based on the annual salary of \$32,136.00.

Resolution No. 84-12 "Appointing Auditing Firm for the Town of Cairo" offered by Councilperson Ostrander and seconded by Councilperson Joyce:

BE IT RESOLVED, that the Town Board of the Town of Cairo does hereby appoint Patterson, Koskey, Howe & Bucci, CPA, P.C. as the Auditing Firm for the Town of Cairo for a time period of 90 days from April 1, 2012 to June 30, 2012 according to the terms provided in the Letter of Understanding dated December 14, 2011.

Resolution No. 85 -12 "Appoint Member to the Board of Ethics Review" offered by Councilperson Ostrander and seconded by Councilperson Joyce:

BE IT RESOLVED, that the Town Board of the Town of Cairo does hereby appoint Barbara Annis as the fifth member to the Board of Ethics Review formed on 7/21/10 for a three year term to conclude on December 31, 2014 at a rate of no pay as it is a volunteer position.

Resolution No. 86-12 "Authorize Use of Angelo Canna Park Pavilion by Medusa Meadows for a Farmers Market and Authorize Supervisor to Execute Contract" offered by Councilperson Suttmeier and seconded by Councilperson Joyce:

BE IT RESOLVED, that the Town Board of the Town of Cairo does hereby authorize Medusa Meadows, LLC, to operate "The Farmers' & Artisans' Market of Cairo, NY ("The Market") at the pavilion in Angelo Canna Town Park on Saturdays from June 16, 2012 through October 13, 2012, 8 am through 3 pm, and

BE IT FURTHER RESOLVED, that Supervisor Ted Banta is hereby authorized to execute an appropriate contract with Medusa Meadows, LLC for the operation of such Market.

Resolution No. 87-12 "The J S McHugh Change Order #1" offered by Councilperson Joyce and seconded by Councilperson Suttmeier:

4th of July Supervisor Banta suggested having a charity softball game on the 4th of July along with other events to make it a family day. The day would finish with fireworks in the park. The Town received a quote of \$4,000 for fireworks from Misbehaven. Supervisor Banta would like to make this a nice half day event for Cairo.

Subject: Town Employee Handbook

Doug,

We have reviewed the Employee Handbook changes and offer the following:

Section 406 -Personnel File (page 7)

Immigration Form (I-9): There is no mandate requiring I-9 forms be filed separate from an employee's personnel file. However, the U.S. Department of Homeland Security recommends that employers keep I-9 forms separate from personnel records.

Section 802 - Vacation (page 25)

Accumulation: We believe that the language in the Employee Handbook currently provides that vacation leave credits must be used in the year it was earned. Specifically, the Employee Handbook states "An employee may not accumulate vacation leave credits. Any vacation leave credits remaining unused at the end of the last business day of the calendar year shall be cancelled."

Section 803 - Sick Leave (page 26)

Donation of Time: We believe that a provision regarding the donation of accrued time should not be included in the Employee Handbook. We agree that it should be in the sole discretion of the Town Board to allow employees to donate their time. If a situation presents itself which warrants the creation of a one-time sick leave donation program, the Town Board can, at that time, implement such a procedure on a non-precedent setting basis.

Section 806 - Medical Insurance (page 28)

Premium Payment: We believe the Employee Handbook provides the Town Board with the flexibility to change health insurance contributions for non-union employees. The next section, "Changes in Premium Contributions", provides as follows:

The amount of the insurance premium paid by the Town is subject to change by resolution of the Town Board. The Town Board will provide a two-month written notice of such change.

This gives the Town the ability to change the amount of contribution as long as it passes a resolution and provides 2 months written notice of the change. If this is not sufficient for the Board, the language could be amended as follows: "Employees are referred to the Town Supervisor for all questions related to health or other insurance."

Section 806 - Medical Insurance for Retirees (page 28)

Premium Payment: We believe the current retiree health insurance requirements are laid out; employees who retire with 20+ years of service do not contribute toward their health insurance and employees who retire with at least 15 years but less than 20 years contribute 50% for individual health coverage and 65% for family coverage. Moreover, the Town retains the ability to control the amount it will pay for retiree health insurance. The next section provides as follows:

Changes in Premium Contributions - The amount of the insurance premium a retiree or retiree's spouse is required to contribute is subject to change by resolution of the Town

Board. The Town Board will provide a two-month written notice of such change.

Accordingly, the Town Board can change the contribution requirement as long as it passes a resolution and provides 2 months notice.

INTER-MUNICIPAL AGREEMENT BY AND BETWEEN

THE TOWN OF CATSKILL

AND

THE TOWN OF CAIRO

THIS AGREEMENT made by and between the TOWN OF CATSKILL, New York (hereinafter referred to as "Town", "Provider", "Providing Entity", "Requester" or "Requesting Entity") and the TOWN OF CAIRO (hereinafter referred to as "Village", "Requester", "Requesting Entity", "Provider" or "Providing Entity").

WITNESSETH:

WHEREAS, this agreement is made pursuant to the Article 5-G, Section 119-o, of the New York State General Municipal Law and the inherent authority of the Provider and the Requesting Entity; and

WHEREAS, pursuant to Federal and State law the Provider and the Requester are allowed to enter into Mutual Aid Agreements to assist in times of emergency; and

WHEREAS, the Provider and the Requester desire to enter into a post and pre-event Mutual Aid Agreement; and

WHEREAS, the Provider and the Requester have been subjected to winds, rains, flooding and damage caused by Hurricane Irene and other associated rainfalls necessitating emergent responses and mutual aid and in the future may have similar catastrophic natural disasters; and

WHEREAS, the parties intend this agreement to facilitate the reimbursement of expenses incurred by the Providing Entity by the Requester through the Federal Emergency Management Agency ("FEMA").

NOW, THEREFORE, in exchange for valuable consideration received from the other IT IS MUTUALLY AGREED between the parties as follows:

1. <u>Purpose and Scope.</u> Due to a significant emergency such as fire, earthquake, flood, tornado, hurricane, hazardous material incident, terrorist incident or other such man-made or natural emergency disaster or public safety need, the highest ranking official of any

- political subdivision or public safety agency or their designee may render aid to or request aid from any jurisdiction, agency or organization. A public safety need, as used in this agreement, shall include any event or incident necessitating the mutual aid assistance from another public safety agency.
- 2. <u>Laws Governing.</u> When responding to mutual aid or emergency aid requests, political subdivisions or public safety agencies shall be subject to all provisions of the law as if it were providing service within its own jurisdiction. Requesting Entity and Providing Entity agree to be bound by the terms, covenants and conditions set forth in this agreement.
- 3. <u>Eligible Expenses.</u> The labor force expenses of a Providing Entity will be treated as contract labor, with regular and overtime wages or salaries and certain benefits eligible for reimbursement in accordance with FEMA policies, rules and procedures.
- 4. Examples of Emergency Mutual Aid. Emergency mutual aid work covered by this agreement includes, but is not limited to, the following:
 - a. Search and rescue, sandbagging, emergency medical care, debris removal;
 - b. Reasonable supervision and administration in the receiving party that is directly related to eligible emergency work;
 - c. The cost of transporting equipment and personnel by the Providing Entity to the incident site.
 - d. Provide labor personnel, equipment and machinery necessary for department of public works functions;
 - e. Law enforcement;
 - f. Costs incurred in the operation of the Incident Command System (ICS); such as operations, planning, logistics and administration, provided such costs are directly related to the performance of eligible work on the disaster or fire to which such resources are assigned;
 - g. State Emergency Operations Center or Joint Field Office assistance in the receiving party to support emergency assistance;
 - h. Assistance at the National Response Coordination Center (NRCC) and Regional Response Coordination Center (RRCC), if requested by FEMA (labor, per diem and transportation);
 - i. Dispatch operations in the receiving party;
 - j. Donations warehousing and management (eligible only upon approval of the Assistant Administrator of the Disaster Assistance Directorate);
 - k. Firefighting activities;
 - 1. Dissemination of public information authorized; and
 - m. Work associated with the performance of grantee's responsibilities as the grant administrator.

- 5. <u>Eligibility for Reimbursement.</u> Only Requesting Entities are eligible applicants for FEMA assistance. A Providing Entity must submit its claim for reimbursement to a Requesting Entity. Parties may be eligible applicants where statewide mutual aid agreements or compacts authorize the party to administer the costs of mutual aid assistance on behalf of local jurisdictions.
- 6. Remimbursement Limitations. Reimbursement for services rendered under this agreement shall be in accordance with any local, state and federal guidelines. Any political subdivision or public safety agency providing assistance shall receive appropriate reimbursement according to those guidelines. To be eligible for reimbursement by FEMA, the mutual aid assistance should have been requested by a Requesting Entity or in response to a declaration of emergency, major disaster or fire. Reimbursement shall be made in accordance with FEMA policies, rules and procedures.
- 7. <u>Records.</u> Both parties agree to keep detailed records of services requested and received and provide those records as part of the supporting documentation for a reimbursement request.
- 8. <u>Benefits.</u> Applicable benefits normally available to personnel while performing duties for their jurisdiction are also available to such persons when an injury or death occurs rendering assistance to another political subdivision or public safety agency under this section.
- 9. <u>Liability.</u> For the purposes of liability, all members of any political subdivision or public safety agency responding under operational control of the requesting political subdivision or a public safety agency are deemed employees of such responding political subdivision or public safety agency are subject to the liability and worker's compensation provisions provided to them as employees of their respective political subdivision or public safety agency. In addition, both parties agree not to seek reimbursement from the other for any monies not reimbursed from a third party.
- 10. <u>No Liability for Failure to Respond.</u> Neither party to this agreement shall be liable to the other for failure to respond to any call by the other, or delay, negligence or mistake in receiving or responding to any call, nor shall this agreement ever be interpreted as being an agreement for the benefit of any third party.
- 11. <u>Consideration</u>. The consideration for this agreement shall be the service given for the protection of lives and property by the Requesting Entity and by the Providing Entity, and no compensation, except eligible reimbursement as herein provided, shall accrue or be paid by either party to the other by reason of this agreement.
- 12. <u>Termination</u>. Either party may cancel this agreement by giving sixty (60) days' written notice to the other party.
- 13. Counterparts. This agreement may be executed in counterparts.
- 14. <u>Effective Date.</u> This agreement is effective as of _____

Dear Supervisor Banta,

As the Chairman of the Greene County Alternatives to Incarceration (ATI) Advisory Board, which has oversight of the Greene County Community Service Program for offenders, I am writing to you to let you know that the board is looking to expand the use of offenders to include public and not-for-profit worksites in your community. Having an offender perform a sentence of community service serves multiple purposes, including reducing taxpayer expenses by allowing an individual to serve his/her debt to the society and remain out of jail while they're held accountable for their transgressions. For many years, the program has suffered from a lack of available sites to place offenders, primarily due to a lack of supervision at a site, even though there are a number of agencies/organizations that could use "free labor" to do work that may not otherwise get done or would place an undue burden on an organization or your community if public employees are required to do such. At this time, the board is looking to gauge interest in your community regarding the enhanced use of community service offenders, and if your municipality or not-for-profit organizations therein would have available personnel to verify that the offenders did complete their assignments. Therefore, I ask that you contact me if you would be interested in hosting community service workers, or to advise of possible non-profit agencies in your community that may be interested in doing so. The board is also willing to meet with you for further discussion, should you desire.

Ok, do we have any preferred dates?

How are we going to handle the diamond drilling company. From the US side or the UK?

Core diameter was fixed by the drilling company choice. It will be up to us how deep and how many.

One way to remediate is to cut down centre, clamp and cut again. This gives us a centre slice. WE then trim off the edges and have an uncontaminated section for geochem. In reality if the core volume is large enough we are ok as contamination will be on the edges. Our drilling fluid would be water.

Hi Bill,

for a provisional discussion, we are looking at

6 cores, up to 2 meters deep and 2.5 inches diameter (or 4 - see below).

Would that be enough to get you started in your discussion?

I can't see that we are going to try to do loads more than that in that site. If we choose exactly where, it could almost certainly be done in one day. It doesn't seem like a huge operation - probably just one moderately small truck......

We are probably looking at later in the summer rather than earlier, but we need to have a think about all of that. We are just about to advertise for the postdoc for the project.

We don't want the cores any smaller than this. We could do bigger (4 inches), then we run into increased problems of moving them around and cutting them, which we need to resolve. On the other hand, bigger may be better for you/us in terms of sedimentology, so it is worth you thinking about that. So you could say 2.5 or 4 when you talk to them and see what they say.
