### Minutes

#### Town of Cairo Town Board Meeting Location: Town Hall Meeting Room @ 7:00 PM

#### August 28, 2013

The Town Board of the Town of Cairo met for a board meeting on Wednesday, August 28, 2013 at the Town Hall, Main Street, Cairo, New York.

Supervisor Banta called the meeting to order at 7:15 PM and then asked the attendees to Pledge Allegiance to the flag. Councilperson Ostrander, Councilperson Joyce, Councilperson Suttmeier were present. Councilperson Puorro was absent.

<u>**Resolution No. 186-13**</u> - "Exemption of Greene County From Land Use Laws" offered by Supervisor Banta and seconded by Councilperson Ostrander:

**WHEREAS,** Greene County (the "Owner") has requested that the Town Board of the Town of Cairo make a determination with regard to whether it shall be exempt from the applicability of the Town's land use laws in relation to its proposal to subdivide a portion of a parcel of land containing a soccer field and other recreational uses, to allow a donation thereof to the Town of Cairo; and

WHEREAS, the Town Board recognizes that there is significant case law on point, with regard to the exemption of such a project including In the Matter of the County of Monroe, 72 NY2d 338 (1988), which held that a balancing test must be performed to determine whether a project of a municipality or agency thereof, is exempt from the local land use regulation weighing the following factors: 1) Legislative intent; 2) Nature and scope of the instrumentality seeking immunity; 3) The kind of function or land use involved; 4) The extent of the public

interest to be served; 5) The effect local land use regulation would have on the enterprise; 6) Impact on legitimate local interests; 7) Alternative locations for the facility in less restrictive zoning areas; 8) Alternative methods of providing the needed improvement; 9) intergovernmental participation in the project development process; and 10) Opportunity of the public and others to be heard; and

**WHEREAS**, the Owner is a municipal corporation duly organized under the laws of the State of New York and is the County government within which the Town of Cairo is located; and

**WHEREAS**, specifically the project includes a proposal to subdivide approximately Acres of land from an existing acre parcel which contains several municipal uses and buildings; and

WHEREAS, the Town of Cairo does not have a zoning law or ordinance, but does regulate subdivisions with a duly enacted Subdivision Local Law and the action would involve the approval of a minor subdivision, as that term is defined therein, by the Cairo Planning Board, and

WHEREAS, the Town caused a notice to be published in the official newspaper of the Town notifying the public of the public hearing on the issues herein and allowed the public an opportunity to be heard and there being testimony from several members of the public in favor of the project and no opposition voiced either against the project or against the granting of an exemption pursuant to the County of Monroe, and

**WHEREAS**, following a discussion and analysis of the aforementioned issues and testimony, offered a motion which was seconded by and carried:

NOW, THEREFORE, BE IT RESOLVED, that the Board finds that the Legislative intent as it relates to the within matter is found in the Comprehensive Plan of the Town of Cairo. The Comprehensive Plan acknowledges the existence of the recreational opportunities within the Town and recommends as a part of the future vision of the town, at pages 6 and 7: "IN THE FUTURE...Cairo is an aesthetically pleasing, well maintained community where civic pride and friendly, positive attitudes drive our success at providing a high quality of life for residents. Our community is sustained by a diversity of cultural recreational (emphasis added) and opportunities for all ages...Additional recreational opportunities have been created, such as a community center for teens, swimming, and nature enjoyment." (Emphasis added). Town of Cairo, Comprehensive Plan, at Pages 6-7. Clearly, the Comprehensive Plan contemplates that recreation is an important asset for the Town of Cairo both now and in the future.

**IT IS FURTHER RESOLVED**, that the Town Board finds that the nature and scope of the instrumentality seeking immunity, the kind of function or land use involved and the extent of the public interest to be served are as follows: Greene County is a municipal corporation duly organized under the laws of the State of New York and is the County government within which the Town of Cairo is located. The Town and County have a long history of cooperating with and supporting one another. The property is already being used for recreational purposes and the Town wishes to ensure that such use continues, and

**IT IS FURTHER RESOLVED**, that the Town Board finds that the effect local land use regulation would have on the enterprise would be minimal since as discussed above, the current and future proposed use as soccer fields for recreational activities of the Town residents and the ministerial act of creating a subdivided parcel for the purpose of conveying the land to the town will have no real or practical effect on the community, the environment or other factors, and

**IT IS FURTHER RESOLVED**, that the Town Board finds that there shall be no impacts on legitimate local interests of any kind. As mentioned above, the current and future proposed use as soccer fields for recreational activities of the Town residents and the ministerial act of creating a subdivided parcel for the purpose of conveying the land to the town will have no real or practical effect on the community, the environment or other factors, and

**IT IS FURTHER RESOLVED**, that the Town Board finds that there are no alternative locations for the facility in less restrictive zoning areas and that there are no alternative methods of providing the needed improvement. The Town currently does not have zoning and the minor subdivision required by the action is inconsequential; and

**IT IS FURTHER RESOLVED**, that the Town Board finds that there has been and shall continue to be considerable intergovernmental participation in the project development process. Both the Town and the County have been contemplating, discussing and planning the action which is proposed for several years. Indeed, in 2008 the Town granted the County immunity from the town land use regulations in connection with the construction of the soccer fields in a

similar Monroe style analysis and resolution. Public input was sought and received at that time, which resulted in unanimous support for the project, and

**IT IS FURTHER RESOLVED**, that the Town Board finds that there has been ample opportunity for the public and others to be heard. The public hearing was conducted in an open meeting at the Town Board's regular meeting, following notice thereof being published in the Town's official newspaper and there was again unanimous support for the project during public comment, and

**IT IS FURTHER RESOLVED** that the Town Board of the Town of Cairo hereby finds that upon the balancing of all factors in relation to the subdivision of the land for conveyance, by way of donation, to the Town is exempt from the applicability of the Town of Cairo land use regulations and subdivision approval by the Planning Board is not required; and

**BE IT FURTHER RESOLVED**, that the Town Clerk is directed to file this Resolution in the appropriate index within five (5) business days.

Unanimous vote of 5 to 0. The Town Board of the Town of Cairo herby determines under the County of Monroe "balancing test" that the subdivision of the land for conveyance, by way of donation, to the Town is exempt from the applicability of the Town of Cairo land use regulations and subdivision approval by the Planning Board is not required.

<u>**Resolution No. 187-13</u></u> - "AUTHORIZING THE SUPERVISOR TO EXECUTE NECESSARY DOCUMENTS TO ACCEPT DONATION OF SOCCER FIELDS FROM THE COUNTY OF GREENE" offered by Councilperson Suttmeier and seconded by Councilperson Joyce:</u>** 

WHEREAS, the County of Greene has offered to subdivide the existing soccer fields from other county lands and the Town of Cairo has granted the County immunity from the subdivision town local law, and

WHEREAS, the Town Board hereby determines that it is in the best interest of the residents of the town to accept such donation, therefore

Be it resolved, that the Supervisor of the Town of Cairo is hereby authorized to

execute the all necessary documents to complete the conveyance of the soccer

fields to the Town of Cairo and that such donation is hereby accepted.

All members in favor-carried

<u>**Resolution No. 188-13**</u> - "No Negative Impact Determination" offered by Councilperson Ostrander and seconded by Councilperson Joyce.

Be it resolved, that the Town Board of the Town of Cairo does hereby determine there is no negative impact with the Cairo Town Park Improvements/Soccer Field Project.

All members in favor-carried

<u>**Resolution No. 189-13**</u> - "Receipt of Monthly Supervisor's Report" offered by Councilperson Ostrander and seconded by Councilperson Suttmeier.

WHEREAS, it has been recommended by the NYS Comptroller's Office in the Town of Cairo report of Examination 2008M-175, that the Supervisor should present a Monthly Report to the Board Members consisting of cash receipts, cash disbursements, and a budget versus actual report for expenses and revenues, and it be documented in the minutes; therefore, be it

RESOLVED, that the Town Board Members accept the monthly Supervisor's Report for July, 2013.

All members in favor-carried

<u>**Resolution No. 190-13**</u> - "Accepting Sewer Billings" offered by Councilperson Suttmeier and seconded by Councilperson Joyce.

WHEREAS, it is necessary for the Water Billings be authorized by the Town Board and documented in the minutes; therefore, be it

RESOLVED, that the Town Board accepts the Sewer Billings as presented from the Water Administrator in the amount of \$32,569.50 dated August 1, 2013.

All members in favor-carried

<u>Resolution No. 191-13</u> "Authorize Amendments to the Library's Capital Fund Project Form E" offered by Councilperson Suttmeier and seconded by Councilperson Joyce. BE IT RESOLVED, that Administrative line items be amended as follows:

A.1 Legal: Reduce the approved budget of \$12,000.00 to \$5,593.50. The balance of \$6,406.50 will be allocated to the Contingency line item.

A.7 Audits: Reduce the approved budget of \$18,000.00 to \$12,000.00. The balance of \$6,000.00 will be allocated to the Contingency line item.

BE IT FURTHER RESOLVED, that Technical Services line items be amended as follows:

B.1.c Contract Administration: Increase Contract Admin. (BRMA) to \$106,180.00 for the remaining contract administration. The additional \$1,000.00 will be deducted from Contingency.

BE IT FURTHER RESOLVED, that Construction line items be amended as follows:

C.1.i Contract 9 – FFE: Increase \$10,767.45 to cover HON furniture purchases making the Approved Budget \$200,543.95. The additional \$10,767.45 will be deducted from Contingency.

These increases and reductions will make the Contingency line item \$395,070.42.

<u>**Resolution No. 192-13</u>** "Authorization to Attend NYS Association of Magistrates Court Clerks Conference" offered by Councilperson Joyce and seconded by Councilperson Ostrander:</u>

WHEREAS, the Town of Cairo Court Clerks are requesting permission to attend the New York State Magistrates Court Clerks Conference at the Holiday Inn in Albany, NY on October 7th and 8th, 2013; and

WHEREAS, the mileage will be reimbursed at the approved mileage rate, and

WHEREAS, the cost to attend is \$250.00 for both clerks which includes meals and registration fees; therefore be it

RESOLVED, that Town of Cairo Court Clerks are authorized to attend the NYS Magistrates Court Clerks Conference.

All members in favor – carried.

<u>**Resolution No. 193-13**</u> "Accepting Water Penalties" offered by Councilperson Ostrander and seconded by Councilperson Joyce:

WHEREAS, it is necessary for the Water Billings be authorized by the Town Board and documented in the minutes; therefore, be it

RESOLVED, that the Town Board accepts the Water Penalties as presented from the Water Administrator in the amount of \$1,324.86 dated August 15, 2013.

All members in favor – carried.

<u>**Resolution No. 194-13**</u> "Authorize Amendments to the Library's Capital Fund Project Form E " offered by Supervisor Banta and seconded by Councilperson Ostrander:

BE IT RESOLVED, that Administrative line items be amended as follows:

A.1 Legal: Reduce the approved budget of \$5,593.50 to \$3,458.50. The balance of \$2,135.00 will be allocated to the Contingency line item.

BE IT FURTHER RESOLVED, that Technical Services line items be amended as follows:

B.1.c Contract Administration: Increase Contract Admin. (BRMA) to \$106,845.00.00 for the remaining contract administration. The additional \$665.00.00 will be deducted from Contingency.

These increases and reductions will make the Contingency line item \$396,540.42.

Other funding sources – NYS DLD Grant 2011 corrected from \$115,000.00 to \$115,747.00 making the total of Other Funding Sources \$283,291.00.

All members in favor – carried.

<u>**Resolution No. 195-13</u>** "Authorize Town Supervisor to Sign Certification for Technical Work Force Account Use" offered by Councilperson Suttmeier and seconded by Councilperson Joyce:</u>

WHEREAS, the NYS Environmental Facilities Corp. requires that the use of town employees to perform construction tasks be under the direct supervision of a professional engineer; and

WHEREAS, Delaware Engineering agrees to provide inspection and certification of the portion of the sewer project completed by town employees; and

WHEREAS, the Town of Cairo must certify that the employees possess the necessary skills to accomplish the work in a timely fashion and that time sheets for each employee performing technical work will be completed clearly identifying the task(s) performed, hours spent and hourly wages to complete the tasks; therefore be it

RESOLVED, the Town Board does hereby authorize the Town Supervisor to sign the certification for technical work force account use; and be it further

RESOLVED, that project funds allocated for net interest will be reallocated to the Technical Force Account line in the amount of \$40,500.00 to complete the excavation, inspection and repair of sewer tank risers as needed.

All members in favor – carried.

<u>**Resolution No. 196-13**</u> - "Approve Tax Assessor Continuing Education" offered by Councilperson Joyce and seconded by Councilperson Ostrander.

Be it resolved that the Town of Board of the Town of Cairo approves the attendance of a one day class for *Conservation Easements* @Columbia-Greene Community College on November 8, 2013, for Janice Hull's- The Town Assessor's continuing education certification. Any applicable expenses will be paid according to the Travel Policy.

<u>**Resolution No. 197-13**</u> - "Sponsor Candidates for Police Academy" offered by Councilperson Ostrander and seconded by Councilperson Joyce:

Be it resolved, that the Town Board of the Town of Cairo agrees to sponsor Theresa Neville, Nicholas Orso, and Corey Clarke for the 2013-2014 Zone 14 Police academy.

The following report cover's facility operations of the Waste Water Treatment Plant (WWTP) and collection system servicing the Town of Cairo.

#### WWTP

Flow, monthly average: July 27,000gpd

Compliance was met for the month of July.

**Comments:** 

The new filters went on-line on 7/22/09 and are performing well.

We're having problems with the Cumberland Farm's pump station. Emmon's Pump& Equipment are working on the "Tripping" issue. This has been an issue from start-up that needs to be resolved. The fence posts are in and the fence is up and looks good.

Contractor is almost done with the WWTP upgrades. He needs to complete the diffusor instillation on 1&2 SBR's then we can schedule Start-Up with Xylem, the equipment manufactor. This work is scheduled for September 9<sup>th</sup>.

Pinch valve is **"on-line"** as of this afternoon. This is the device that will allow us to regulate flow through the plant and enhance overall performance.





Subject: Well Drilling Proposals

Dear Supervisor Banta:

Quotations were selected from three drilling contractors. A limited number of quotes was obtained since the driller would be working under the direction of the Town's engineer to conduct exploratory drilling which, by its nature, requires a particular level of expertise.

Alpha Geoscience further assessed published geologic data and maps and concluded there is a potential for significant water in deeper gravel deposits. Since the potential exists, and since such water would likely be of a higher quality than a bedrock well they recommend drilling a well specifically to evaluate and test the gravel zone (above bedrock). I gravel well(s) were found the bedrock drilling would likely be unnecessary. If the gravel well does not prove productive the bedrock well would be drilled. For each type well, the work was itemized; so that if a pump test is obviously not needed then the work and costs can be omitted. The quotes obtained were as follow:

We received no quote from Stewart and could not reach anyone by phone today. It is possible they declined due to the gravel wells which I doubt they regularly drill many of.

The low quote was from Smith Well Drilling of Valatie, NY submitted the lower quote. Smith is a small family owned business operated by the owner Jeff Smith. They have worked for Alpha Geoscience and Delaware on numerous occasions and we can highly recommend them. We are recommending that the Town award the work to Smith Well Drilling for the net cost of the Gravel and Bedrock Wells for a total of \$23,988.

Note that we recommend meeting with organizations and key users of the park to reduce complaints about surface features of a finished well head that park users might find offensive or an obstruction. Please call me at 452-1290 if you have any questions.

Subject: Well House Flood Insurance

Dear Supervisor Banta:

In reviewing well sites in the park, it was noted that the existing well house is within the 100-year flood zone. The flood elevations marked suggest the floor of the well house was raised enough to technically be above the 100-year flood level. However, based on experience with the floods of two years ago and FEMA's handling of claims for public facilities in and around flood plains the Town should consider flood insurance if it is not already in place.

Following Irene, a municipal water, sewage and other facilities that were in such marginal flooding areas were heavily damaged, because the flood mapping in imprecise at best. Those facilities that did not have flood insurance were denied FEMA funding to rebuild or relocate. Those facilities above the 100-year flood, or that were in the flood zone and were insured, received insurance or FEMA funds better enabling them to make needed repairs.

The cost of flood insurance adds to the budget, but given the particular location of the well house it may very well be worth it here. Since the floor appears to be above the 100-year level, it may also make sense to have a flood elevation certificate done for the building. Kaaterskill has recently done this for us on a number of other facilities and the cost of the certificate may be made up in reduced insurance premiums.

#### Subject: Dangerous Intersection in Round Top

Dear Mr. Banta,

We have been tax paying residents of Round Top since 1978. Over the period of 35 years It has become quite apparent that there is a significant safety problem at the intersection at Hearts Content Road, Maple Lawn Road, County Road 31 and County Road 39. There have been serious accidents there as well as many near misses. There are stop signs on County Road 39 and Maple Lawn Road. When vehicles stop at those stop signs and look North on County Road 31, the drivers can only see about 200 feet because of the turn in the road and the trees blocking their visibility. Autos traveling South on County Road 31 have the right of way and travel faster than the 45 mile an hour speed limit. By the time the driver traveling west reaches the middle of the road, the car traveling south on County Road 31 is right next to them. This situation happens daily. Many vehicles drive on to the firehouse apron to avoid an accident. Many vehicles traveling South on County Road 31 make the turn onto County Road 39 on the wrong side of the road (making the turn to soon). The same thing happens with vehicles traveling North on Hearts Content Road. The drive faster than the speed limit and make a right turn on to County Road 39 crossing over to the wrong side of the road. Something needs to be done to correct this situation before someone gets killed. Members of the fire department tell stories of the many near misses that they witness when they sit just inside the firehouse. The owner of the building, where the Post Office is (a retired NJ Policeman) tells stories of many near misses and screeching brakes. This is a very busy intersection. The traffic on Hearts Content Road and County Road 31 has increased significantly since drivers use GPS Systems, as they found a shortcut to Route 23 and Windham.

I talked to the Greene County Highway Superintendent about this situation, when he was working at this intersection, trying to correct some of the problems. He was shocked what he witnessed in a short period of time. He suggested that we get as many residents as we can and attend a Town Meeting and ask the Cairo Town Board request the State of New York Highway Department perform a review of the area.

I do not have the time to do this, so I placed a petition in the Round Top Post Office for people to sign. I left it there for one week and got twenty three (23) signatures. I really do not understand why many more people did not sign it. I talked to several residents about it and they all agreed, but did not sign it. One woman told me "I agree with it ! I lived here all my life and figured it out-People now have GPS Systems and found a short cut to Route 23. "I asked her please sign the petition, however, she turned around and walked out. I guess people do not want to get involved.

I do not think this is a complicated issue, all the intersection needs is a 4 way stop sign and a reduction in speed. This simple fix could save a life.
