### **Town Board Monthly Meeting**

July 21, 2010

The Town Board of the Town of Cairo held a regular meeting on Wednesday, July 21, 2010 at the Cairo Town Hall located on Main Street, Cairo, New York. Supervisor Coyne, after a Pledge to the Flag, called the meeting to order at 7:30 PM with the following members present: Councilpersons Lorenz, Ostrander and Suttmeier. Councilperson Schwarzenegger was absent.

The approval of the minutes were tabled until the August Workshop.

Supervisor Coyne reported the roof repairs were completed.

Coyne reported he received a letter from Bob Rezsnyak resigning from the Board of Assessment Review Board. He agreed to finish out the year.

Tom Roe from WGXC gave presentation to Board about his proposal. His plan is to hang FM antennas on existing tower, also adding a small equipment shelter.

Attorney for the Town Tal Rappleyea explained that the existing law states the Town Board is the Review Board. It is the discretion of the Town Board to require the public hearing or waive the public hearing. Tal went through the SEQR Form and determined there is no negative impact on the environment.

There was discussion about the Lease Agreement with American Tower and there may be a few things for the Board to review.

**Resolution No. 143-10** - "Waive Public Hearing for Cell Tower Application" offered by Supervisor Coyne and seconded by Councilperson Suttmeier:

### **Town Board Monthly Meeting**

### **September 21, 2011**

The Town Board of the Town of Cairo held a regular meeting on Wednesday, September 21, 2011 at the Cairo Town Hall located on Main Street, Cairo, New York. Supervisor Coyne, after a Pledge to the Flag, called the meeting to order at 7:30 PM with all Board Members in attendance.

The approving of the minutes will be tabled until the workshop.

Supervisor Coyne reported the Town ran an ad in the paper for Board of Appeals and Board of Ethics members. He said they received one application for the Ethics Board and three applications for the Board of Appeals. The Board will set a date between now and the workshop to interview the applicants and then appoint members at the workshop.

Supervisor Coyne reported on the damage from Hurricane Irene:

Supervisor Coyne thanked Ewald Schwarzenegger for his help in the Town during the aftermath of Hurricane Irene. He also thanked Gerry Buckley, Fire Chief of Cairo Hose and Ed Maasmann, Fire Chief of Round Top, for their efforts during and after the storm.

There were many areas in the Town of Cairo that were damaged during the storm. There were a number of road and bridge closures due their instability and safety concerns. The bridge at Pollys Rock has been closed. Traffic has been re-routed through a driveway at Reidelbauers Resort. This driveway is in need of repair to accommodate for this traffic. The highway dept. will help and get the driveway fixed and pot holes filled in while the residents need to use it.

There was a land slide in Round Top. Representatives from DOT will assess the situation and provide the Town with a report.

There were homes destroyed during the storm. Many homes were condemned by the Building Department and residents displaced.

Coyne also reported the cleanup bills from the storm are starting to come in. The hurricane work was given to local contractors on a rotation basis. The Board discussed there would need to be budget adjustments until the Town is reimbursed from FEMA. Board received an informational packet from FEMA but it does not have a contact number for FEMA. It was reported that FEMA has great intentions, but no guarantees.

The Town Park was closed for about a week after the storm as Cairo was the central location for emergency help to the mountaintop. Helicopters bringing supplies were landing there and the Board didn't want anyone getting hurt.

Attorney for the Town Tal Rappleyea informed Board that the Town of Prattsville hired an expert in dealing with FEMA paperwork. Board will look at fees and scope of work and decide whether it would benefit the town.

Councilperson Schwarzenegger reported she has the name of an attorney who offered to do pro bono work for victims of storms trying to get assistance from FEMA.

Councilperson Ostrander explained how the Town was cited by Dept. of Labor for various violations. One of violations was for Workplace Violence training which is being held in the Town Hall in the morning for Department Heads. Board will pass resolution to accept Workplace Violence Policy.

Supt. Of Highways Steven Rumph will put a legal in the paper for the work that needs to be done in the Town from the storm. It will run for 5 days in the paper and all bids must be returned to the Town Clerk's Office by next Thursday, September 29, 2011 by 3:00 pm. The bid opening will take place on Friday, September 30, 2011 at 9:00 am.

Councilperson Schwarzenegger asked Board if the signs for the Nature Center were taken down. She also reported that Cornell Cooperative has not been posted.

Schwarzenegger asked about a meeting for zoning review and also for the Budget review. The Board will come up with a schedule at the Workshop of when to meet. The Tentative Budget needs to be given to the Town Clerk by October 5<sup>th</sup>.

The closing on the Sewer Loan with EFC will be September 29<sup>th</sup>. Supervisor Coyne reported the papers were signed today and send overnight to EFC in Albany.

Attorney Tal Rappleyea informed Board members of a new law limiting Towns from increasing the tax levy by more than 2 percent. He recommended that the Board pass a local Law overriding the limit on the amount of real property taxes that may be levied by the Town of Cairo pursuant to General Municipal Law Section 3-c, and to allow the Town of Cairo to adopt a budget for the fiscal year beginning January 1, 2012, and ending December 31, 2012 tht requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law Section 3-c.

Legislators Lawrence and Lennon attended the Town Board meeting. They reported they requested a Flood Relief Act. They have asked the governor to step in.

They reported the VA hospital was going to be moved to. Lawrence and Lennon suggested writing a letter in support of keeping clinic in Catskill.

**Resolution No. 168 -11** - "Accept EDU Billings dated September 1, 2011" offered by Councilperson Suttmeier and seconded by Councilperson Lorenz:

Whereas, it is necessary for the EDU Billings be authorized by the Town Board and documented in the minutes; therefore, be it

George Kleinmeyer reported to Board that no one has been to his house to help. DEC is to come up with plan. Soil and water has not offered any help. Army Corp. and Jeff Flack will determine what plan will remedy situation.

On Bogardus Rd. Mr. Reinwald complaining about his mailbox being blocked by rocks.

Residents from the South Durham Estates Road informed Board the culvert was washed out from Hurricane Irene. They would like to request consideration from the Town for help to fix it. South Durham Estates Road is a private road.

Mr. Fritz on Ross Ruland Rd. contacted the town in 2008. The highway came out to assess the problem. The culverts are filled. They need a catch basin.

George Weiss said the town should come up and put item 4 on Reidelbauer's property since the residents from Pollys Rock are using their driveway to get to Winter Clove. Since the Town is under a State of Emergency the highway can go in on private roads and fix them.

The Perrones asked about fixing the bridge on Pollys Road and when it would be open.

John Jarvis asked about Suttmeier's bridge in South Cairo. The bridge needs to be addressed due to the erosion and should be marked with signs.

Ewald Schwarzenegger reported that there may be other money for repairs from FEMA. He wants to get the word out to other town residents.

Mrs. Young reported that she lost another foot and a half of property. She reported there was brush and garbage in the culvert. Soil and water conservation will be going out to assess the situation.

Bob Hempstead said that in emergencies, Supervisor John Coyne could give permission to Highway Superintendent Steven Rumph to make a road.

### October 19, 2011

The Town Board of the Town of Cairo held a regular meeting on Wednesday, October 19, 2011 at the Cairo Town Hall located on Main Street, Cairo, New York. Supervisor Coyne, after a Pledge to the Flag, called the meeting to order at 6:00 PM with all Board Members in attendance.

The minutes of September 19<sup>th</sup> Board Meeting will be reviewed by Board Members and approved at the workshop.

Supervisor Coyne went over Hurricane Irene Update. He reported on the landslide on Blackhead Mountain. DEC will bring a specialist to look at it and determine what to do. At this time, another landslide has been found in the same area.

Councilperson Schwarzenegger had Supervisor Coyne sign voucher for Greenway Commission to get grant money for the Zoning Commission.

Councilperson Schwarzenegger redid form for Change of Request form for Sewer.

A meeting to interview members for the Board of Appeals and Ethics Board will be held on Tuesday, October 25<sup>th</sup> at 3:00 pm. Carrie will make copies of the letters and resumes and put them in Board boxes.

Deputy Clerk/Supervisor Clerk Carrie Anderson has a call into Main Care for a new outdoor tank for fuel for the back of the Town Hall.

### **Public Comment**

Highway Superintendent Steven Rumph informed Board that there is some additional work that needs to be done by Maple Ridge as far as the stream stabilization projects. Board will review bill and authorize when work is done.

### Park

The Board discussed the condition of the Salvation Army clothing drop boxes at the recycling center at the town park. Councilperson Ostrander will contact the Salvation Army regarding a pick-up schedule.

Councilperson Ostrander being on the Park Committee expressed the wishes of the group to be recognized as a task force by resolution. There would be no term appointment for members.

### **Hannaford Brothers Project**

A representative from Hannaford Brothers made a presentation to the Town Board regarding the repairs and dedication of the paper street Lake Ave.

Resolution No. 195-11 "Acceptance of a Portion of Lake Avenue and Oak Street" offered by Councilperson Schwarzenegger and seconded by Councilperson Lorenz: Be it resolved that the Town Board of the Town of Cairo does hereby accept as a town road, those portions of Lake Avenue, Oak Street and land of Cairo Plaza, LLC (collectively "Proposed Roadway"), identified for dedication to the Town on plans entitled "Hannaford Supermarket & Pharmacy and Retail Shops" dated August, 2011 – Sheets OFF 0-9 (Submission for Town Board

Review 10/31/11) – prepared by Deluca-Hoffman Associates, Inc., P.C. (the "Off-Site Roadway Plans"), which plans were submitted by Hannaford Bros. Co. ("Applicant") for Site Plan approval and approved by the Town Planning Board on October 25, 2011; and as submitted to the Town Board on November 3, 2011, subject to the receipt by the Town Supervisor of the following on or before December 31, 2013:

- 1. The Applicant shall provide to the Town Highway Superintendent contractor certification that the Proposed Roadway has been constructed in accordance with the Off-Site Roadway Plans, together with copies of test reports for sub-base aggregate compaction, and an As-Built Survey. The Town Highway Superintendent shall then indicate to the Town Supervisor that the Proposed Roadway is ready for acceptance by the Town.
- 2. The Applicant will provide a Deed or Deeds to the Town conveying good and marketable title to the Proposed Roadway.
- 3. The Applicant will provide a Title Insurance Policy Commitment showing good and marketable title to the Proposed Roadway, subject only to private rights of way of present neighboring landowners and utility easements, together with the Applicant's check for the title insurance premium.

### **Summer Recreation**

The Board along with Summer Recreation Coordinator Janet McKeon discussed the program's policy for charging fees and possible changes for the 2012 season. The issue will be readdressed at the December 2011 Workshop.

### Highway

### **February 22, 2012**

Supervisor Ted Banta, called the meeting to order at 7:00 PM and then asked the attendees to Pledge Allegiance to the Flag. Board members present: Councilperson Ostrander, Councilperson Suttmeier, Councilperson Joyce and Councilperson Puorro.

Supervisor Banta informed Board and Public that the Cairo Website is up and running. He is in process of inputting all information along with meeting agendas and minutes.

Elizabeth Brinkeroff gave presentation on Town Park and some plans for the near future.

Superintendent Robert Hempstead gave presentation on the Buildings and Grounds and Highway Dept. in the Town of Cairo. After a question regarding a Clean-up day, Hempstead feels the Highway Dept. should not handle the Clean-up day at the highway garage each year. He suggested a scheduled event approved by the Town Board for the residents to bring their items to Solid Waste in Catskill.

The Board will discuss the cleanup-day further at the workshop session in March.

The minutes for the January 25, 2012 Board Meeting were accepted by Supervisor Banta and seconded by Councilperson Ostrander.

<u>Ambulance</u> Ambulance Administrator Reay Mahler reported they are soliciting bids from 3 vendors for a new ambulance. Bids will be opened on March 28, 2012.

**<u>Dog Control</u>** Police Chief Chris Sprague reported the Dog Shelter is in need of old blankets for the dogs. There are 3 dogs up for adoption. Supervisor Banta asked Sprague to get pictures of them, so the dogs up for adoption could be put on the website.

Supervisor Banta reported the Workshop scheduled for March 14 will be cancelled due to no quorum. He asked Board Members to meet one hour before Workshops each month. He also reported the IT issues in the Town need to be addressed immediately.

The first order of business for the meeting was to present Debra Kamecke, the Distinguished Librarianship Award, for her achievements with the Cairo Public Library. Debra Kamecke received the L. Marion Moshier/Asa Wynkoop Award for Distinguished Librarianship. The award honors a library director who has given outstanding service to a community of 7,500 in population or less.

Warren Hart, Director of the Department of Economic Development, Planning & Tourism gave a presentation about programs available for small business training classes and funding. He reported that Greene County also has economic development loan funds available for job-creating projects through its Quantum Fund.

Mr. Hart also informed of some of the new events coming to Greene County this year.

Supervisor Banta introduced Robert Bradley as the new owner of the Family Dollar on Main Street in Cairo.

The minutes for the February 22, 2012 Board Meeting was accepted by Councilperson Joyce and seconded by Councilperson Ostrander.

Ethics Board Supervisor Banta reported on the Ethics Board which was established on 7/21/10. The members still willing to service and who were reappointed/reconfirmed on February 22, 2012 were Donald Gibson, Sr., Denise Daly, Joseph Kames and Kathleen Passaro. Supervisor Banta was able to speak with the 5<sup>th</sup> member, Barbara Annis, who was previously appointed. Barbara stated that she was interviewed and sent a letter of acceptance. She also stated that a meeting was scheduled and then cancelled, and nothing more was done.

**Farmers Market** Chuck Solberg, owner of Medusa Meadows Farm and the Catskill Country Store addressed the Board about having a Farmers Market in the Cairo Town Park starting June 16 through October 13. Mr. Solberg wants to get the local community groups involved to foster a sense of community pride. He also explained that the Farmers Market would not interfere or be a conflict with events already scheduled for the park.

Town Property Forest Management Supervisor Banta will contact Forest Manager to see what opportunities are available to the Town, such as logging. Councilperson Joyce suggested looking into the possibility of generating revenue for the Town by logging/thinning the trees on the Town properties.

Parking Lines on Main Street

Councilperson Suttmeier suggested having the lines on Main Street done before Memorial Day Weekend. Supervisor Banta informed Board that Highway Superintendent Hempstead purchased machine to do lines in-house to save money for Town
