Public Hearing on CR.23B Bridge Rehabilitation

Greene County Highway Superintendent, Bob VanValkenburgh, County Engineer, Stan Wase, and representatives of Creighton Manning gave a presentation on the County Route 23B (Main Street) Bridge Rehabilitation work that is scheduled to begin in May of 2019. Creighton Manning explained to residents the deficiency in the guide rails, water lines, concrete abutments, and wearing surface. Total estimated time for repairs is three months. Easements will need to be acquired and will be paid fair market value. It was asked that before work begins, can they research installing a dry hydrant.

Public hearing closed at 7:06

The Town Board of the Town of Cairo met for a Town Board Meeting on Monday, April 2, 2018 at the Town Hall, Main Street, Cairo, New York.

Supervisor Benoit called the meeting to order at 7:06 pm with all board members present and asked the attendees to Pledge Allegiance to the Flag.

Commercial Solar Moratorium Public Hearing

Supervisor Benoit explained about the installation and development of Solar farms and introduced a proposed law to enact a six month moratorium on Solar farms. He asked if anyone had any questions. A representative of Clean Energy Collective stated that he submitted plans for a solar farm 12 weeks ago and since they were the only project in town, it would be unfair to stop project. Questions arose about manufacturing and materials used in panels. Clean Energy Collective representative stated there isn't any toxicity in the panels. They are green products. Solar panels were previously manufactured in China but now they are manufactured in the US by the Tesla Group.

Supervisor Benoit made a motion to close public hearing at 8:15pm and seconded by Councilperson Warner. All members were in favor – motion carried.

Resolution No. 82A -18 "Waive Building Permit Fee" offered by Councilperson Cords and seconded by Councilperson Joyce:

BE IT RESOLVED, that the Town board of the town of Cairo does hereby waive building permit fee for the building on Railroad Avenue owned by the Cairo Historical Society.

Robert Flores from Delaware Engineering gave an update on the water meters. 70 meters installed. He stated they were having trouble setting up appointments and to catch home owners home or to get them to return phone calls. Discussion arose about the town to send letters and Tal will check water law.

Jesse from Little League wanted permission to install a water irrigation system and new sod on the little league field in the Town Park. There will be four sprinkler heads at 2 ½ gallons per minute. Town Board approved the project with the understanding a water meter will be installed and water usage formula must be created. Project will begin April 11th and any volunteers are welcome.

Supervisor Benoit updated the board on the sidewalk project. Public presentation will be at May 2018 regular board meeting with project specifications.

The soccer field will commence construction the third week in April with a 6-8 week phase of work.

The annex is nearing completion.

The discussion arose over updating the town's fee schedule and the handling of fire inspections.

Councilperson Warner stated that there will be an active shooter training which will cost \$50.00 per officer. He will mention this to Sergeant Busch.
