# May 7, 2018

The Town Board of the Town of Cairo met for a Town Board Meeting on Monday

May 7, 2018 at the Town Hall, Main Street, Cairo, New York.

Supervisor Benoit called the meeting to order at 7:05 pm and asked the attendees to Pledge Allegiance to the Flag.

Attendance: Supervisor Benoit, Councilperson Cords, Councilperson Joyce, Councilperson Warner and Councilperson Watts were present.

Presentation on the Sidewalk Project was given by Tony Christian from Creighton Manning. He discussed about the funding, the design, and materials to be used.

The public brought up about the bike path along the old railroad tracks and the safety. The path on old railroad track (Wm. Dinger Drive) had to be put in, to receive the grant. The public brought up about some of the old sidewalks that where in bad shape. Since they were not put in the original grant the sidewalks could not be added to the grant.

Supervisor Benoit introduced Eagle Scout Erwin Lampman who is with the Boy Scouts of American. Scout Lampman wants to do an Eagle Scout project by cleaning up the Rudolph Weir Cemetery which is in bad shape. In the cemetery there are war veterans that are buried in there. Scout Lampman asked the board if the town would be able to keep it up.

Scout Lampman is also looking to put a sign up for the cemetery. Supervisor Benoit and the board would like to see a drawing of the proposed sign first.

Supervision Benoit and the board have no problem with him doing his project and long as it is a public cemetery and in the Cairo Township.

Supervisor Benoit announced the Cairo Development Foundation received a \$ 20,000 Technical Assistance Grant. The Technical Assistance Grant is to hire an engineer firm to help get the funding the Main Street Grant which is available.

The Public Hearing on the Solar Moratorium on LOCAL LAW NO. 1 OF THE YEAR 2018: Supervisor Benoit and board discussed if there had to be changes to the law. Supervisor Benoit talked about the panels in Rogers Garage and Rose Motel, both have large parcels of land. The percentage of land on these two projects is low and did not see about any restrictions.

The public brought up about the vegetation around the panels and if herbicides would used. A gentleman from one of the solar companies spoke and told them that they use slow growing grasses.

Supervisor Benoit makes motion to close the public hearing seconded by Councilperson Cords, Councilperson Joyce-Aye, Councilperson Warner –Aye and Councilperson Watts-Aye. Motion carried.

Supervisor Benoit went on to existing business starting with the water meter installations. The meters are about half way done. They are having problems with the people making and keeping appointments.

Supervisor Benoit gave update on the sidewalk project there still have to have an environmental review done.

Supervisor Benoit stated that the soccer field is coming right along.

Supervisor Benoit stated the Annex building is close being finished.

Supervisor Benoit stated that it will be named after Floyd Hempstead Municipal Annex. A sign will be put up in Chief Hempstead's honor.

Supervisor Benoit spoke with Senator Amedore about the Ambulance building. Senator Amedore talked to Supervisor Benoit about a USD grant. Senator Amedore assistance sent the paperwork the Supervisor Benoit. Supervisor Benoit is working on it now.

Supervisor Benoit received correspondence from the Greene County Veterans Service Agency to Honor a Vet Memorial Ceremony.

This year they will honor Technician Fourth Grade Alfred A. Daoust who was enlisted in the United States Army on April 14, 1942. He was a recipient of the Bronze Star Metal.

The ceremony held on Saturday May 19, 1918 at 10:00 AM on the Greene County Courthouse steps at 320 Main Street, Catskill, NY.

Supervisor Benoit brought us new business on change in zoning. Supervisor Benoit and discussed changing in wording on keeping Main Street mixed use.

Supervisor Benoit and board discussed having public hearing. Supervisor Benoit offered and seconded by Councilperson Warner. Supervisor Benoit- Aye, Councilperson Cords- Aye, Councilperson Joyce- Aye, Councilperson Warne – Aye, and Councilperson Watts. Motion carried.

Supervisor Benoit brought up about charging outside entities for use of the park.

Councilperson Watts offered to look into it.

There were no reports from the Board Member Liaisons.

**BE IT FURTHER RESOLVED**, the Town Board of the Town of Cairo does hereby set the rate of pay for the Zoning Board of Appeals Clerk to be \$30.00 per meeting.
