Water Meter Installation:

### **New Business:**

Park Camera Replacements:

Sergeant Rick Busch would like to replace the old cameras in the Angelo Canna Town Park. Out of all of the cameras only one is left working. CIA security would cost over 13,000 to replace the cameras. Spoke with Todd at Toad's Stereo, and can purchase a 16 camera system, which cost \$549 with a monitor for another \$100. It will record for at least a month and up to 3 months with 24/7 recording.

The Town Board received a letter from Council about the recent Supreme Court decision of Janus vs. AFSCME. 'You cannot take agency fees from employees who aren't members of the Union without their permission.'

Health Dept – Acra Community Center:

The Greene County Senior Nutrition Program site was visited by the NYS Department of Health on June 11<sup>th</sup>, 2018. Three citations were noted; there are no separate hand washing sinks in the bathroom, missing floor tiles on the kitchen floor and unshielded florescent lights in the kitchen over the sink and serving counter.

Residents on Halfmoon Drive in Cairo address the situation at the Woodstock Dam. Concerns consist of noise and trash pollution, along with the dangers that they can be liable for. Also concerns of who in fact owns the property due to a large group of people who had recently went into the creek.

# <u>Resolution No. 2018-107</u> "Authorize Justice Court Clerks' Attendance at the Annual Fall Court Clerk Training"

**Whereas**, the efficient operation of the Town Court requires regular, updated training in current practices and procedures, now therefore

**Be It Resolved**, that the Town Board does hereby authorize Court Clerks Joan M. VanDenburgh and Kathleen Costanza to attend the Magistrates Association Fall Training for a total cost not to exceed \$1,158.00, including 1-room, double occupancy, also including meals as set forth in the Reservation Lodging Form, a copy of which is annexed hereto, and, calculated as follows:

# <u>Resolution No. 2018-112</u> "Local Law #4 of 2018, Amendment No. 2018-3 to the Town of Cairo Zoning Law of 2017 – Modifications to the Main St. District and Commercial Solar District Criteria."

**Whereas**, the Town of Cairo's Comprehensive Plan Calls for a vibrant commercial presence within the town's Main St. district; and

Whereas, preserving existing Main St. commercial space is in keeping with the town's vision; and

Whereas, the town believes it is within its best interests to achieve a balance between commercial energy solar development and preservation of the town's open and agricultural spaces, existing woodlands and viewsheds; and

Whereas, the town believes use of native ground cover pollinator plants and vegetation within commercial ground mounted solar arrays would help reduce dependence on chemical weed killers and foster a healthy pollinator population; now therefore

**Be It Resolved**, that the Town Board does hereby adopt Local Law #4, a copy of which is annexed hereto, as a means of attaining its stated objectives.

# <u>Resolution No. 2018-116</u> "Agreement for the Expenditure of Highway Moneys – Section 284 of the Highway Law"

AGREEMENT between the Town Superintendent of Highways of the Town of Cairo, of Greene County, State of New York and the undersigned members of the Town Board for the year 2018.

Pursuant to the provisions of Section 284 of the Highway Law, we agree that moneys levied and collected in the Town for the repair and improvement of highways, and received from the State for State Aid for the repair and improvement of highways, shall be expended as follows:

- 1. **GENERAL REPAIRS**. The sum of \$356,127.00 shall be set aside to be expended for primary work and general repairs upon \$86.40 miles of town highways, including sluices, culverts, trees and bridges having a span of less than five feet and boardwalks or the renewals thereof.
- 2. **PERMANENT IMPROVEMENTS**. The following sums shall be set aside to be expended for the permanent improvement of Town highways:
