Whereas, the town board believes the littering of cigarette butts is both unsightly and unsanitary and terra-cycle bins are an appropriate method for reducing pollution caused by improper cigarette butt disposal, now therefore

Be It Resolved that the Cairo Town Board does hereby authorize the Cairo Durham High School students to obtain and place two terra-cycle bins for cigarette butt collection and recycling in the town park, with one being placed in the vicinity of the recycling center and Dog Park and the Town Hall.

Be It Resolved: that the Cairo Town Board, does hereby determine that the proposed action will not result in any significant negative environmental impacts and a negative declaration is appropriate.
