Town Board Meeting @ 7:00 pm

Location: Town Hall Meeting Room

The Town Board of the Town of Cairo met for a Town Board Meeting on Monday October 7th, 2019, at the Town Hall, Main Street, Cairo, New York.

Supervisor Benoit called the meeting to order @ 7:05 and asked the attendees to Pledge Allegiance to the Flag.

Attendance: Supervisor Benoit, Council Member Cords, Council Member Joyce, Council Member Watts Council Member Warner

Review and Approval of Minutes:

June 3rd, 2019: Offered by Council Member Watts and seconded by Council Member Joyce.

Supervisor Benoit – Aye, Council Member Cords – Aye, Council Member Joyce – Aye, Council Member Watts – Aye, Council Member Warner – Abstain. Motion Carried.

September 9th, 2019: Offered by Council Member Cords and seconded by Council Member Warner.

Existing Business:

- 1. Water Infrastructure Project In Progress
 - a. Water Tank currently being put together, should be finished in about 3 weeks. Down to 2 uninstalled meters left in the town. Water/Sewer Clerk to go for training on the new computer system for the meters.
- 2. Ambulance Building Update
 - a. Talk about tearing down the blue house on Railroad Ave. next to the Town Hall and replacing it with a modular for the new ambulance building. Possible cost would be \$250,000.00 compared to expected cost of \$500,000.00 to repair and bring the blue building up to code.
- 3. Property Taxes
 - a. Local Law #3 (Resolution #2019-124)

- 4. Renaming of Road
 - a. Thomas Drive in Cairo to possibly be renamed due to the confusion of Thomas Drive and Thomas Road that are connected to one another. Possible renaming it to Ridgeline Drive or name after a fallen hero of Cairo. Must see if the residents are okay with a change.
- 5. Sidewalk Project
 - a. The project will be rebid in November and if a bid is accepted the project will start early spring.

New Business:

- 1. Budget Discussion
 - a. Talked about the raises in the budget and why each department deserved what they got.
- 2. Set public hearing for budget November 4th
 - a. There will be a public hearing on November 4th @ 7:00PM before the monthly board meeting.
- 3. Harvest Festival October 12th
 - a. The Cairo Chamber of Commerce request for the Town Board to be present during the opening ceremony @ 10:00AM. The festival goes from 10:00AM-6:00PM.
- 4. Elections November 5th
 - a. Elections for Supervisor, Town Board Members, Town Clerk, Tax Collector, Town Justice and Highway Superintendent will be held on Tuesday November 5th.

<u>Resolution No. 2019-124</u> "Adopt Proposed Local Law #3 of 2019 entitled: Exemption of Capital Improvements to Residential Buildings"

Offered by Council Member Warner and seconded by Council Member Cords.

Be it enacted by the Town Board of the Town of Cairo:

Article I. Title, Purpose and Effective Date

- Section 1.01 <u>Title:</u> This local law shall be know and may be cited as "Exemption of Capital Improvements to Residential Buildings" of the Town of Cairo, County of Greene, and State of New York.
- Section 1.02 <u>Enacting Clause:</u> The Town Board of the Town of Cairo in the County of Greene, pursuant to NYS Real Property Tax Law, Article 4, Section 421-f, hereby ordains, enacts, and publishes this law.
- Section 1.03 <u>Effective Date:</u> This local law shall take effect upon its filing with the New York State Secretary of State.

Article II. Definitions

As used in this law, the following terms and words shall be defined as follows:

Commissioner: Shall mean the New York State Commissioner of Taxation and Finance.

<u>Exemption Base:</u> The increase in assessed value as determined in the initial year of the term of the exemption as limited by Section 3.

<u>Market Value</u>: Shall mean the increased assessed values attributable to residential building reconstruction, alteration or improvement divided by the most recently established state equalization rate, except where the state equalization rates equals or exceeds ninety-five percent, in which case the increase in assessed values attributable to such reconstruction, alteration or improvement shall be deemed to equal the market values of such reconstruction, alteration or improvement.

<u>Residential Building:</u> Shall mean any building or structure designed and occupied exclusively for residential purposes by not more than two families.

Article III. Exemption Provisions

Section 3.01 General Provision – Calculation of Exemption

- a. Any residential building that is reconstructed, altered or improved subsequent to the effective date of this law shall be exempt from taxation and special ad valorem levies to the extent provided hereinafter.
- b. Such buildings shall be exempt for a period of one year to the extent of one-hundred percent of the increase in assessed value thereof attributable to such reconstruction, alteration or improvement and for an additional period of seven years. The extent of such exemption shall be decreased by twelve and on-half per centum of the "exemption base" each year during such additional seven-year period subject to the following limitations:
 - In any year that the final assessment role certified by the Commissioner has a change of fifteen percent or more in the assessment level, the exemption base shall be multiplied by a fraction, the numerator of which shall be the total; assessed value of the parcel on such a final assessment roll (after accounting for any physical of quantity changes to the parcel since the immediately preceding assessment roll), and the denominator of which shall be the total assessed value of the parcel on the immediately preceding final assessment roll. The result shall be the new exemption base.
 - II. The assessor shall thereafter re-compute the exemption taking into account the exemption base, notwithstanding the fact that the assessor receives the certification of the assessment level change after the completion, verification and filing of the final assessment roll.
 - III. In the event the assessor does not have custody of the roll when such certification is received, the assessor shall certify the recomputed exemption to the local officers having custody and control of the roll, and such local officers are hereby directed and authorized to enter onto the roll the re-computer exemption certified by the assessor.
 - IV. The assessor shall give written notice of the re-computed exemption to the property owner, who may, if he or she believes that the exemption was re-computed improperly, apply for a correction in the manner provided in Article 5, Title 3, of the New York State Real Property Tax Law for the correction of clerical errors.
- Section 3.02 <u>Exemption Limit:</u> The exemption granted in Section 3.01 shall be limited to eighty-thousand dollars in increased market value attributable to such reconstruction, alteration or improvement, and any increase in market value greater than eighty-thousand dollars is not eligible for the exemption provided for herein.

Section 3.03 Exemption Requirements:

- a. No exemption shall be granted herein unless:
 - I. The reconstruction, alteration or improvement was commenced after he effective date of this local law; and
 - II. The value of such reconstruction, alteration or improvement exceeds three-thousand dollars; and
 - III. The greater portion of the building reconstructed, altered or improved as determined by square footage, is at least five years old.
- Section 3.04 Non-Qualifying Activities: For purposes of this Article, the terms reconstruction, alteration and improvement shall not include ordinary maintenance and repair.

Article IV. Administrative Procedures

Section 4.01 Application for Exemption

- a. The exemption provided for by this local law may only be granted to the owner of a residential building who files an application for such exemption on a form prescribed by the Commissioner.
- b. The application shall be filed with the town assessor on or before the town's taxable status date.

Section 4.02 <u>Action by Assessor</u>

- a. If the assessor is satisfied that the applicant is entitled to an exemption, he or she shall approve the application and such building shall thereafter be exempt from taxation and special ad valorem levies as herein provided for commencing with the assessment roll prepared on the basis of the taxable status date referred to above in Section 4.01(b).
- b. The assessor shall enter the assessed value of any exemption granted pursuant to this section on the assessment roll with the taxable property, with the amount of the exemption shown in a separate column.

Article V. Loss of Exemption

- Section 5.01 Reasons for loss of Exemption: in the event that a building granted an exemption pursuant to this section ceases to be used primarily for residential purposes or title thereto is transferred to other than the heirs or distributes of the owner, the exemption granted pursuant to this local law shall cease.
- Section 5.02 <u>No Loss on Repeal:</u> No local law shall reduce or repeal an exemption granted hereunder until the expiration of the period for which such exemption was granted.

Article VI. Severability

Section 6.01 In the event any section or provision of the law contained herein or as amended hereafter shall be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of the law as a while or any part thereof other that the part so declared to be invalid.
