Whereas, the animal control shelter is utilizing 560 sq. ft. of the garage; and

Whereas, the Cairo Town Board deemed that a fee of \$4.00 per sq. ft. which includes a stipend for electric, heat and water would be sufficient for rent; and

Whereas, the Sewer District has an inter-fund loan from the General Fund, therefore be it

Resolved, that in lieu of cash rent to the Sewer District from the General Fund, the monthly sum of \$186.67 will be written off the inter-fund loan due to the General Fund for an annual amount of \$2,240.04 for fiscal year 2019.

- **Tim Powers requested an update on the Grant for updating the Town Park. They town will know the responses at the end of the year.
- **Deborah from the Library talked about the census and how to get more people involved to report the correct amount of people in the Town of Cairo,
- **Jim Freeman questioned why the bathrooms down at the park were locked during the winter. This is due to the fact that is costs a lot of money to heat the bathrooms thought out the winter. Talking about the possibilities of putting porta lets down at the park during this time frame.
- **Ed from the Town Planning Board address the ice and water on a different spot on Jerome Ave, which looks like it could be more serious than it is. Possibility of water main leak.
- **Marc vanSchendel requested a credit towards his Water, EDU and Sewer bills that were brought up at last month's meeting. During snow removal on Main Street his fence was hitting and broken, requesting who caused this and who to address, whether it be the town or the county. Raising the question of another stop/caution light up on Mountain Ave in Purling/Round Top.
- **Addressed the idea of homeowners being in charge of the snow on the sidewalk in front of their properties.
