# Resolution No. 2019-156 "Support Kedemah Lodge and American Legion Sign Request"

Offered by Supervisor Benoit and seconded by Council Member Cords.

Whereas, The Brothers of the Kedemah Lodge #693 F & AM and the members of American Legion Post 983 (hereinafter, "the applicants') have jointly requested planning board approval for a new, electronic, free-standing message board sign on property located at 523 Main Street Cairo because their 40 year old message board sign at that location has become unserviceable, and

Whereas, the planning board referred the applicants to the town board for its approval of the proposal, and

Whereas, there is no moratorium involving the review or approval of electronic message-board signs and, pursuant to the Town of Cairo Zoning Law, the planning board of jurisdiction to review and make decisions on all proposed signage within the Town of Cairo, including the ability to exempt applicants from restrictions imposed therein, now therefore

**Be It Resolved,** that the Town Board does hereby state its support for the applicants' proposal and does refer the applicants to the planning board for its review and determination of the applicants' proposal for an electronic message board sign to replace its existing, unserviceable sign.
