End of the Year Meeting (Zoom)

Monday, December 30th, 2020 @ 7:00PM

Location: Town Hall Court Room

The Town Board of the Town of Cairo met for a Town Board Meeting on Monday, December 30th, 2020, at the Town Hall, Main Street, Cairo, New York. Supervisor Coyne called the meeting to order at 7:03PM.

Attendance: Supervisor Coyne, Council Member Cords, Council Member Kralovich, Council Member Powers was present but late, Council Member Watts was present but late.

Review and Approval of Minutes:

December 7th, 2020: Will be voted on January 4th, 2021 Re-Organizational Meeting.

<u>Resolution No. 2020-199</u> "Adopts Provisions of Executive Oder Suspending the Requirements of Renewal Applications as a Condition to Granting Exemptions under Sections 459-C Partial Tax Exemptions for Real Property of Persons with Disabilities and Limited Income and 467 Partial Tax Exemptions for Real Property of Senior Citizens"

WHEREAS, the Town Board of the Town of Cairo, in recognition of the Governor's Executive Order dated December 18, 2020, subdivisions 7, 7-a and 8 of section 459-c of the Real Property Tax Law, and subdivisions 5, 5-a 5-b, 5-c and 6 of section 467 of the Real Property Tax Law to adopt a resolution directing the assessor to grant exemptions pursuant to such section on the 2021 assessment roll to all property owners who received that exemption on the 2020 assessment roll, thereby, dispensing with the need for renewal applications from such persons, and further dispensing with the requirement for the assessor to mail renewal applications to such persons, and include in such resolution that the assessor may require a renewal application to be filed when he or she has reason to believe that an owner who qualified for the exemption on the 2020 assessment roll may have since changed his or her primary residence, had a significant income change, added another owner to deed, transferred the property to a new owner, or died.

Council Member Cords – Addressed the goals for the next year and would like to start addressing the ambulance building again and to discuss what is next. Supervisor Coyne mentioned that we will come back around to the ambulance building come the New Year.

Council Member Kralovich – Addressed the new cabinets that need to be approved for the senior center. The Board will approve them in the year as they have been approved in the 2021 budget.

Council Member Powers – Addressed obtaining appraisers for the Fossil Forest to Council Member Watts, no luck so far. Council Member Cords says she is looking into it as well. Mr. Powers is also looking into getting a UTV for building and ground to have better transportation in the park on top of assisting with plowing the walking path in the park. He currently has 3 quotes for a UTV and the best is currently with Greenville Power.
