Old Business:

- 1. Barton & Loguidice Bob Murphy (Grant Writer) and Jeremy Hughes
 - a. Senior Park Update
 - i. Looking into a fitness trail for seniors with low impact exercise stations. Spaced out evenly throughout the trail, the trail would be paved with a track surfacing. The Lee Physical Therapy could possibly take advantage of this as well if needed. Just a preliminary plan, the board can decide what items will be beneficial to the project and the residents. Recommend order the equipment first and then break ground to match the delivery just so the Town is not waiting on anything. Funding for this would be earliest maybe late fall and then spring the Town can break ground and complete the fall after that. There is an ideas to make the senior center share with the nutrition center, possibility to make it a joint project with Greene County Dept. of Aging.

b. Children Playground

i. Compatible inclusion playground equipment for children with special needs within the playground that is there now. Make sure that the special needs equipment is not separated from the rest of the playground equipment. The Town has a packet from the company on what they would like to plan to do and they also help plan a grant program to fund the playground project. Proposed budget and an add-on's portions of the budget was also given to the board so they can customize what they would like. The budgets are close to about 300,000 and the grant program would pay for up to 50% of project cost and other programs to fill the gap that is left over. Timeline depends on when the grant program is available, hopefully this summer and the award would be next fall/winter.

- ii. The American Legion has the Hoover Grant leftover and would like to use it on a future project. They would like to give the money to the Town for this type of project. The Legion has had the grant for a long period of time and have now decided that this is the project that they would like to pursue.
- c. Polly's Rock Bridge
 - i. This bridge is in need of replacement according to the Highway Superintendent. The State has put out funding called the Bridge of NY Program, this helps with replacement and repairs for bridges own by different jurisdictions of the state. The deadline for the application is May 15th, the Town needs to put out and RFQ to solicit companies to get grant assistance for the bridge and can decide on which company we would like help from. The program would pay for design cost along with construction costs, Bridge of NY will pay for 95% of the cost for the bridge. If the bridge is a certain size the County can take the bridge over and take care of it instead of the Town, the Town will look into it and see if the County can take it over. The highway dept. will have to be a part of this conversation when the time comes so they can determine how much weight will need to go across that bridge, as in plows and salters.

<u>Resolution No. 2021-080</u> "Authorize Issuance of a Request for Qualifications (RFQ) for the Polly's Rock Bridge"

WHEREAS, the NYS Department of Transportation (DOT) has issued a Notice of Funding Availability under the BRIDGE NY program and is soliciting applications from local governments to rehabilitate and replace bridges and culverts; and

WHEREAS, recent inspections of the Town-owned Polly's Rock Bridge have identified deterioration of the timber deck and steel I-beams; and

WHEREAS, the Town wishes to retain an engineering firm to assist in completing a preliminary assessment and preparing a BRIDGE NY funding application for the Polly's Rock Bridge.

NOW THEREFORE BE IT RESOLVED, that the Town Board authorizes the issuance of a Request for Qualifications (RFQ) for completing a preliminary assessment and preparing a BRIDGE NY funding application for the Polly's Rock Bridge. The RFQ shall be sent to all firms listed on the 2019-2022 New York State County Highway Superintendents Association (NYSCHSA) Local Design Service Agreement (LDSA) list as attached to this resolution.

Resolution No. 2021-081 "Agreement for the Expenditure of Highway Moneys Section 284 of the Highway Law."

Offered by Supervisor Coyne and seconded by Council Member Powers.

AGREEMENT between the Town Superintendent of Highways of the Town of Cairo, of Greene County, State of New York and the undersigned members of the Town Board for the year 2021.

Pursuant to the provisions of Section 284 of the Highway Law, we agree that moneys levied and collected in the Town for the repair and improvement of highways, and received from the State for State Aid for the repair and improvement of highways, shall be expended as follows:

- 1. **GENERAL REPAIRS.** The sum of \$ 423,000.00 shall be set aside to be expended for primary work and general repairs upon 86.40 miles of town highways, including sluices, culverts, trees and bridges having a span of less than five feet and boardwalks or the renewals thereof.
- 2. **PERMANENT IMPROVEMENTS.** The following sums shall be set aside to be expended for the permanent improvement of Town highways:
- a) On the road commencing at Caniff Road and leading to County Route 67, highway known as Plattekill Road, a distance of 1.90 miles, there shall be expended not over the sum of \$148,000.00. Type Motor Paving Width of traveled surface 20' wide Thickness 2" – 3" b) On the road commencing at Caniff Road and leading to County Route 67, highway known as **Doman** Road, a distance of 2.04 miles, there shall be expended not over the sum of \$142,000.00 Type Motor Paving Width of traveled surface 20' wide Thickness 2" - 3"
