 - a. Paul Napoli and Walter Huang from Napoli Shkolnik PLLC spoke about the water issues with in the town/want to focus on municipal water area first and then the overall town water.
 - b. They have represented multiple individuals including some from 9/11.
 - c. The real responsibility for the PFOS and PFAS falls on Dupont and 3M
 - d. Testing on Fire Training center and air strips/1 part per trillion is 1 sec per 32,000 years.
 - e. They discussed that the town should not have to pay for this, but the companies that created the products/Items that needed fire foam with these chemicals were gas fires
 - f. Carbon filters will work and trap the PFOS and PFAS but not on Dioxides.

The water adjustment will be in the amount of \$616.88 and the sewer adjustment is in the amount of \$955.44.
