Town Board Workshop Session

Wednesday June 17th, 2020 (Closed to the Public)

The Town Board of the Town of Cairo met for a workshop meeting on Wednesday June 17th, 2020 at the Town Hall, Main Street, Cairo, New York.

Supervisor Coyne called the meeting to order at 7:03 PM and then asked the attendees to Pledge Allegiance to the Flag.

Items to Discuss:

-

- Solomon Energy
 - Recently they have looking over some sites; landfills, etc. and they will continue with their search for sites to continue their progress of this project due to the constant changing policies. If the project is approved the turnaround time will be about 2-3 weeks to get up and running.
- Next Amp Energy
 - This company is looking at 2 spots here in town for this project.
 - The goal of this project is for the town and residents are saving money and also to meet the energy goal for the state.
 - While you will have to opt into this program you are not guaranteed at first and may be on a wait list.
 - For every person who signs up there will be a \$75 dollar donation from the company to go to whomever the town choses
- Security Camera Presentation HIPPOS

- The Town was given 2 proposals for cameras for the Public buildings like the town hall police station, library and the down in the park. These cameras will have enough storage for 24hrs a day for 30 days with 3 terabyte storage.

Commercial Alterations and Repairs (as follows)

Alteration Level: Minor structural repairs, replacement of windows and doors with no reconfiguration of space of extension of existing systems. \$150 (was \$100)

Alteration Level II and Level III: Reconfiguration of space, addition or elimination of any door or window, reconfiguration of any space, or the installation of any additional equipment. \$150 (was \$100) plus \$.50 per sq ft.

Resolution No. 2020-100 "Authorization to Appropriate Sidewalk Project Funds"

Offered by Supervisor Coyne and seconded by Council Member Kralovich.

WHEREAS, a Project, TAP/CMAQ, Multi Use Pathway & Sidewalk project, Towns of Cairo and Greenville, Greene County P.I.N. 1760.85 (the "Project") is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs such program to be borne at the ration of 80% Federal Funds,

WHEREAS, the Town of Cairo desires to advance the Project by making a commitment of 100% of the non-federal share of the costs of Design and Construction, C/I, Therefore, the Town Board duly convened does hereby,

RESOLVE, that the Town Board hereby approves the above-subject project; and it is hereby further,

RESOLVED, that the Town Board hereby authorizes the Town of Cairo to pay in the first instance 100% of the federal and non-federal share of the cost of Design and Construction, C/I, work for the Project or portions thereof; and it is further,

RESOLVED, that the sum of \$77,000.00 has hereby been appropriated from General Fund and made available to cover the cost of participation in the Design phase of the Project; and it is further

RESOLVED, that the sum of \$1,353,960.00 is hereby appropriated from Federal Tap Grant DOT PIN 1760.85 and made available to cover the cost of participation in the Design and Construction, C/I phases of the Project; and it is further,

RESOLVED, that in the event the full federal and non-federal share costs of the project exceeds the amount appropriated above, the Cairo Town Board shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the New York State Department of Transportation thereof, and it is further,

RESOLVED, that the Town Board of the Town of Cairo be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or Marchiselli Aid on behalf of the Town of Cairo with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of project costs and permanent funding of the local share of federal-aid and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible, and it is further

RESOLVED, that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project and it is further,

RESOLVED, this Resolution shall take effect immediately.

Resolution No. 2020-101 "Move Highway Employee from Part Time to Full Time"

WHEREAS, Martin South passed his CDL, and there is an operational need for an additional full time employee as well as an opening, and,

WHEREAS, Martin South is currently employed by the Town of Cairo Highway Department as a part time employee at a rate of pay of 16.97. Therefore;

BE IT RESOLVED, that the Town Board of the Town of Cairo authorizes the change in employment status for Martin South from part time to full time at a rate of \$17.15 per hour effective June 18, 2020.

BE IT RESOLVED, that the Cairo Town Board does hereby approve the addition of 4 vendors at the Cairo 4th of July Fireworks Celebration. The understanding of this agreement is that the Chamber of Commerce is responsible for monitoring social distancing around the vendors.

Resolution No. 2020-103 "Town Highway Department to do Sidewalk Work"

WHEREAS, The Town of Cairo Highway Department has the manpower and the required skills to work on a portion of the Sidewalk Project for the Town of Cairo. Therefore;

BE IT RESOLVED, that the Cairo Town Board does hereby approve the Town of Cairo Highway Department to complete the portion of the sidewalk project from the beginning of Dinger at Rt. 32 to the end where it meets to paved road. The project consists of a 10' stone path and a grass area on each side to allow for recreational activities. The cost for this project is not to exceed \$20,000.
