AMENDING LOCAL LAW #2 OF 1991 REGULATION OF DWELLING UNITS

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF CAIRO AS FOLLOWS:

Local Law #2 of 1991 of the Town of Cairo shall be and hereby is amended as follows:

Section 6, Paragraph 6A(2) shall hereafter read, "No lot shall be smaller than 1.25 acres in size, with a minimum of 150 (one hundred and fifty) feet of frontage on a highway or private roadway."

This Local Law is expressly adopted pursuant to the relevant sections of the New York State Town Law and the New York State Municipal Home Rule Law.

In the event any section or provision of the laws contained herein or as amended hereafter shall be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of the laws as a whole or any part thereof other than the part so declared to be invalid.

This local law shall be effective immediately upon filing with the Secretary of State.

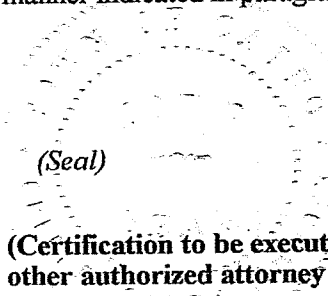
