## REGULATING PARKING OF VEHICLES AND/OR MACHINERY

**Section 1.** Be it hereby enacted by the Town Board, Town of Cairo, County of Greene, State of New York, pursuant to provisions of the Vehicle and Traffic Laws of the State of New York, the following Local Law to regulate parking of vehicles and machinery on all highways within the Town of Cairo, from November 15<sup>th</sup> to April 15<sup>th</sup>, called the "Winter Season," for removal of snow and ice from such highways.

**Section 2.** The Highway Superintendent is hereby authorized to declare a snow emergency during any snowstorm within the Town. Announcement of such declaration shall be published in the official newspaper of record for the Town and/or upon the town bulletin board. Upon such declaration, parking shall be permitted only upon any road within the Town on even days, on the even side of the street and on odd days, on the odd side of the street until such declaration is terminated.

**Section 3.** The Town Highway Superintendent is hereby authorized and directed to remove, at his discretion, any vehicles parked on highways within the Town of Cairo in violation of this Local Law and to make arrangements for the towing and storage of such vehicles as he may, in his discretion, determine, with the charges and expenses being borne solely by the owner or owners of such vehicles.

**Section 4.** The owner of a vehicle so parked or abandoned on the highways within the Town of Cairo during the time periods, including during a snow emergency, as set forth in this Local Law will be in violation of the Local Law and the owner of said vehicle will be subject to a fine of not more than \$50.00 for the first offense, not more than \$75.00 for the second offense within an 18-month period, and not more than \$100.00 for a third offense within an 18-month period.

This Local Law shall take effect immediately upon compliance with the Statutes of the State of New York.
