The Town Board of the Town of Cairo met for a Town Board Meeting on Monday, January 9<sup>th</sup>, 2023, at the Town Hall, Main Street, Cairo, New York. Supervisor Watts called the meeting to order @ 7:00pm and asked the attendees to Pledge Allegiance to the Flag.

Attendance: Supervisor Watts, Council Member Bogins, Council Member Cords Council Member Flaherty, Council Member Powers.

- Supervisor Watts apologized to the public for the mistake that was made on the budget. The mistake was discovered for the 2023 tax levy increase turned out to 7.5% instead of .51% that had been approved. The correct tax levy for 2022 should have been 4.5%.
- An emergency meeting tried to override the mistake. Unfortunately the override could not be done per Attorney Rappleyea. The taxes will have to remain the half percent. The extra money that is collected will have to go into other special account and not used till next year.

- Supervisor Watts introduced Nicole, an accountant who works with a local attorney in Greene County. Nicole has a background in forensic accounting. Nicole was asked to examine the books by Supervisor Watts. Nicole explained that the spreadsheets show that the numbers have been put on the spreadsheets a number of times. Nicole discovered that the budget sheets from the last two years did not have any matches.
- The town residents agreed that the town needs someone to come in to do an audit. Council Member Powers said that if Nicole would be willing to do the audit, he would like to see her credentials and who referred her.
- Council Member Powers abstained from voting on the earlier organizational meeting agenda, because he does not want to any more money spent until the budget is signed off by the NYS Comptroller's Office.
- Supervisor Watts said he has no intention of firing the bookkeeper since she was only here for just a few months and has not had all the required and up to date training.
