The Town Board of the Town of Cairo met for a Town Board Meeting on Wednesday, June 21, 2023, at the Town Hall, Main Street, Cairo, New York. Supervisor Watts called the meeting to order @ 7:00PM and asked the attendees to Pledge Allegiance to the Flag.

APPROVAL OF MINUTES:

New Business:

- 1. The burned Commercial Bldg. Stacy Sprague was here from Code Enforcement stating that an engineer talked to her about the burnt out building on the corner of Main St. and Bross is not in sound shape and must come down. The owner of the property does not want take it down. The board will have to make a resolution that the building will have to come down. Supervisor Watts has be in touch Shaun Groden County Administrator and Harry Lennon with the Legislator to see what possibilities there are.
- 2. New York Citizen Audit Group came to talk to the Town Board. They learn more about our findings and want the town to become a volunteer, or make a donation to support their legal efforts and hold officials accountable. They have found more votes cast than voters and other problems. The Town Board would like more information. They will come to the next meeting.
- 3. Advertise for Bids for Cleaning Companies for 2024: There have been rooms that have not been cleaned and have not been rooms that have not been put the contract. Will advertise for cleaning companies for the 2024 year.
- 4. Don Gibson called the town for water out of the hydrant by the soccer field that they are fixing. Supervisor Watts is getting in touch with the water department so see it there will be enough water.

Old Business:

- 1. 2023 CFA re-Submission for Senior Exercise Area/Playground Project at the Town Park; Barton & Loguidice. Resubmitting at \$2000.00. The grant would be \$290,000.00 and with the Town being \$290,000.00 as well. The Town has no funds at this. The Board hold town all but on hold.
- 2. There were two companies that provided quotes on three types of signs, the third company-had a negative reply received.

Resolution No. 2023-131 "Approve the Sale of the Easement/Right-of-Way on Lake Mills Road"

WHEREAS, Accredited Appraisal Services has Determined that the value of the lands encumbered by the easement to be \$2,800.00; therefore,

BE IT RESOLVED, that the Town Board has previously determined that the granting of a right-of-way will not impede or prevent in any way, the use of the subject property by the Town for its intended uses and has no value to the Town for its intended uses and has no value to the Town: Furthermore,

BE IT RESOLVED, that the Town Board does hereby approve the sale of the easement/right-of-way on Lake Mills Road for the appraised value of \$2,800.00.

BE IT RESOLVED, that Cairo Town Board does hereby approve the switching of full to part time Laborer/Mechanic of Time Spring and to continue to pay him at an hourly rate of\$22.61 effective July 6, 2023.

BE IT RESOLVED, that the town board does hereby approve to use up to \$10,000.00 in ARPA funds for the purchase of Topsoil and Landscaping items for the Town Park.

BE IT ALSO RESOLVED, that the town board does hereby approve to purchase a new sigh from **Matthew Signs or Saxton Sign Corp** (circle the company chosen) not to exceed the amount of \$ 18,756.90 .

<u>Resolution No. 2023-140</u> "Authorize Supervisor to Sign the Contract with Intelligent Technology Solutions, Inc." Offered by Council Member Flaherty and seconded by Council Member Cords.

WHEREAS, the current license has expired with Intelligent Technology Solutions, Inc. (ITS); and WHEREAS, the Town of Cairo plans to migrate to a VOIP system in 2024 which will require to upgrade and replace the current router; and

WHEREAS, ITS has provided two quotes to choose from, **Option 1: \$1,150.00** is renewing the router under the old model for one year subscription, which will not support VOIP that is scheduled for 2024; **Option 2: \$7,220.00** is to replace the router with a 5 year subscription which will accommodate the future migration to VOIP. Therefore;

BE IT RESOLVED, that the Town Board does hereby authorize the Supervisor to sign the contract with ITS for Option **2** in the amount of **\$ 7,220.00**.

Resolution No. 2023-141 "Authorize Salary Increase for Justice Clerk"

WHEREAS, there is a need to hire and retain qualified court clerk positions with unique skills, mandatory background checks, retention of information and confidentiality.

WHEREAS, the salary/hourly rate currently being offered for Justice Clerks is insufficient to retain and/or hire interested candidates when vacancies are available.

BE IT RESOLVED, that the town Board does hereby approve the hourly pay rate from\$19.17 to \$22.25 per hour not to exceed 40 hours per week (annual salary from \$39,870 to \$46,800) for Kathleen Costanzo effective June 28, 2023.
