Resolution No. 2023-142 "Approve Full Time to Part Time Laborer-Pellccia"

WHEREAS, a Map Plan and Report by an Engineer licensed in the State of New York describing the boundaries of the proposed Sewer District Extension, a general plan of improvement and description of facilities, the maximum amount to be expended, regulatory review requirements, the cost of hook-up fees if any, the cost to the typical property, and method of financing the project, and a statement of benefit assessment was prepared; and

WHEREAS, the Town Board accepted the Map Plan and Report prepared by Delaware Engineering, DPC and dated May 17, 2024 as having been prepared in conformance with Section 192 of Town Law Article 12; and

WHEREAS, a copy of the Map Plan and Report was made available for public inspection at the office of the Town Clerk in Cairo Town Hall, Main Street, Cairo, New York during regular Town Hall business hours upon acceptance by the Town Board and also on the Town's website; and

WHEREAS, a Public Hearing on the proposal to establish Sewer District Extension was conducted on, June 5, 2023 at 7:00 PM at Cairo Town Hall, Main Street, Cairo, New York with all persons desiring to be heard on the subject of the proposed Sewer District Extension having been heard upon due posting and publication as required by Article 12 of the Town Law; and

WHEREAS, the Town Board has given due deliberation to the hearing and the testimony and allegations presented concerning the same; and

WHEREAS, a Negative Declaration under SEQR was issued on June 15, 2023 for this action; **NOW THEREFORE**, **BE IT RESOLVED**,

- 1. The Town of Cairo finds:
- a. The notice of public hearing was published and posted as required by law, and is otherwise sufficient;

- b. The petition is signed and is sufficient as required by law;
- c. All the property and owners within the proposed district extension are benefited thereby;
- d. All property and property owners benefited are included within the limits of the proposed extension; and
 - e. The Sewer District Extension is in the public interest.
- 2. The Town of Cairo approves the Sewer District Extension as described in Attachment A.
- 3. The Town Clerk shall file a certificate stating such fact in the office of the Greene County Clerk and Office of the Department of Audit and Control in Albany, New York
 - 4. This resolution shall take effect immediately.

<u>Resolution No. 2023-151"</u> Authorize Salary Increase for Code Enforcement Officer" **TABLED**

WHEREAS, there is a need to retain qualified Code Enforcement Officer/ Department Supervisor position with Experience, commitment, education, strong public relation skills, origination, efficiency, flexibility (on call 24 hours a day), Uniform Building and Fire Prevention Codes, Executive Laws, Zoning and Planning Laws, Town Regulations and Laws, State Laws, Public Safety, Knowledge of legal procedures and how to create legal documents as well as official documents, creating reports, creating budgets, leadership, Office procedures and the responsibility and knowledge of all other staff within the Department and those duties.

WHEREAS, the salary/hourly rate currently being offered for the Code Enforcement position is insufficient for the amount of experience, availability, length of employment (17 years), responsibilities and the job duties compared to other salaries of existing and newly appointed staff.

BE IT RESOLVED, that the Town Board does hereby approve the hourly pay rate from \$25.91 to \$30.72 per hour not to exceed 40 hours per week (annual salary from \$53,893 to \$63,893) for Stacy Sprague effective July 3, 2023.

WHEREAS, there is a need to retain qualified building inspector with a knowledge and experience (17 years) of The Uniform Building and Fire Code, field inspections, plan review and strong public relations.

BE IT RESOLVED, that the Town Board does hereby approve the hourly pay rate from \$16.26 to \$19.60 per hour not to exceed 40 hours per week (annual salary from \$33,824 to \$40,750) for Kyrie Fielder effective July 2023.
