Resolution No. 2023-198 "Appoint and Set Salary of Dog Control Officer for the Town of Cairo"

WHEREAS, the Rip Van Winkle Soccer Club is requesting a renewal of that lease for a period of 10 years to continue providing a place for many of the communities children to learn and to play soccer commencing on January 1st, 2024; Therefore,

BE IT RESOLVED, the Town Board does hereby approve the lease with the Rip Van Winkle Soccer Club for use of the Mountain Ave. Soccer Field for a period of 10 years commencing on January 1st, 2024.
