Workshop Meeting

Wednesday November 15th, 2023

Location: Town Hall Meeting Room (Court Room)

The Town Board of the Town of Cairo met for a Town Board Meeting on Wednesday, November 15th, 2023, at the Town Hall, Main Street, Cairo, New York. Supervisor Watts called the meeting to order at 7:00PM and asked the attendees to Pledge Allegiance to the Flag.

Old Business:

Public Hearing – Zoning Law Amendments

Open Public Hearing @ 7:01

Offered by Supervisor Watts and seconded by Council Member Cords

- The board created a new Commercial/Industrial District on the opposite side of 23 across from McDonalds, which is classified as Commercial/Industrial 2 and all others are Commercial/Industrial 1. Left all usages the same except there is to be no residential zone. If water and sewer is eventually able to hold households in the future then the law can be amended once again.

Public Comments:

 Only change to the budget from the public hearing on Nov. 6th, 2023 was the accountant line item that went from \$12,000 to \$24,000 in hoping to find an accountant for the Town of Cairo.

The local accountant in Town stated that they would look over anything they need but is not interested in being the Town accountant.

The board also stated that they discussed the entire budget with the county to make sure that there were no mistakes or issues.

 Mark Gorelick stated that the Cairo Public Library has a new Director as of December 11th, 2023, her name is Corrine Tatovito and is coming from the Tivoli Library with a lot of experience.

BE IT RESOLVED that the Town Board of Cairo does hereby approve to buyout the current copier for \$642.00.

The charges were for property tax ID 101.05-1-11 for an abandoned, unsafe building for the removal of all junk and debris and maintenance of exterior property areas according to the Violation Order of the Town of Cairo Local Law #1 (2020 Unsafe Buildings) Local Law #4 (2020 Garbage, Rubbish and Refuse); therefore,

BE IT RESOLVED, that the Town Board of Cairo does hereby accept the Miscellaneous Charges as presented from the Building and Code Department in the amount of \$1,785.20 dated Nov. 10th, 2023.

WHEREAS, that on July 19th, 2023 at 7:00 pm, at the Cairo Town Hall, the Town Board held a Public Hearing and has kept it open to enact changes based on the public comments. Therefore;

BE IT RESOLVED, the Town Board of the Town of Cairo approves to adopt Local Law #3 of 2023 to amend the Town of Cairo Zoning Law and directs the Town Clerk to file the necessary paperwork with the Secretary of State.

BE IT RESOLVED, the Town Board does hereby authorize the Cairo Development Foundation to assess, renovate and fund the suggested repairs to the World War I Memorial Fountain.
