Town Board Meeting @ 7:00PM

Location: Town Hall Meeting Room

The Town Board of the Town of Cairo met for a Town Board Meeting on Monday, September 11th, 2023, at the Town Hall, Main Street, Cairo, New York. Council Member Cords called the meeting to order @ 7:00PM and asked the attendees to Pledge Allegiance to the Flag.

Attendance: Supervisor Watts, Council Member Bogins, Council Member Cords, Council Member Flaherty, Council Member Powers.

Minutes:

August 16th, 2023:

Offered by Council Member Bogins and seconded by Council Member Flaherty.

New Business:

- Public Hearing – Override Tax Levy Limit

Open Public Hearing:

Offered by Supervisor Watts and seconded by Council Member Cords.

Supervisor Watts – Aye, Council Member Bogins – Aye, Council Member Cords – Aye, Council Member Flaherty – Aye, Council Member Powers – Aye. Motion Carried.

- Each year there is a meeting for approving going over the tax gap just in case the Board needs to go over the budget for some reason; this was done last year, not the year before. Every town does this public hearing/meeting.

Last year's budget was over approx. \$176,000, which then had to be doubled due to the fee/fine from the comptroller's office for going over the budget, this is to give the tax payers a break for the following year, the Board put that money in an interest bearing account with the Bank of Greene County; all in accordance with the comptroller's office.

According to Supervisor Watts the Town had 3 audits done this year. The town has also gone through 3 different bookkeepers this past year as well.

Currently discussing raises, there are open positions within the Town but they are not getting applicants, or long term people due to non-livable wages or just not enough in general. Goes on to discuss the issues with the roof and how the Town is slowing patching it due to the money that was put away since it was partially for the roof repair.

- Code enforcement needs an updated truck due to some mechanical issues; hard time finding another vehicle within a decent price range.
- Supervisor Watts states that he believes that the taxes will not be going up next year. The current budget that the Town is working with is about 4.2 million dollars to run the Town.
- Council Member Cords addresses how the Daily Mail put in there article that both her and Council Member Flaherty had no comment on the money, they state that the Daily Mail actually never called them or had any messages from them to even ask for a comment, they also had budget wrong numbers. A couple of people in the audience then address the board about how they should reach out to the Daily Mail to correct the article that was put out; a possible retraction.
- The board continues onto the budget and how there are some departments that they are still waiting on. A gentleman states that the board should just give the departments that don't return their budgets in on time get the same budget as last year.
- Another gentleman in the public gives the board an actual timeline of how the board is supposed to go about the budget process each year. According to this alleged article they have to have at least a tentative budget available for 7 days before having this public hearing. The board neither agrees nor denies, but is willing to have another public hearing.
- JR VanDenburgh addresses the zoning law change issues; the board states that the public hearing on that is not complete yet and will be brought up again. The zoning plans have not gone through the planning board yet. The board does not agree with most of the proposed changes that the county brought up in the proposed zoning law change. The only change that was supposed to happen was with the property across the street from McDonalds stating that there were to be no residential zoning because the water/sewer could not support it.
- A resident state he heard something about that the taxes were going to double or triple; board addresses this and states that is not true and simple a rumor.
- A women from the audience addresses the internal process/plan that the board may have. Are the tax letters and budget going to be checked over by all parties of the board and bookkeeper? Are the checks and balances in line, etc.? If the Town does submit the budget after being looked at and there is a mistake the County does not allow for a correction.
- Council Member Bogins goes on to state that the Town had recently applied for the NY Forward Grant.
- The board is planning on having another meeting after the tentative budget comes out.
- The board addresses why they need to have this meeting and vote on going over the tax gap if needed; simply because the future cannot be predicted and if there is an emergency throughout the year that they cannot control; building issues, water and sewer, etc.
- Council Member Cords addresses that the taxes last year did not go up 7.5%, if you look @ the tax base and rate it was actually 4.5%. Supervisor Watts states that the average tax payer had to pay \$35 dollars more on their tax bills.
- Council Member Powers mentions that maybe the Town should invest in an accountant to go over the budget one last time before it gets submitted to the County, even if it was \$500.
- All dept. budget meetings and dept. request to the board are open to the public.
- A women asked if the Town could ever do fundraising for large items or updates that maybe required in the Town; the computer system for example. Supervisor Watts says that a great idea, they would need many volunteers if available.
- The reason the Town had a large amount of the money from last year that was able to be put in a reserve fund was because the Town had budgeted for a new roof and some to address the community center, which was not done this year.

- In the past there have been bonds that were to be put in the budget and there were not which have caused domino effects and other issues.
- The board is basically starting at zero with the budget to address the issues that have already occurred. Also any leftover budget from each dept. rolls over to the next budget. After tomorrow the board will inform each dept. about spending on items that are not necessary until the budgets is addressed for next year.
- A gentleman asks about the plan that have been made and addressed by engineers, what is going on with these and how much has that already cost the Town, Board address that they are waiting on them to move forward. Also trying to figure out this whole well issue with Delaware Engineering, where they signed off on the well when it was not working correctly.
- Senior residents appreciate the fact that the Board does not want to raise the taxes.

- Cairo Public Library – Mark Gorelic
 - The library had recently hired a new director with a 4 month probationary period. Unfortunately the person selected, though was very personable and friendly, was let go after the period for not being the best fit. The library board will be putting out the position once again with different guidelines that will allow more people to be qualified.

Public Comment:

- Women from the public speaks about how she believes that no one really wants to raise taxes. But we as a Town we do wants the roads plowed and our Police Officers patrolling, etc. Unfortunately the

Town does not have a lot of applicants for jobs when they are available, due to the salaries; so if the Town wants to continue to employ themselves they would have to raise salaries, which would raise taxes in the end, unless other things are cut.

Starting pay rate will be \$16.20 per hour based on the union contract and board resolutions for 2023.
