#### Public Comment:

 Joseph Hasenkopf speaks on the upcoming planning board meeting and the project that is being pursued in Round Top. The next planning board public hearing on March 7<sup>th</sup> @ 7PM is going to take place in the Cairo Elementary Cafeteria.

At the meeting there will be separate sign in sheet for people who have questions and people who are just there to listen. Everyone who has questions they will be giving their information to the planning board and will be answered through a letter from the project engineers. The engineers are from Cobleskill and recommended from Tal who says that Durham also uses them.

Mention of the possible helipad in the plans mention that emergency services would also be able to use this along with DEC. Truck traffic will continue to go the same route as it has always gone. Food deliveries will still happen and it will always be a tractor trailer like it has always been. There will be many people apart of this project while it is being done so there will be traffic but once it gets closer to being done obviously it will slow down. They also plan on putting down 'traffic mats' they are honeycomb shaped and dirt and rock and grass can be put and planted in it and this would protect the road while the amount of traffic increases while work is being done. They are also paying Central Hudson to run 3 phase power all the way up to the site. They will also be using less water than when the golf course was using when they were running. They are going to be as environmentally friendly as possible.

Resolution No. 2024-070 "Authorize to Amend Sidewalk Project Funds"

Offered by Supervisor Watts and seconded by Council Member Bogins.

WHEREAS, a Project for Multi-Use Pathway and Sidewalk Project, Town of Cairo, Greene County, PIN 1760.85 (the Project") is eligible for funding under a New York State Program administered by the New York State Department of Transportation (NYSDOT); and

WHEREAS, a sum not to exceed \$63,435.00 in Program Funding is available to progress the project; and

**WHEREAS**, the Town of Cairo desires to advance the Project by making a commitment of 100% of the State share of the costs of construction and construction inspection.

BE IT RESOLVED, that the Cairo Town Board hereby approves the above-subject project; furthermore,

**BE IT RESOLVED**, that the Cairo Town Board hereby authorizes the Town of Cairo to pay in the first instance 100% of the cost of construction and construction inspection work for the Project or portions thereof; and furthermore,

**BE IT RESOLVED**, that the sum of \$63,435.00 is hereby appropriated from the Town of Cairo Capital Project Funds and made available to cover the cost of participation in the above phase of the Project; and furthermore,

**BE IT RESOLVED**, that in the event the full state share costs of the project exceeds the amount appropriated above, the Cairo Town Board shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the Supervisor of the Town of Cairo thereof, and furthermore,

**BE IT RESOLVED**, that the Supervisor of the Town of Cairo be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for State Aid on behalf of the Town of Cairo with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the Municipality's/Sponsor's first instance funding of project costs and permanent funding of the local share and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible, and furthermore,

**BE IT RESOLVED**, that a Certified Copy of this resolution be filed with the New York State Commissioner of Transportation of the State of New York by attaching it to any necessary Agreement in connection with the Project between the Town of Cairo and the State of New York; and furthermore,

**BE IT RESOLVED**, that this Resolution shall take effect immediately.

# <u>Resolution No. 2024-071</u> "Authorize Greene County Youth fair to Construct a Cold Storage Building at the Angelo Canna Town Park"

WHEREAS, the Greene County Administrator is proposing the construction of a cold storage building to be dedicated for the exclusive use of the Greene County Youth Fair to store materials and event structures for the Fair; and

WHEREAS, Greene County would request a permanent land lease accompanied by the Town of Cairo's support; and,

WHEREAS, Greene County would assume all engineering, construction, and capital costs and full Town approval processes through the Planning/Zoning Boards, however, future maintenance and utility costs would either be the responsibility of the Greene County Youth Fair Board or the Town of Cairo. Therefore;

**BE IT RESOLVED** that the Town Board of the Town of Cairo does hereby approve Greene County to build a cold storage building on the grounds of the Angelo Canna Town Park.
