The Town Board of the Town of Cairo met for a Town Board Meeting on Monday May 6<sup>th</sup>, 2024, at the Town Hall, Main Street, Cairo, New York. Council Member Cords called the meeting to order @ 7:00PM and asked the attendees to Pledge Allegiance to the Flag.

Attendance: Supervisor Watts, Council Member Bogins, Council Member Cords, Council Member Murphy.

Absent: Council Member Flaherty.

## **New Business:**

- Public Hearing Water District Extension
  - Offered by Supervisor Watts and seconded by Council Member Cords.
    - Opened @ 7:01

Supervisor Watts – Aye, Council Member Bogins – Aye, Council Member Cords – Aye, Council Member Flaherty – Absent, Council Member Murphy – Aye. Motion Carried.

- ➤ Allen Veverka asks who is paying for all of this construction and why and who is interested in bringing their business. The Town Board states that County is paying for it with ARPA money and it's a place that they would like to develop for more business; an industrial park similar to Coxsackie. The Town is not spending any money moving water or sewer across 23 across from McDonald's. Supervisor Watts goes on to say that there were a few businesses that have shown interest, one was a recycling company; these companies are in contact with the county.
- ➤ Ray Pacifico asks about the lines on William Dinger Road and if the county will be doing anything with the water/sewer lines with the money left over. The board states that the county is not sure if there will be money leftover or not since they just started the project. Supervisor Watts says that the county is also planning to bring money, if any, to the Ambulance/Senior Center Building on 32.
- Mary Finneran asks the actual location of the water/sewer line extension. The board goes on to say that they are simply starting off where the lines end and extending them across 23, crossing under McDonalds.
  - Mary states that they cannot turn on the water or the sewer until there is someone; business, etc. using the utilities. The Town Board agrees that is the plan, to wait until businesses are using the utilities then they are to be connected, turned on & billed for.

The Board also states that there is a hope of finding another water source across 23 once the water/sewer district is extended. Also future possibilities of having to extend water/sewer farther south towards the community in South Cairo due to other contamination issues; this would also involve Catskill is need be. That would be paid for by FEMA; for future conversation.

- ➤ These PH's are mainly so the Town can bill the extending Districts.

#### **Old Business:**

- 460 Main Street Ralph Rodriquez
  - An engineering report was done last week, closing is planned for mid-July.
    Engineering reports state that the building does not need to be torn down, that it is repairable, they would just need an okay from the board to continue. Before the completed purchase of the building Mr. Rodriquez wanted to let the board know that the building is okay to repair and he would like to do so.
  - The attorney for the former owner, Margaret, took a while to get her name on as the administrator, finally earlier this year 2024 it was done and now the building can be sold; the fire happened in July 2022 and it's finally being sold in 2024. In order for the property to be sold there needed to be an administrator.
  - The reason the building was not repaired within the last 2 years was because there was only liability insurance on it. Mr. Rodriquez wants to put his own money into it and restore it, overall plan is he will be occupying the second floor and not completely sure with the first floor.

- Will need to get the architect to pull any and all permits that will be required once the purchase is complete. There is not much structural damage more facial damage.
- The board would like an earlier closing if possible; also a more detailed list of what specifically is being planned for the building. The board will look it over and re-evaluate at the next meeting on May 15<sup>th</sup>.

### **Correspondence:**

- o Park Walking Path
  - 'I'm not sure what the rules are. But I would like to share an experience I had last week at the park. As this seems quite unsafe for all. On Friday April 26th, I was walking my Dog, on leash, on the walking path. There were 2 other women, with children in strollers, also using the path. Then there was a gentleman using the path to drive his powered bicycle on. He was not giving way to any of us on foot and therefore we moved out of his way. We were not together. It's just what I saw. This seems to be quite dangerous and I was wondering if the path is actually for walking only, or also for biking? Even if biking is allowed I can't imagine power bikes are allowed? I may be wrong. So I just wanted to ask. Thanks.'
  - The board also address the future plans for the path, planning on installing exercise spots/machines around the walking path for people to use while also walking the path.
- o COVID-19 Sick Leave Law repealed effective July 31st, 2025
  - The final New York State budget legislation was recently approved and sunsets the current COVID-19 sick leave law beginning in July of 2025. As you know, New York enacted a law in 2020 providing that public employers must provide paid sick leave for employees subject to a mandatory or precautionary order of quarantine or isolation related to COVID-19 for the period of isolation. This leave was not to be charged to leave accruals. The state later issued guidance stating that employees could use this leave up to a maximum of three times. The budget includes a repeal of this law effective July 31<sup>st</sup>, 2025. The original proposal by the Governor was to repeal this law in July of 2024. The enacted version pushes this out until 2025.
- Highway Part Time Employee Resignation
  - As part of due diligence, some of highway employees have not been available to work and their last day of work as follows, this letter confirms, effective April 1<sup>st</sup>, 2024, the dismissal of: Christopher Franchi at the Town of Cairo Highway Department due to availability of work hours.
- Union
  - The Highway Department has a meeting with the Union tomorrow May 7<sup>th</sup>, 2024. Part of the board will be in attendance.
  - Highway, Ambulance and Police Departments all have their own Unions.
