The Town Board of the Town of Cairo met for a Town Board Meeting on Wednesday May 15th, 2024, at the Town Hall, Main Street, Cairo, New York. Council Member Cords called the meeting to order @ 7:00PM and asked the attendees to Pledge Allegiance to the Flag.

- o Public Hearing Use of ARPA Funds

- > The town needs to use funds leftover from ARPA.
- > The Town is proposing to use funds on three items;
 - + First are the IT needs in the building; update all computers, servers, etc.
 - Second is for the proposed exercise stations that will be placed on the walking path down at the park.
 - + Third is putting money towards a heating system for the ambulance building.
- Supervisor Watts mentions that the county is also giving out \$25,000 to each town in the county, so more money will be coming to the Town; this money will have to be spent on certain items.
- The veterans also mentioned that they have grant money that needs to be used; they would like to use it towards some equipment for the seniors, also a concrete corn hole set and 2 concrete table tennis tables.
- Council Member Flaherty addresses the large basketball court that could possibly be converted into something else; there is a lot of wasted space. Possibly more pickle ball courts to go with the one that is already down there.

- The Water/Sewer are going to the same area across 23. The main goal is to possibly find the aquafer, if this happens then a well will be able to be drilled in the future.
- Richard Lorenz ask if there will be enough water across 23 for what the Town is planning. The Town says yes there, this project would not work if it wasn't.
- They go on to discuss the well that is in park and how it is not sufficient as a replacement or even a backup well. The Town and Delaware Engineering have been in discussion about what is going to be done for some time now.
- Marc Gorelick asks if the well for the Round Top project deplete water from the park well. The Board says not that they know of but that information would be with the engineers who are on the Round Top project.

- o Ambulance
 - There is enough money for the ambulance department to purchase a new ambulance, in the amount of \$340,000, no loan is required. The head of the department says that there is a truck ready and the Town can get it in about 60 days, the cheaper is also available but that would be about a year and a half wait.

The Town would plan to keep the current ambulance in service on top of the new ambulance, it has about 130,000 miles and it was just serviced. The prices will be given to the Board for the next meeting for them to go over.

Old Business:

o 460 Main Street – Ralph Rodriquez

• 'The plan for this building is to start with the future occupancy of the building. The second floor apartment will be occupied by us. The first floor office will become the new home of JCD Construction. We will be relocating from Long Island, NY to Cairo, NY.

Phase 1: Before the closing takes place we would like secure, and clean up the exterior of the building. We are willing to replace broken windows and doors. We would also clean, paint and repair the affected areas where there is fire damage. Any and all other suggestions by you and any other board member is welcome.

Phase 2: We will replace the fire damaged rafters and studs once Phase 1 has been completed. The building will be secured, and structurally safe.

This work, if approved by the Board and Building Department can begin the first week of June. We are looking to close on this property at the end June.

Once the closing takes place we will file the proper paperwork and pull necessary permits to do a complete gut job and bring this beautiful building back to its former glory. I would love to be given the opportunity to be part of this great project.

- The Town is going to put this project out to bid again in case the plan above falls through and does not take place in the near future.
- o Ambulance/Senior Center
 - Ambulance portion of the building is coming along great. Once that is in the final stages they will start the Senior Center portion of the building. The Town is planning on working with the County on the Senior Center part. The County is trying to find some more funds along with helping with the kitchen and assisting with the water and sewer getting to the building.

- Park Clean Up Volunteers Ruth Shelato
 - 'I would like to talk about the Cairo Park clean up like 2 weekends before Mother's Day (starting next year). If it rains or there is bad weather on a set day, like a Saturday then it can be rescheduled for the Sunday after; a rain check.

 - 'This Saturday, May 18th at 8AM the Cairo Rotary will be taking the white stones out of the Memorial Fountain. The Cairo Development Foundation is going to be working with the American legion on repairing and revitalizing the entire are there.
 If anyone has time and would like to assist the Cairo Rotary on their "Day of Service" I am sure they would love the help.

BE IT RESOLVED, the Town Board of the Town of Cairo approves to use ARPA funds for Outdoor Park Equipment in the amount not to exceed \$46,000.00; Furthermore,

BE IT RESOLVED, the Town Board of the Town of Cairo approves to use ARPA funds for the necessary computer upgrades in the amount of \$49,307.00.
