The Town Board of the Town of Cairo met for a Town Board Meeting on Monday July 1<sup>st</sup>, 2024, at the Town Hall, Main Street, Cairo, New York. Council Member Cords called the meeting to order @ 7:02PM and asked the attendees to Pledge Allegiance to the Flag.

Attendance: Supervisor Watts, Council Member Bogins, Council Member Cords Absent: Council Member Flaherty, Council Member Murphy

#### Minutes:

#### June 3<sup>rd</sup>, 2024:

Vote on next month, no voting quorum.

#### New Business:

- 460 Main Street
  - Windows are in and the front of the building is painted, lots of things were changed/updated and it has been cleaned up. Pictures have been taken and distributed to the Board for before and after improvements, wanted to make sure it was presentable for the Town. The sale of the building is still on schedule to be closed on at the end of July. Also waiting on the Engineers to come back with a design, once that happens they will be coming back to the Town for other approvals.
  - Supervisor Watts spoke to Tal and since they have been good on their promise they are giving them another extension on the building. They have to make sure they continue to keep up with the maintenance of the building. The board also thanks them for using their own money, yes the Town would have gotten reimbursed from the county, but the Town does recognize the gesture and greatly appreciates it.

  - Looking for a 4 wheel drive SUV

- Looking for an Ambulance that can hold a larger person, they would keep the other ambulance as an extra so that there are less wait times. There were some improvements to the ambulance building on 145 but there is a long way to go, need new furniture/heat/AC.
- Earl asks about a possible lease of an Ambulance instead of a Bond, the Board isn't sure if the ambulance would last long enough before the lease was paid off.
- Ambulance dept. employees work 12 hour shifts, they are eligible for the Short Term Disability and they were given raises last year.
   Besolution No. 2024 142 (Amount to Durahase on Ambulance)
  - Resolution No. 2024-143 "Approve Intent to Purchase an Ambulance"
- Petition from Residents of Cairo Mace Burr (Safety of the Round Top Roads)
  - Follow Up to Petition Submission to the Town of Cairo: Petition to evaluate for safety of Crow's Nest Road, Blackhead Mountain Road and Bald Hills Road N and S and the intersection thereof in Round Top, Town of Cairo NY.
     'Residents are experiencing unsafe situations where pedestrians and driver safety have been compromised. The current and projected use of the referenced roads is not an urgent public safety concern to residents along those routes.'
  - Mace Burr speaks on the behalf of the residents who have become concerned with the conditions of the roads in Round Top, due to the increase of traffic in the last 2 years. This is due to more people moving into and the project going on in Round Top.
     'NYS Law hold Municipalities responsible to assure that there roadways are maintained in a safe condition, the Town of Cairo Town Board has the authority to regulate roads by local law ordinance, order rule or regulation as granted in NYS Traffic Law Section 68-40. The current and projected use of these roads is an urgent concern to the residents, these are residential winding roads, narrow with inclines, etc. Residents are experiencing unsafe situations where pedestrian and driver safety has been compromised. These roads are vulnerable to further, excessive damage through increased use and activity due to commercial construction vehicle use and increased traffic following the development of the Blackhead Mountain Lodge Property. They would like the Town Board to implement the following; designated truck weight restriction signs, speed limit reductions not to exceed 30mph, a full 4 way stop at the intersection of these roads.
  - Supervisor Watts addresses that these actions along with stop signs and speed limits are under the approval of the State DOT and that a similar request was done for South Cairo but it took a long period of time. The Board is for putting in for the 4 way stop but in the end the State DOT must approve any changes to the roads. They Board has made sure there has been more Police presence, with all 3; State Troopers, County Sheriffs and Town Police present. Supervisor Watts continues on to say that the Board has requested lower speed limits on other roads and that the state would not go below 45mph. He believes one of the roads being discussed is 50mph, which would be a suggested speed limit since it is not officially posted with the white State DOT signs. The Highway Dept. cannot just go out and update speed limit signs, all has to be submitted and approved. Supervisor Watts said he will discuss everything with the Town Attorney, but it is not expected to be changed immediately, possibly within a year.
  - The few Round Top residents in attendance then question the weight limit and safety signage for some vehicles. How parts of the road are being damaged and collapsing due to weight of these vehicles. Watts goes on to say that if these vehicles do not have safety signage then they would be ticketed, then continues on with how some emergency vehicles also have a large weight load. Any road issues need to be discussed with Art and the DOT.
  - The residents brought up one confrontation of a well truck on the side of the road for multiple days, but the Police Dept. was called and the issue was fixed.

#### Old Business:

- Jerome Avenue Water Improvement Grant Jesse Levine
  - $\circ$   $\;$  Looking for a grant of a million dollars and how the Town Residents can assist with this.
  - National Non-Profit Company called RCAT, they help municipalities with water issues with money that is given to them by the State, and this is not a bond. They help with the grant process and surveying the population of the water district. The residents should expect an income survey to determine what amount of money can be given to the Town. This company was contacted by the Town Bookkeeper, they are a State Agency that does not cost any money to the Town. Money is needed to go towards the water infrastructure due to the fact that it is from 1800 and it needs to be updated. New requirements are currently being put in place that the Town needs to abide by. Public involvement is a huge thing in this grant, they need a census of the residents from Jerome Avenue and the Water District; the Town has applied for something like this before and the lack of resident involvement attributed to the denying of past grant applications.

These surveys will be sent in the mail to residents and private information will not be distributed.

**WHEREAS**, the Town of Cairo is looking at options to increase the weekly rate for employees who are eligible to receive short term disability; and,

WHEREAS, Shelter Point has provided the Town of Cairo two additional options:

1. Option 1 - \$4.68 per employee; Pays out up to \$340 per week;

Quarterly cost is approximately \$790.92

2. Option 2 - \$7.16 per employee; Pays out up to \$510 per week;

Quarterly cost is approximately \$1210.04

**BE IT RESOLVED,** that the Town Board of the Town of Cairo accepts Option <u>1</u> to increase the short term disability for any eligible Town employee.
