Re: Tax Collector's Report thru end of collection season

- The 2024 collection season for the Town of Cairo ended on July 31, 2024. I have attached a Collection Summary which indicates all transactions through that date. As indicated, 89% of the warrant was collected totaling an amount of \$7,488,126.35. There were a total of 227 bills that remained unpaid at the close of the collection period.
- A final check for 2024 in the amount of \$3551.16 was written to the Town of Cairo on August 5, 2024 for July interest (\$00.25), July penalties (\$3048.91), July 2<sup>nd</sup> notice fees (\$46.00), December 2023 interest (\$00.08), 2<sup>nd</sup> notice reimbursement fees from the County for the 227 unpaid bills (\$454.00) and overpayments (\$1.92).
- I met with the Greene County Deputy Treasurer on August 5, 2024 to reconcile the books. A final check in the amount of \$56,608.18 was written, closing the books for this year. I have attached a copy of the reconciliation page. I am pleased to say that my figures matched Deb's to the penny.
