The Town Board of the Town of Cairo met for a Town Board Meeting on Wednesday Aug. 21<sup>st</sup>, 2024, at the Town Hall, Main Street, Cairo, New York. Council Member Cords called the meeting to order @ 7:00PM and asked the attendees to Pledge Allegiance to the Flag.

### Old Business:

- IT Bids
  - This will not be voted on tonight. Someone with 'ITS' explains the multiple parts of the proposals that is required for the Town and why there are so many parts and prices.
  - 2 components of the RFP which are the actual service agreement (which ITS currently provides) and another which includes unlimited phone and remote support, additional cyber security, also taking in consideration the Towns budget and a full service. They currently take care of all of the backups, updates, patches, management of work stations, monitoring 24/7, etc. which currently is about \$920 a month.
  - The new service contract that they are proposing is expanding all of the currently services. Unlimited phone and remote support Mon.-Fri. 8am-6pm, includes a certain amount of prepaid hours, other hours can be purchased, annual budget, quarterly meetings, etc.; this comes out to about \$2,100 a month which also includes everything that they were already servicing and more. ITS services about 7 or so other municipalities in multiple counties, this also includes a few police departments and the Sheriff's Dept. and Jail.
- NY Forward Grant
  - The Town was not awarded the Grant, will be trying again next year with someone new as the grant writer. Changes were needed and required within the application for the grant and this was part of the reason it was not awarded.

- Ambulance Building
  - The building is coming along nicely; AC/Heat were addressed and units were installed, floors are being done, next will be furniture and beds/bedframes. There is currently a donation account for the ambulance building.

- Water/Sewer
  - The water and sewer expansion was successful across State Route 23 near McDonalds. There are a few companies that may be interested in expanding business, possible car recycling company; names not listed.
- South Cairo Water
  - Council Member Flaherty and Bogins went to a meeting with DOH, EPA and others; after hearing that the South Cairo contamination problem wasn't going to be addressed for 3-5

years, Bogins contacted and had an emergency meeting with Flaherty, Legislatures, EPA, DOT, DEC, owner of Country Estates, etc. As of right now, testing will go beyond the Country Estates, both Council Members contacted residents with letters from DOH informing residents what is going on and to get there water tested ASAP so this process can move forward.
