## Town Board Meeting @ 7:00PM

### Location: Town Hall Meeting Room

The Town Board of the Town of Cairo met for a Town Board Meeting on Monday September 9<sup>th</sup>, 2024, at the Town Hall, Main Street, Cairo, New York. Council Member Cords called the meeting to order @ 7:01PM and asked the attendees to Pledge Allegiance to the Flag.

## Minutes:

## August 5<sup>th</sup>, 2024:

Offered by Council Member Flaherty and seconded by Council Member Murphy.

### New Business:

- Public Hearing Polly's Rock Road over Kiskatom Brook Bridge Replacement
  - o Offered by Supervisor Watts and seconded by Council Member Flaherty
    - Opened @ 7:02PM

Supervisor Watts – Abstain, Council Member Bogins – Absent, Council Member Cords – Aye, Council Member Flaherty – Aye, Council Member Murphy – Aye. Motion Carried.

- Byron Raych and Joseph Fremante from Barton and Loguidice spoke on the Polly's Rock Road Bridge Replacement Project.
- Location of this is the Polly's Rock Road over the Kiskatom Brook, east of the intersection after Winter Clove Road. This is a replacement and hydraulic improvement project. There will also be right-of-way takings around the bridge, with a temporary onsite detour use for traffic during this time. The total length of the project is approx. 300 feet along Polly's Rock Road.
- This project is required to be approved by both the NYSDOT and FHWA; 95% of the funds are Federal and State while the other 5% are local funds.
- The current condition of the bridge is mostly the deterioration, which is causing section loss around the steel girders, which then causes a lower load holding of the bridge, which is currently at 10 tons. Due to this deterioration caution cones are required to be put down which then makes the bridge narrower and harder for traffic to pass.
- The overall goals of this project is replacing the structure of the bridge which should have a 75 year life span. Also improving the capacity of under the bridge for standard 50

and 100 year floods. There are other cost effective replacement alternatives due to the long term maintenance costs. (All alternatives can be found on the Town website)

- Schedule to date;
  - Design Approval: November 2024
  - Right-Of-Way: January 2025
  - Final Design Complete: February 2025
  - Bidding: March 2025
  - Construction Begins: June 2025
  - Construction Complete: November 2025

- M. Gorelick addresses a few things;
  - What is a feet taking? A permanent easement or when the Town purchases the land that is required/needed for the space/area of the bridge. The grant money will cover the purchase of this property required for the project.
  - Spalling concrete is a bad pour that you can accommodate by using precast concrete. The concrete that is there is going to be removed, spalling can happen to concrete overtime, any type of concrete. They plan to have a better more up to date concrete so it won't deteriorate as quickly. There are some pours that are much more regulated than they used to be.
  - Surface of the road, driving area, width of the road, capacity? Asphalt will be on top of the concrete. The road will be wider than it used to be, much easier to have two cars pass at the same time. Capacity will be to today's standards, not what it was when it was originally built; it will be more than what it is currently posted as. Future amount of 36-40 tons.
- A gentleman asks about the curvature; since the bridge is being raised 3 feet, will the road be a flat surface or will it be more curved? The bridge will be a linear slope from one crest to the next crest. The picture that is being shown is much more zoomed in so you can recognize the curve versus if you were further away it would not be as pronounced. It will be sloped in two different directions.
- A woman asked about the dotted line on the map. That is the existing/current place where the bridge sits. The reason the bridge floods is because it is at the bottom of the curve, it's at the low point.

She then asks about the purchasing of the property from the 4 surrounding properties, also addressing that one of them does not live up here permanently. *The contractor of the project is in charge of contacting these people about their properties; these people have already been reached out to both in person and through the mail about what is going on and needed with these right of ways.* 

- A different gentleman asks about the temporary bridge and if that will be open the day the current bridge is to be closed, so there is no lapse of traffic? There should be no days that there can't be traffic going across. There will be no days, which will be a requirement.
- Supervisor Watts addresses that this is the only bridge that the Town of Cairo owns.
  Once the Bridge is complete it will be handed over to the County so they will be fully responsible for it.
- Highway Superintendent mentions that it is the only and last Town owned Bridge in Greene County.
- A third gentleman asks what the cost of this project is. *The projected costs are about* 1.2-1.3 million dollars or at least that is what the grant is for. Should have a more

specific figure once they get into the actual design process for the bridge, they can have a more projected idea of costs.

- Even with all the construction vehicles it is required that all roadways and driveways are accessible for residents and their properties.
- Offered by Council Member Cords and seconded by Council Member Flaherty.

- Zoning Law Modification of Section VI Accessory Buildings and Uses
  - The Board is looking into changing the Town of Cairo Zoning Law 'Section VI. GENERAL REGULATIONS FOR ALL DISTRICTS, A. General Review Standards, 5(a). Accessory Buildings and Uses'.
  - This is a change in order to allow people who own vacant land who would like to put some other structure other than a house on their property. In the current zoning law you must have a house on the property in order to put up another structure, such as a barn or garage. The board is looking to change this where you do not have to have a house on your land before putting up other structure.

Supervisor Watts plans to have more information on this at the next board and then set up a public hearing to implement this change.

- Police Department Requesting Use of the Route 32 Building
  - The Cairo Police Department is requesting use of the Route 32 Building (Ambulance/Senior Center) for Active Shooter Training on Saturday September 28<sup>th</sup>, 2024 starting at 1PM.
