## New Business:

- Lease for the Youth Fair Cold Storage Building
  - Changes that Greene County would like done; Board will discuss with Tal and reevaluate.
    - Term we are looking to get a longer term than 20 years. The fair began 75 years ago, and we hope to continue for at least another 75 years. Can we extend the term longer than the 20 years?
    - Use of the Leased Premises the county is paying for all the building construction. The
      agricultural society will have a licensed electrician run a 200-amp service to the new
      building and set a Central Hudson meter that will be paid by the agricultural society. Can
      this be added to the lease agreement?
    - Termination can this section be removed or reworded? We are concerned that we will be asked to remove the building in the future while still having the fair at this location.
    - Surrender can this section be removed or reworded? Also concerned about being terminated from the premises while conducting fair business at this location.

#### Old Business:

- Continue Opened Public Hearing Amend Zoning Law Sect. VI.-A-5(a)
  - The one gentleman that had concerns at the last meeting thanks the board for leaving the public hearing open so he can understand and read the law before the decision of the change. There is no replacement language the board is taking a line out of the law; which classifies as an amendment.

The concern from the gentleman is that there is no limit of the amount of building that can be put up before a home goes up. He would like the board to change the wording for it to at least reflect no more than 1 structure should be permitted before the home goes up or a certain about of buildings dependent on how many acres you own. This would still allow people to put up their barn, garage or shed, but he has a concern about people abusing the law and putting up as many as possible before putting up a home.

Once your home goes up that number of buildings after would be under the discretion of the building dept. The Town Board understands where the gentleman is coming from due to his concerns with a current property in Town. But overall the board believes you should be able to do what you want with your property no many how acres you own.

Some other discussion on zoning and why zoning has its good and bad sides.

- House on Main Street/Bross Street
  - The gentleman, Ralph, who is planning on buying this property has not had the closing on his other house in the city, which he plans to use this money to purchase the building on Main Street. This why the closing is taking so long.

The current owner, Margaret, wants to still sell the property to Ralph, but wants to make sure that the Town does not approve the demo of this building since the closing is taking longer than expected and she does not want to incur the cost of the demo if this property is going to be sold. She also wants the okay from the Board to hire an engineer so that a building permit can be done and progress is being shown. Though she is spending this money, once Ralph purchases the property she will be reimbursed. Since gaining ownership the house since her mother died all of the back taxes have been paid.

Supervisor Watts understands that closings take time and addresses that they have put money into the building already to make more structurally sound, event though Ralph is not the owner yet, and that it is safer than it was before, safer that some other buildings in Town.

The Town Board has gotten reports that state the building is not going to fall down. Council Member Bogins and Murphy want to look over the report again from the Town Building Dept. before a decision is made.

The question is why would she hire an engineer now, this is because everything was delayed and by now they expected Ralph to own the building and hire the engineer himself. She wants to start this as soon as possible, would like the Town Board to allow this. But it will still take some time for an actual engineers report.

There was not much word from Ralph or his attorney in quite some time, this is the reason that the Board wanted to meet with him for an update. Jerry Buckley will keep the Board updated.
