New Business:

- Public Hearing Amend Zoning Laws Sect. VI. A 5.
 - Offered by Council Member Flaherty and Seconded by Supervisor Watts
 - Opened @ 7:00PM

Supervisor Watts – Aye, Council Member Bogins – Aye, Council Member Cords – Aye, Council Member Flaherty – Aye, Council Member Murphy – Aye. Motion Carried.

 As of right now according to the zoning law, you cannot put a structure (garage/shed/barn) on a vacant piece of land unless there is a dwelling first.

- A gentleman has been trying to get the actual zoning law since last month since the law was supposed to be put up on the website and was not. Would like to look at it and see what the actual language that is being changed in the law. A FOIL was submitted by his wife last week to the Town Clerk's Office. Would like to know what the law is since he state he has no idea what the actual law is.
 - This should have been forwarded to the zoning dept. if it has not for some reason it will be taken care of and forwarded. Any zoning law is open to the public to look at, a FOIL is more than allowed but anyone can call the zoning dept. and ask to look or get any law in the office.
 - Tal states two important/key parts of the law; "It is the intent of this local law to amend the Town Zoning Law, as the same may have been amended from time to time, in order to allow the establishment of accessory uses on a parcel before the construction of a primary use."
 - What the board is doing is eliminating/deleting section VI, A.5. of the zoning law. The board is looking to change this, with certain rules and regulations that would be decided by the building and code dept.; number of buildings, etc.
- The gentleman in discussion is in agreement with tabling the law till the next meeting.
- The board asks for the gentleman's information and states that the public hearing will just stay open until the next meeting.
- T. Cornelison says he owns property on Klingerman Drive and is also trying to a structure there and is currently paying a weekly fee for where his structure is being stored. The building is not a house be will eventually be converted to one. He is waiting on this law to be passed so it can go onto the parcel. He's also waiting of some other building code updates through the State, but those are weeks out.
 - Supervisor Watts states he understands and that there are also a few other residents looking to put other structures on their lots and are also waiting on this zoning law approval.
- Highway Superintendent Art Evans states that the reason for the original law is so that someone who may build a tiny home cannot classify it as a shed. Supervisor Watts agrees and will still have to continue being on the lookout for that.
- Former Supervisor John Coyne asks if some wording can be put into the law that would limit the number of structures that could be put up prior to the actual dwelling.
 - Supervisor Watts agrees for prior, but after a dwelling that would be the discretion of the building dept.
- T. Endress asks how much longer this law is going to be until approved, he has been waiting for this since July. He asks if there is any way to get a waiver before then so he can put up his barn.
 - The board says it should be approved on the Nov. 20th, meeting. Understands it been a while and they want to help him but he will have to wait the extra 2 weeks till the next meeting. It will be taken care of on the 20th.

- Council Member Bogins goes on to say that the Board has tried to keep everything low, made some cuts. Plus they no longer need to budget money for the senior center thanks for the 2 million dollars from the Greene County and the \$500,000 from Senator Hinchey's Office.
- o Greene County is going to bring water and sewer down to the old DOJO on 32, where the senior center is going, they are also going to help with the construction of the kitchen. The County has

asked of the Town that when the old senior center in Acra is sold that the money goes back to the county, possible estimate of about a couple hundred thousand or so.
