## Resolution No. 2024-255 "Approve 2025 Ambulance Fee Rate Increases"

WHEREAS, The Town of Cairo Ambulance Service charges the patients who have been transported to the hospital; and

WHEREAS, it has been brought to the attention of the Ambulance Administrator that the Town of Cairo is charging below average for billing rates in the area and below average compared to other Municipal Ambulance agencies in the area; therefore,

**BE IT RESOLVED**, that effective January 1, 2025 the Ambulance transport fees will be increased to the following rates:

1. \$ 1,500 for a BLS transport

- 2. \$ 1,800 for ALS 1 transport
- 3. \$ 2,000 for ALS 2 transport

4. \$ 32.00 per mile for all transports

**WHEREAS,** the Town Board of the Town of Cairo is proposing to use Unallocated American Rescue Plan Act (ARPA) funds for to pay for the Town Park Water Well Repairs; and

WHEREAS, that on April 1, 2024 at 7:00 pm, at the Cairo Town Hall, the Town Board held a Public Hearing which is necessary prior to the expenditure of ARPA funds and allocated \$27,650.00 towards expenditures for the Water Well; and,

**WHEREAS,** expenses for the Town Park Water Well exceeded the amount of ARPA funds that were allocated; therefore,

**BE IT RESOLVED,** the Town Board of the Town of Cairo approves to use the remaining 2024 unallocated ARPA funds for necessary repairs to the Town Park Water Well.
