# <u>Resolution No. 2025-111</u> "Authorize Supervisor to Sign 3-Year Contract with Round Top Volunteer Fire Company Inc."

**WHEREAS,** the Town Board of the Town of Cairo has reviewed the proposed 2026-2028 contract with the Round Top Volunteer Fire Company, Inc. contract; therefore,

**BE IT RESOLVED**, the Town Board does hereby accept and authorize the Town Supervisor to sign a 3-year contract with the Round Top Volunteer Fire Company, Inc. to provide fire service in the Round Top Fire District in the amounts stipulated each year referenced in the contract.

#### Resolution No. 2025-112 "Authorize Establishment of the South Cairo Water District"

**WHEREAS,** the Town Board of the Town of Cairo has heretofore determined that the establishment of a water district, which district was and is known as the South Cairo Water District; and

WHEREAS, the Town Board held public hearings on the 5th day of May 2025 and on the 21st day of May, 2025 in accordance with §209-d of the NYS Town Law for the purpose of extending such district, and

**WHEREAS,** the Town Board of the Town of Cairo adopted an Order in accordance with the said Section 209-d of the NYS Town Law on the 21st day of May, 2025, and

**WHEREAS,** the Town Board passed a resolution subject to a permissive referendum on the 21st day of May, 2025 creating the said water district, and

**WHEREAS,** the Town Board has found in the affirmative that all requirements of Section 209-e (1) of the NYS Town Law have been satisfied; therefore,

**BE IT RESOLVED,** that the Town Board hereby approves the establishment of the water district with the boundaries being determined as set forth in the notice for the public hearing, the Order and attached hereto as Schedule "A"; and furthermore,

**BE IT RESOLVED,** that this Resolution is subject to a permissive referendum and shall be binding on June 21, 2025 unless a petition is filed with the Town Clerk prior thereto in accordance with NYS Law, and furthermore,

**BE IT RESOLVED,** that the permission of the NYS Comptroller is not required for the within action since all matters herein are consistent with the requirements of Section 209-f of the NYS Town Law.

# <u>Resolution No. 2025-113</u> "Establish Capital Account for the Construction of Polly's Rock Bridge Project" Offered by Council Member Cords and seconded by Council Member Bogins.

**WHEREAS**, the Town of Cairo desires to establish a specific capital project for the construction of Polly's Rock Bridge; and

WHEREAS, the estimated maximum cost of the project is \$ 1,390,152.00; and,

**WHEREAS,** the funding for the project will come from DOT as well as the Town of Cairo for the Polly's Rock Bridge Construction; and

**BE IT RESOLVED,** that the Town of Cairo board does hereby authorize to establish a capital project for the purpose of the construction of Polly's Rock Bridge, with an estimated maximum cost of \$ 1,390,152.00; Furthermore,

**BE IT RESOLVED,** that funds within this specific capital fund shall be used solely for the purpose of the construction of Polly's Rock Bridge and shall be expended only upon authorization of the governing board; Furthermore,

**BE IT RESOLVED,** that this resolution is effective immediately.
