## **Animal Control Report - May 2025**

5/1/25- report of aggressive goats coming onto someone's property on Joseph d kollar rd in Cairo- i informed them to call town PD or to contact the sheriffs office.

5/2/25- nuisance dog barking/welfare check reported on Gina Marie circle building 4- called and spoke to the person reporting this- also spoke with Cairo pd on it and we reached out to the property manager who is getting contact info for the owner of the dogs. As of 5/31/25 we Have not heard back from the property manager or the complainant on this matter

5/3/25- 2 possible missing dogs seen on security camera- homeowners got home and found the dogs and damage to a golf cart seat- the dogs ran off into the woods- they sent me pictures they were able to take and i posted on facebook to find an owner- owner located and has not seen his dogs confirmed them missing- later that night the dogs did show up back at home and are safe

5/4/25- RN# Cairo-6-2025

Uncontrolled dogs reported on county route 39 and Danielle Drive-called owners and left a message to call me back will be issuing tickets

5/7/25- welfare check request for a dog left outside in a run with no one home for over a day- checked it out and dog has water food and shelter and spoke with owners

5/9/25- Call from NYS police about a welfare check request they got for a dog out in the rain on a concrete slab- checked it out and did not locate any dogs outside at the address provided

5/10/25- RN# Cairo-7-2025

Uncontrolled dogs reported from Danielle drive- had numerous conversations with the owner of these dogs- Issuing additional tickets

5/12/25- welfare check for a dog in a apartment located on mountain ave in Cairo- reached out to complainant and they told me that they were evicting the people from the residence and that the sheriffs office has been there numerous times.

5/12/25- RN # Cairo-8-2025

Uncontrolled dogs reported on maple ave in acra- spoke to neighbor who's dogs were involved in a short fight with the uncontrolled dogs on his property- 3rd time I've been contacted about the same dogs- Tickets were issued

5/13/25- received a call about a dog that got loose from a address on County route 23B in the town of Cairo- owner has seen the dog numerous times but could not catch it- posted on facebook in case anyone came across the dog and could catch it- Dog was caught and is home safe

5/15/25- Received information in regards to a prior dog that was seen by myself and Cairo pd back in January 2025- back in January the conditions of the dog were not severe just a minor skin condition that i was told is being treated and the dog was slightly underweight- a updated video surfaced and re opened a investigation of the dogs conditions because in the last 5 months they have rapidly worsened- myself, Cairo PD, Greene county sheriffs office, and SPCA are involved and per SPCA president Perez's recommendation the dog needs to be brought in for a evaluation- a visit was made by Cairo pd to inform



the owner that they had until Friday May 23rd to bring the dog in to SPCA to be evaluated by a vet and failure to do so would result in animal cruelty charges- Dog was evaluated on May 30th and owner was told he either had arrange to get the dog medical care or the Dog needs to be euthanized due to the evaluation showing the dog has final stages of kidney failure- Dog is being euthanized

5/16/25- Received a call about a dog that was seen roaming around the area of Rudolph weir jr rd and scoharie turnpike on the Cairo coxsackie town line - posted about this dog on Facebook with a picture of the dog someone was able to get to look for owner- dog was caught on 5/18/25 and brought to SPCA for evaluation- no owner found as of yet- Dog is now up for adoption at SPCA in Hudson

5/18/25- Received a call from a landlord about a nuisance barking dog outside at night located on mattera ln in Cairo- spoke with the complainant again and he said that the person was being evicted and he told them that he called me and the barking has since stopped

5/19/25- Spoke with a person in regards to a complaint he had about a dog that was chasing him from a property on hearts content rd in round top when he is biking on his way to work in the morning- this has happened multiple times- stopped by and spoke with the person who owns the dog and informed them of the concern they told me they would contain the dog better so this doesn't happen

5/22/25- Received a call about a dog that was found near a residence on south Lincoln drive in the town of Cairo- they were able to contain the dog until i was able to get there- could not locate a owner so i transported to SPCA in Hudson- the next day. On 5/23/25 the owner reached out to me and i advised them that the dog was safe at SPCA and to call them to arrange getting the dog back.

5/25/25- Received a call from Greene county 911 about a call they got for a loose dog- upon calling them back they informed me that the dog was caught

5/27/25- Received a call around 11:30pm about a unknown animal making loud screeching noises in the area of the 4 corners in south Cairo on route 67- called back and informed them to possibly call the sheriffs on the matter or DEC if it does not sound like a dog my thoughts were that it was coyotes

5/28/25- Received a call about a baby Deer found on the side of the road that was described as days old- i informed the caller to call DEC for assistance and provided phone numbers

5/29/25- Received a call inquiring about a license status for a dog- caller stated that they mailed in all the appropriate paperwork and wanted to know if they get a updated license tag or paperwork- i informed them to call the town clerk or stop by the town to get all that information
