New Business:

- Greene County Animal Alliance Photography Event Mark Gorelic
 - 'The Greene County Animal Alliance and Angela Mia Photography are hosting a fundraiser to benefit the GCAA Shelter Fund on July 20th, 2025 from 2-7pm in the Angelo Canna Town Park.'
- NY Building Recreational Infrastructure for Communities, Kids and Seniors
 - Grant writer needs to know what things will not or cannot be covered in the grant that is going to be applied for. Will recommend that the grant writer, Nicole, talk with the county about this.
- Ira Vail Cell Phone Tower Lease
 - Cell phone company is interested in leasing a plot of land located on Ira Vail from the Town of Cairo. Tal will look over the information packet some more and re-discuss at the next board meeting.
- Fitness Court Grant Funding Available
 - From MVP Health Care/NFC Healthy Cities
 - 'I'm reaching out once more regarding the National Fitness Campaign partnership with MVP Health Care and the opportunity to bring a Fitness Count to Town of Cairo. With grant funding and full program support available, this is an exciting opportunity for the Town of Cairo to make a lasting impact on public health.'

- Park Updates

 The Town Board got a quote from Toad's for 5 cameras to be placed in the Town Park for more security due to the increase in vandalism. There was also discussion about Mid-Hudson Cable going into the park to look at the possibility of Wi-Fi, this is with assistance from the County.

- DOT Highway Work Permit
 - o Issued 6/16/2025. 'Annual Permit to Perform Emergency Work and/or Maintenance of Existing Facilities on NYS Right-of-Way. All work shall be done in Accordance with the NYS Specifications or ad otherwise directed be the State Engineer. Notification must be given to NYS DOT prior to the start of any work or within 24 hours after completion of Emergency Work, etc. Any new Installation will require a Separate Highway Work Permit. All work is to be approved by the Resident Engineer.'

WHEREAS, the Town of Cairo received grant money for the police department for technological improvements in 2024 and the grant money was not fully expended; and

WHEREAS, it is necessary for accounting purposes to track the expenses and appropriations associated with these funds; therefore,

BE IT RESOLVED, the Town Board does hereby authorize the Town Supervisor to amend the expense line item A-3120.401 (Police Contractual - Grant) and the revenue line item A-1062 to reflect the increase in the General Fund in the amount of \$ 8,255.00 in the 2025 budget.

BE IT RESOLVED, that the Town Clerk is hereby authorized to attach a certified copy of this resolution to the SLA (Standardized Notice Form for providing 30-Day Advanced Notice to a Local Municipality or Community Board) and forward same to the applicant and/or NY State Liquor Authority.

WHEREAS, the New York State Office of Parks, Recreation and Historic Preservation (OPRHP) is accepting applications for funding under the 2025 Environmental Protection Fund (EPF) Parks, Preservation and Heritage Program; and

WHEREAS, the Town of Cairo seeks to undertake the rehabilitation and improvement of public recreational assets within Angelo Canna Town Park, including but not limited to the restoration of the Little League and softball fields and related park infrastructure; and

WHEREAS, the proposed project will enhance recreational opportunities, improve public safety, and preserve essential community assets that serve youth programs and the general public; and

WHEREAS, the Town Board of the Town of Cairo is committed to providing the local match and fulfilling all administrative, financial, and regulatory responsibilities associated with any grant received through the Environmental Protection Fund; and

WHEREAS, it is in the public interest to submit an application for such funding; therefore,

BE IT RESOLVED, that the Town Board of the Town of Cairo hereby authorizes the Town Grant Writer, Nicole Ambrosio, to prepare, submit, and execute all necessary documents in connection with an application for funding under the 2025 Environmental Protection Fund Parks, Preservation and Heritage Program; and furthermore,

BE IT RESOLVED, that upon approval of said request, the Town Supervisor is authorized to execute all funding agreements and implement the project in accordance with the requirements of the Environmental Protection Fund and all applicable state regulations.
