BE IT RESOLVED, that the Town of Cairo is participating with Greene County to complete the construction of a new Community Center for which SEQRA must be completed and the County has expressed its desire to be Lead Agency for such review; furthermore,

BE IT RESOLVED, that the Supervisor or his designee is hereby authorized to execute an agreement to consent to the County to be Lead Agency.

<u>Resolution No. 2025-153</u> "Exemption of the County of Greene from Town Land Use Laws Town Board of the Town of Cairo"

Offered by Supervisor Watts and seconded by Council Member Cords.

WHEREAS, the County of Greene (the "County") has requested that the Town Board of the Town Cairo make a determination with regard to whether it shall be exempt from the applicability of the Town's land use laws in relation to its proposal to construct a 20,000 square foot called the Greene County Community Services building which will house the Greene County Mental Health Department; and,

WHEREAS, the Town Board recognizes that there is significant case law on point, with regard to the exemption of such a project including In the Matter of the County of Monroe, 72 NY2d 338 (1988), which held that a balancing test must be performed to determine whether a project of a municipality or agency thereof, is exempt from the local land use regulation weighing the following factors: 1) Legislative intent; 2) Nature and scope of the instrumentality seeking immunity; 3) The kind of function or land use involved; 4) The extent of the public interest to be served; 5) The effect local land use regulation would have on the enterprise; 6) Impact on legitimate local interests; 7) Alternative locations for the facility in less restrictive zoning areas; 8) Alternative methods of providing the needed improvement; 9) Intergovernmental participation in the project development process; and 10) Opportunity of the public and others to be heard; and the Nanuet Fire Engine Co. No. 1, Inc. v. Amster, 177 Misc. 2d 296 (Rockland County S. Ct., 1998) wherein the Court determined that the construction of fire houses are municipal projects and must undergo the County of Monroe "balancing test" to determine whether such action is exempt from local land use regulation; and,

WHEREAS, the County is a New York State municipal corporation duly organized under the laws of the State of New York in which the Town of Cairo is located and the service proposed to be offered by the project will benefit both the residents of the Town of Cairo and the County; and,

WHEREAS, specifically the project will include site excavation, parking, drainage, utilities, public water and sewer, public safety controls, lighting and security. The project will be located on an approximate 18.088-acre parcel on County Route 84 and 23B Town of Cairo, NY bearing tax map number 83.00-4-1 located in a Main Street Commercial (MSCOM) Zone, as that term is defined in the Town of Cairo zoning law; and,

WHEREAS, one of the permitted uses in the Main Street Commercial (MSCOM) Zone is a "Municipal Use"; and,

WHEREAS, the Town caused the matter to be placed on the agenda during a regular Town Board meeting allowing the public an opportunity to be heard and there being testimony from several members of

the public in favor of the project and no opposition voiced either against the project or against the granting of an exemption pursuant to the County of Monroe and Nanuet cases; and,

WHEREAS, following a discussion and analysis of the aforementioned issues and testimony, Supervisor Watts offered a motion which was seconded by Councilperson Tim Murphy and carried:

NOW, THEREFORE, BE IT RESOLVED, that the Board finds that the Legislative intent as it relates to the within matter is found in the 2008 Comprehensive Plan and the Zoning Law of the Town of Cairo. The Comprehensive Plan acknowledges several strengths and weaknesses throughout the Town and specifically cites, at page 9, as one of the strengths that County Offices are located within the Town. Further, the Plan at pages 26 through 28 finds that one of the important economic development recommendations is to "Work with the County to explore ways of fully utilizing the existing County office building in Cairo. This may be an opportunity to set up a conference center or house a regional health center."

Clearly, the Comprehensive Plan supports the type of project that is now offered. Further, the Town Zoning Law, Main Street Commercial (MSCOM) Zone, encompasses the location of the project. The legislative intent and actual impact of the Zoning Law was to allow for public facilities to be used in the zone. The testimony and project materials show that the proposed Community Center is a public use. The Zoning Law defines the term 'public use' as "Any use related to municipal functions as authorized by the Town Board." Thus, the Board finds that the project is consistent with legislative intent within the Town; and,

IT IS FURTHER RESOLVED, that the Town Board finds that the nature and scope of the instrumentality seeking immunity, the kind of function or land use involved and the extent of the public interest to be served are as follows: the County is a New York State municipal corporation duly organized under the laws of the State of New York in which the Town of Cairo is located and the service proposed to be offered by the project will benefit both the residents of the Town of Cairo and the County; and,

IT IS FURTHER RESOLVED, that the Town Board finds that the effect local land use regulation would have on the enterprise would be minimal since as discussed above, the proposed use of project fits squarely into the permitted use of the Main Street Commercial (MSCOM) Zone in which it is located as a public use. Thus, only a site plan review would be required of the project. The project materials show that that the County has already created sufficient plans to address all typical site plan review issues; and,

IT IS FURTHER RESOLVED, that the Town Board finds that there will be no impacts on legitimate local interests since the project is located on Main Street, has adequate site distance, will be serviced by Cairo's municipal water and sewer systems and is consistent with the uses of the adjoining and nearby properties. Lastly, notwithstanding any grant of exemption from the Zoning Law, the County must still comply with NYSDEC stormwater prevention requirements, SEQRA and Greene County Department of Health requirements. The County has declared itself Lead Agency for the SEQRA review of the project and will conduct a full analysis of any potential environmental impacts. Thus, environmental issues that may impact local interests shall be appropriately addressed; and,

IT IS FURTHER RESOLVED, that the Town Board finds that there are no alternative locations for the facility in less restrictive zoning areas and that there are no alternative methods of providing the needed improvement. Indeed, as set forth above, the parcel is located in a Main Street Commercial (MSCOM) Zone where the proposed community center is allowed as a permitted use. Further, the members of the County presented testimony at the town board meeting with regard to their extensive unsuccessful efforts to locate land in other locations on which to build the proposed project over the past several years; and,

IT IS FURTHER RESOLVED, that the Town Board finds that there has been and shall continue to be considerable intergovernmental participation in the project development process based upon the town board meeting information and the continuing SEQRA review; and,

IT IS FURTHER RESOLVED, that the Town Board finds that there has been ample opportunity for the public and others to be heard. The project was discussed in an open meeting at the Town Board's regular meeting, following notice thereof being published in the Town's official newspaper. Further, the public has had and shall continue to have the opportunity to be heard during the on-going SEQRA review; and,

IT IS FURTHER RESOLVED that the Town Board of the Town of Cairo hereby finds that upon the balancing of all factors in relation to the applications of the County, for the project to subdivide land from an existing parcel in a MSCOM Zone and to construct a new community center is exempt from the applicability of the Town of Cairo land use regulations; and,

BE IT FURTHER RESOLVED, that the Town Clerk is directed to file this Resolution in the appropriate index within five (5) business days.

<u>Resolution No. 2025-154</u> "Approve Stipend for Code Enforcement Officer for Performing Building Inspector Duties"

WHEREAS, the Town of Cairo's Code Enforcement Officer has taken all duties of the Building Inspector in addition to her own responsibilities since March 18, 2025; and

WHEREAS the Town of Cairo's Code Enforcement Officer is advertising to hire a new Building Inspector that won't be able to perform their duties until they complete and pass the first four courses; therefore,

BE IT RESOLVED That the Cairo Town Board does hereby approves a stipend of \$650 per pay period for the Code Enforcement Officer prorated retroactively to March 18, 2025, and to continue until the newly appointed building inspector is trained and certified to perform inspections.

 original number was incorrect and an old number from years ago. She later mentions that the water
 tower up by the rooster is constantly letting out water.
- A. Carr states that when there are events going on at the park that the spigots are not metered or monitored and asks who actually pays for the water that is being used in the park as it should be the Town. Her concern with this is that the Town is not getting all of the bills that they are actually responsible for. The Board states that the Town pays for the water usage in the park.
- A woman, Kathy, asks about the letter and why it was sent out. The board states that this was sent out
 by the water dept. but since they take care of there own dept. it is not required for them to run their
 notifications past the board. The letter will be corrected and posted.
- T. Powers asks why there was not a public hearing about the rate changes. Board addresses that there was meeting where the water/sewer rates were discussed. There was a presentation on May 5th, which was posted in the agenda and another small discussion.
- L. Asaro mentions the leak that has been going on for years at the Shingle Kill Creek in Town near the bridge. Supervisor Watts states that the Water Dept. has been aware of this.
- Another woman addresses why rates increase if everyone is still using about the same amount of water each year. Supervisor Watts states that increases need to occur to keep up with maintaining the pipe lines, water main breaks and other equipment repairs for the water/sewer dept.
