Animal Control Report - July 2025

DCO Donald White

7/2/25- Received a call about a dog on mountain ave that broke off its lead while the owners weren't home- was told the dog isn't leaving its property however it was running at cars/ people that were passing by and didn't want to see it get hit- i got the address and was going to see if i could possibly find owner information to call them- was called back and told that the owner had returned and the caller had spoken with them to let them know of what happened

7/2/25- Was called around 9pm by Greene county 911 about a call they received about a dog that was found in the area of route 32 and Cairo junction rd in the town of Catskill- the person who found the dog, Greene 911 and myself called the Catskill DCO and got no answer- i drove to the location and picked the dog up and transported to SPCA in Hudson due to the tag on the dog having a non working phone number and a address of main st in Catskill 9 miles away from where he was found- on 7/3/25 i received a call from the person who owns the dog and they left a voicemail stating they lived on Cairo junction rd and that they seen my post and i called back when i was available and they told me that they had the dog and picked him up from SPCA

7/6/25- Received a call about a cat that is sick/ injured that someone found on their property- i called back and informed them to call animal kind or hyer ground rescue for further assistance

7/8/25- Received a call about a couple of pitbulls that possibly attacked a horse on mountain ave in roundtop- horse was treated at a vets office- there was no proof of dogs being on the property- spoke to the owners of the dogs in question and vaccinations are up to date and advised to make sure the dogs stay contained to avoid further speculation- owner of horse advised to install cameras of some sort to have proof in the event this happens again.

7/9/25- Received a report of a dog missing from the area of route 23 and Edison timerman rd- posted info on Facebook to attempt to locate- as of 7/14/25 she has still not been found- on 7/18/25 i got a message from the owner telling me that she had returned home

7/10/25- received a call about a possible rabid raccoon in front of someone's house- called them back and advised them to call DEC

7/10/25- Received a call about a aggressive dog on Elizabeth terrace that is on a leashed run but barks and tries to chase people as they walk by- caller stated that neighbors have spoken to the owner with no result- i informed them that not much can be done because the dog is on its own property and is contained by the leash

7/14/25- received a message about 2 dogs tied up outside in the area of main st in Cairo- i drove up and down main st and could not find any dogs outside

7/15/25- received a call about a dog that was seen roaming around in the area of green lake rd in the town of Athens- i informed the caller that they would need to call the DCO for the town of Athens to assist with helping to catch the dog and find a owner

7/20/25- received a message about a missing dog from the area of woodland drive in roundtop- i posted the information on facebook to assist in finding him- the owner told me later in the day that the dog had returned home

7/24/25- received a call about a missing dog from the area of the Cairo public library- i posted the information on facebook to attempt to locate him- no information on if he has been found as of yet

7/24/25- received a call about a golden retriever that was found in the town of Catskill- in the message they stated they were going to hold onto the dog until someone could pick the dog up- I attempted to call back to give them the Catskill DCOs information but was unable to reach them

7/25/25- received a call about a dog that was found in the area of maple lawn rd and deer park rd in roundtop- i posted the information on facebook and i went to pick the dog up- i drove to a residence where i was told the dog likely lived at and was able to find the owner there and we found he broke off his leash and got out of the yard

7/26/25- received a call about a barking dog on county route 41 in the town of Cairo- caller explained in his message that he's trying to sell his property and the dog wont stop barking- i called back the next day and was not able to get ahold of caller

7/26/25- received a call about a dog that was found on mountain ave near the whip o will campground- owners were located and dog is home safe

7/28/25- received a call about a dog that's chained up outside a lot in the heat at a address on silver spur road- i drove by the location and did not see the dog outside at the time and it did not appear that anyone was home

Animal Control Report - August 2025

8/1/25- Received a call about a possible rabid raccoon at a address on schoharie turnpike- informed caller that it is not my jurisdiction but to call DEC for assistance

8/3/25- received a call about 2 dogs that went missing from the area of county route 20 and hull O farms- i posted the information on facebook to attempt to locate them- a few hours later i got a message that they had returned home

8/3/25- received a call about a dachshund that was found in the town of Durham- upon calling back and getting information for the dog they told me that the owner was outside looking around for the dog

8/5/25- received a call about a black bear that has been getting into dumpsters at a address on main street in Cairo- called back and they informed me that they had been in contact with DEC

8/6/25- received a call about dogs that someone felt were being let outside to early in the morning on winterclove rd in roundtop and were barking- informed them that there wasn't much that could be done unless it is a constant thing that takes place with the barking

8/7/25- received a report of barking dogs in the area of mountain ave by the log cabin cafe- informed the caller that there wasn't much that can be done unless its a constant thing that takes place

8/8/25- received a call about 2 dogs running loose in the area of schoharie turnpike and gay head earlton rd on the Cairo/ Greenville town line- they did not get any pictures and i did not receive any reports of missing dogs from the area

8/8/25- received a message about a dog that was found in the area of 23B and Cairo junction rd in the town of Catskill- i informed them that its not my jurisdiction but i would post the dog on facebook to help out and i provided the Catskill DCOs information so they could contact him- the owner was later located and dog was returned

8/8/25- received a call from Greene 911 about a dog that was seen in the roadway then sitting outside of a residence on Bailey rd in roundtop- Cairo PD was already en route when i was called- Cairo PD found the front door open when they arrived and i drove to the location at the request of Cairo PD to attempt to catch the dog but was unsuccessful- due to the appearance of the outside of the house and what could be seen through the front door inside the house we believe the dog lives there- spoke with Cairo PD sergeant Busch and he was going to send a officer to the location the next day to follow up

8/9/25- received a message about a dog that was found on bald hills rd in roundtop- i advised them i was out of town at the moment but could pick the dog up when i returned later that night- in the meantime they sent me pictures and i posted the information on facebook to locate a owner- the next day 8/10/25 the owner called me asking if anyone had found their dog and i informed them that i had him and would drop him off to them

8/16/25- received a call about a issue with some dogs coming onto someone's property and interacting with their dogs- Cairo PD was also called for this and went to interview the complainant- after some time passed the complainant decided they did not want to take this any further- they were informed to let us know if it happens again

8/18/25- received a message about geese, ducks and chickens in the roadway constantly in the area of Edison timmerman rd and sunside rd- was not able to get ahold of caller- was going to inform caller to contact PD or speak to the owner of the animals as this is not something the town has me deal with

8/20/25- report of a deceased orange/ white cat in front of CVS in Cairo- have not heard anything further on this and did not see the cat in the location on my travels through the area

8/22/25- Report of a Dog bite that took place in the area of larch st and orchard drive in south Cairo- Cairo PD was also called and went to the area to attempt to locate the dog and a owner but had no luck- person bitten was able to get a picture of the dog and i posted to attempt to find a owner but have not had any luck with that route either- person bitten was treated at urgent care

8/24/25- received a call about a complaint with a neighbors dogs always running around the area and using his yard to go to the bathroom- was not able to get back in contact with caller and did not leave a address in the message other than that he lived in Leeds

8/31/25- received a call about barking dogs in the area of county routes 24 and 31- I explained that not much can be done about the barking dogs- my advise was to maybe have a talk with the neighbor first and go from there i was told by the caller that they contacted the NYSP and they went and spoke to the dog owners
